## **WSDA NEWS**



### Greetings from WSDA Food Assistance (FA),

Change is inevitable and not knowing about upcoming changes in the hunger-relief world can lead to even more anxiety about what the future may hold. Our goal with this article is to share what we know, share some of our assumptions moving forward, and share our appreciation for you, the organizations that you represent, and the care that you show for the people that you serve.

### **Updates**:

- Final State Budget Pass-through Buckets SFY 2026 (July 1, 2025 June 30, 2026):
- EFAP and EFAP-Tribal Client Data for SFY2025 (July 1, 2024 June 30, 2026) is almost final. Once available it will be posted on our webpage https://agr.wa.gov/services/food-access with additional county/regional analysis. Based on the preliminary SFY 2025 EFAP data it shows a 6% increase in total client visits compared to SFY 2024 almost 14.18 million. A record number of pounds of food were distributed over 2 37.28 million.
- All programs, state and federal, will be receiving amendments and/or agreements in the coming weeks. Key high-level changes include:
- · Reduced audit requirements for state funding
- Increased fiscal training
- Revised nondiscrimination clauses
- Updated TEFAP client intake requirements removal of addresses
- If there is a federal shutdown, we anticipate that TEFAP and CSFP will continue to operate business as usual. We will continue to monitor this closely and provide updates as they are received.

I want to take a moment to highlight the successes of the 2025 WA Food Coalition Conference. The conference continues to be a pulse on the many challenges and opportunities facing emergency food providers in WA State. Our team heard from many of you and appreciated the thoughtful and nuanced conversations.

In addition to connections made, the conference was an opportunity to further WSDA FA's community engagement while also celebrating the work of a true icon in the state's emergency food system, the retiring Executive Director, Trish Twomey. Echoing the praise of so many at the conference, her steadfast commitment to service in WA State over 42 years was deserving of an event like the conference to celebrate and praise the difference she has and continues to make. We were delighted to present Trish with a certificate of appreciation signed by WSDA Director Derek Sandison and myself. If you missed the presentation, here is what it said:




# **Fresh Results Awards**

This year, we are thrilled to honor Smallwood Farms, nominated by Stasia Hazelwood, Food & Nutrition Programs Manager at Okanogan County Community Action Council (OCCAC). Smallwood Farms, run for generations by Dennis and Mallory Carlton, exemplifies what it means to give back to





OCCAC shares: "Smallwood Farms donates throughout the season, supports our gleaning program, and has even lent us ladders when we were just starting out. They have been instrumental in helping us provide fresh, healthy food options to clients across Okanogan County. Already, we're feeding 30% of the county through our food pantries, with Smallwood Farms contributing a large majority of the fresh, local produce through donations, purchases, and gleaning. Dennis and Mallory are always willing to step up when our pantries need more food or our funding falls short. Their generosity, openness, and guidance — even as we learn best practices for safe harvesting and organic farming — make them truly remarkable partners."

This year, we were excited to honor Smallwood Farms at our annual conference in Kennewick, September 17–19, 2025. While Dennis and Mallory were unable to attend in person, their impact was celebrated by attendees who share in their vision for a stronger, healthier food system.
