#### **About CMAA**

#### **Selection Guidelines**

The Construction Management Firm of the Year Award is given annually to an industry leading firm who has made significant contributions on behalf of the construction management industry in the State of Connecticut. This firm must possess unparalleled leadership, high quality workmanship, use new and innovative ways to complete the project, and have an outstanding record of accomplishments.

#### Eligibility

- Open to all Construction Management Association of America (CMAA) member, and non-member Firms.
- The CM Firm must have at least one office in the State of Connecticut and a registered business therein.
- The time period recognized shall be August 31<sup>st</sup> (prior year) through September 1<sup>st</sup> (current year).

NOTE: Incomplete applications will not be considered. The application and all associated attachments must be submitted electronically. Hard copy applications and attachments will not be considered.

#### **CM Firm of the Year Application Process**

All applications and supporting materials must be submitted directly to the CMAA Connecticut Chapter. **Be sure to submit your nomination with all accompanying application and attachments electronically to awards@ctcmaa.starchapter.com no later than midnight, October 17, 2024.** See the Application Checklist for guidance in assembling your application.

You should receive a confirmation email that your application was submitted successfully (please be sure to check your Spam folder, as well). If you do not receive a confirmation, please email Terrence McAuliffe at tmcauliffe@aiengineers.com of the issue.

#### **CM Firm of the Year Review Process**

- 1. The CMAA Connecticut Chapter Project Achievement Awards Selection Committee will review all complete applications received and will make its recommendation to the CMAA Connecticut Chapter Board of Directors for approval. The selected winner will be notified on or about November 1, 2024.
- 2. While not mandatory, the CM Firm of the Year nominees are strongly encouraged to attend the CMAA Awards and Scholarship Dinner on November 21, 2024, at The Aqua Turf Club in Southington, CT, where the CM Firm of the Year will be recognized for its outstanding work and presented with an award.

Provide backup, not exceeding 10 additional documents to support the statement(s) made above, not exceeding 20 pages in total. This may include client referrals, performance indicators, community thank you letters and any other documents that present your firm as a candidate to become the Firm of the Year.

#### Part VII: High-Resolution Logo

Provide a high-resolution, included in the emailed submission as a separate file, of the firm's logo. If selected as the award winner, the photo will be included in the Awards and Scholarship Dinner booklet.
