CERTIFICATE OF INCORPORATION

OF

SARATOGA ECONOMIC DEVELOPMENT CORPORATION

Under Section 402 of the Not-For-Profit Corporation Law

I, the undersigned, desiring to associate ourselves together to form a local development corporation, do hereby certify:

FIRST: The name of the corporation shall be the SARATOGA ECONOMIC DEVELOPMENT CORPORATION.

SECOND: The corporation is a corporation as defined in Subparagraph (a) (5) of Section 102 of the Not-For-Profit Corporation Law and is a local development corporation pursuant to Section 1431 of said Law.

THIRD: The purposes for which the corporation is formed are as follows:

To plan and promote, and if necessary, to coordinate and execute programs in the County of Saratoga aimed at improving the quality of life of its residents by developing new approaches and methods where necessary and proper.

To achieve certain charitable objectives and public purposes of relieving and reducing adult unemployment; promoting and providing for additional and maximum adult employment, and bettering and maintaining adult job opportunities within the County of Saratoga by the following activities:

- (a) to relieve and reduce unemployment;
- (b) to promote and provide for additional and maximum employment;
- (c) to better and maintain employment opportunities;
- (d) to encourage the development of, or retention of an industry or industries in the community or area;
- (e) to lessen the burdens of government;
- (f) to act in the public interest;
- (g) to study and promote, alone or in concert with local officials and interested local groups, the economic growth and business prosperity of the area;
- (h) to provide managerial, technical and administrative advice in order to aid local business enterprises;
- (i) to carry on scientific research for the purpose of aiding the community or geographic area by attracting new industry to the area;
- (j) to aid in the solution of other civic problems of the community or area;
- (k) to perform any other act incidental to, connected with, or deemed necessary in furthering the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors or officers, except as permitted by Articles Five and Fourteen of the Not-For-

Profit Corporation Law and Article Eight of the Public Authorities Law; and

- (1) to exercise all other powers conferred by Paragraph (c) of Section 1411 of the Not-For-Profit Corporation Law.

FOURTH: The corporation shall be a Type C corporation under section 201 of the Not-for-Profit Corporation Law.

FIFTH: The lawful public or quasi-public objectives which each business purpose will achieve are the following: the reduction of adult unemployment; the promotion of maximum adult employment by bettering and maintaining adult job opportunities; the stimulation of the economic growth of the community.

SIXTH: All income and earnings of such corporation shall be used exclusively for its corporate purposes or accrue and be paid to the New York Job Development Authority.

SEVENTH: It is the intention of this Corporation at all times to qualify and remain as exempt from income tax under Section 501(c) (3) of the United States Internal Revenue Code of 1954, as the same may from time to time be amended. Accordingly:

(A) The Corporation is not to have authority to issue capital stock;

(B) The Corporation shall not be conducted or operated for profit, and no part of the net earnings of the Corporation shall inure to the benefit of any member or private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes as permitted under Article 5 of the Not-for-Profit Corporation Law); nor shall any of such net earnings nor any of the property or assets of the Corporation be used other than for the purposes of the Corporation as aforesaid;

(C) No part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation; nor shall the Corporation participate in or intervene in (by the publishing or distributing of statements or otherwise) any political campaign of any candidate for public office; and

(D) In the event of the liquidation, dissolution, termination or winding up of the Corporation (whether voluntary, involuntary or by operation of law), and after the payment of just debts and liabilities, none of the property or assets of the Corporation shall be made available in any way to any private individual, corporation or other organization, except to corporations or other organizations described in Section 501(c) (3) of the United States Internal Revenue Code of 1954, as the same may from time to time be amended, in furtherance of the purposes for which the Corporation is created, subject to the order of the Supreme Court of the State of New York, as provided by Law.

EIGHTH: If the corporation accepts a mortgage loan from the New York Development Authority, the corporation shall be dissolved in accordance with the provision of section 1411(g) of the Not-for-Profit Corporation Law upon the repayment or other discharge in full by the Corporation of all such loans.

NINTH: The office of the corporation shall be located in the City of Saratoga Springs, County of Saratoga, State of New York.

TENTH: The territory in which the corporation's activities are principally to be conducted is the County of Saratoga.



THIRTEENTH: Nothing herein contained shall authorize the corporation, directly or indirectly, to engage in or include in its purposes any of the activities mentioned in Section 404(b) through 404(t) of the Not-For-Profit Corporation Law or Section 460-a of the Social Services Law.

FOURTEENTH: Prior to the delivery of this certificate of incorporation to the Department of State for filing, all approvals or consents required by the Not-For-Profit Corporation Law or by any other statute of the State of New York will be endorsed or annexed thereupon.




