EXHIBITORS INFORMATION

Each exhibitor is allowed up to **6 feet of total display space**. For example, you can bring a 6ft table, or a 4ft table with a 2ft stand or banner—your full setup must fit within the 6ft width limit.

All exhibitors must host an engaging, interactive activity to engage visitors and enhance the Feel Good Festival experience. Any Exhibitor selling goods from their booth must maintain a [Louisville Sales Tax License](#)

Healthy food businesses (e.g. granola bars) may offer pre-packaged samples under 2oz. No cooking or prep on-site and no food or drink sales allowed. Please contact us in advance to confirm your setup meets event guidelines. **Note:** Food and drinks will be available from Relish's bar and food hall.

EXHIBITOR FEES

Chamber Member Booth: \$150 / Non-Member Booth: \$300

SET-UP & TEAR-DOWN

- Exhibitor Setup: 9:00 - 9:45AM
- Booth Setup Completion: By 9:45 AM
- Event Duration: 10:00 AM – 4:00 PM (You may not close before 4pm)
- Tear Down: 4:00 PM – 4:30 PM (All exhibitors must vacate by 4:30 PM)

LOAD-IN & LOAD-OUT

- Park at the main parking lot in front of Relish. There is no loading zone /drop off permitted at the front door, you must park and bring your items into the venue.
- Vendors must manage their own supplies and setup - Max 6ft tables only.
- The Chamber will not provide equipment or labor for moving exhibitor materials.
- Loading areas will be busy with vehicles, staff, and other exhibitors. Please plan accordingly and bring necessary carts or assistance.
- Each vendor will be emailed a map in advance with their location number and there will be volunteers on hand to assist finding your space.

Exhibitor Responsibilities & Code of Conduct

- Exhibitors are responsible for **safely transporting, setting up, and taking down** their equipment.
- **No trash should be left behind**; exhibitors are responsible for their waste. Trash left behind will result in **additional fees**.
- Adhere to **setup and tear-down schedules**.
- Ensure **no damage to Relish property**; any damages incurred are the exhibitor's responsibility.
- Commit to the **full event duration**; early departure incurs a **\$150 fee**.
- **Respect event staff, attendees, and fellow exhibitors**.

Waiver, Insurance, and Terms and Conditions

By selecting **YES** during the application process **and/or by participating in the Feel Good Festival**, I acknowledge and agree that the Louisville Chamber of Commerce and its officers, directors, staff, volunteers, partners, sponsors, and representatives are not responsible for any personal injury, illness, loss, or property damage arising from or related to my participation in this event.

I understand and agree that I am solely responsible for maintaining any insurance coverage required for my participation, including but not limited to general liability insurance, professional liability insurance, and any coverage applicable to demonstrations, services, treatments, physical activities, exhibition space, or offsite activities conducted before, during, or after the event. The Louisville Chamber of Commerce does not provide insurance coverage for exhibitors, vendors, presenters, or participants.

I further acknowledge that I am solely responsible for obtaining, administering, and enforcing any waivers, releases, informed consent forms, or acknowledgments required for my activities, services, demonstrations, or products. The Louisville Chamber of Commerce does not provide, collect, review, or enforce waivers on behalf of participants and assumes no responsibility for the adequacy or use of such waivers.

I agree to indemnify and hold harmless the Louisville Chamber of Commerce and the aforementioned parties from any and all claims, liabilities, damages, losses, expenses, or attorney fees arising out of or related to my participation in the event, including but not limited to claims for personal injury, death, property damage, professional services, or activities conducted by me or my representatives.

Indemnification

The Exhibitor agrees to indemnify and hold harmless the Louisville Chamber of Commerce and its affiliates from all claims, damages, losses, expenses, and attorney fees arising from injury, death, property damage, or other losses connected to this agreement. This includes claims involving subcontractors, representatives, employees, volunteers, or workers' compensation matters related to the Exhibitor's participation. The Exhibitor's liability shall be proportional to their degree of fault as determined by applicable law.

Agreement Confirmation

This agreement becomes effective upon any of the following:

- Submission of an application form
- Written confirmation of participation via email
- Payment of exhibitor fees
- Setup or participation in the Feel Good Festival

By submitting payment, confirming participation in writing, setting up a booth, or otherwise participating in the Feel Good Festival, the Exhibitor acknowledges that they have received, read, understood, and agreed to all Exhibitor Terms & Conditions outlined above.

Participation in the event constitutes full acceptance of these terms, whether or not the Exhibitor completed the formal application form.
