## What Happened to Our Country?

In the New York Times edition of July 4, 2013, it was announced that the U.S. Postal Service has been photographing each envelope entrusted to it in each post box in America. The USPS keeps these images in computers, available to any law enforcement agency who requests them without a warrant.

Founding Father Ben Franklin was the first U.S. Postmaster General. What would he have to say about this?

Recent articles have informed us that the National Security Agency (NSA) keeps track of every telephone call's "telephony metadata" - that is, the numbers called and the time and date of each call. This information is also stored in computers and available to law enforcement without a warrant.

Here in New York City, the "Capital of Freedom", the Metropolitan Transportation Authority (MTA), a State Government instrumentality, keeps track of every time a motorist crosses a toll bridge through a sinister device called "E-Z Pass". Since New York City is built on numerous islands, this means a large portion of the population and its commerce is monitored by the State all of the time.


This could have been named by George Orwell, author of the 1949 classic novel, 1984, about a dastardly future approximately like the time we are now living in. 1984 described a future where

everyone was under surveillance all the time, just as we are today in 2013.

There is nothing "E-Z" about "E-Z Pass". It is a way for State Government to keep track of our movements. And then there is "Metrocard". This all-seeing device allows the MTA to know each time a passenger enters a subway station and each time he or she exits.



## Changing Your Name in New York:

A Guide for Attorneys and the Self-Represented

We are not always happy with the names our parents give us. Because we like to identify ourselves to others in different ways and for different reasons, we have used aliases, a/k/a's, stage names, pseudonyms, monikers, nicknames, and pen names since the Year One. Our names are our labels. And as Proverbs 22:1 advises, "A good name is rather to be chosen than great riches . . . ."

This three-part article is designed to help lawyers and non-lawyers understand the rules and procedures surrounding how to get a new name in New York: the common-law way to change one's name; acquiring a name by filiation, adoption, marriage, and divorce; and the right to petition, or apply to, a court for leave to assume another name.

#### I. Common-Law Name Change

Changing your name in New York is easy. New York recognizes the common-law right to change your name without having to petition the state. If you are a movie star — or a fan of one — you

can change your name whenever you wish. Just make the conscious decision to do so. Then consistently hold yourself out to the world using your new name while managing all your regular business and day-to-day affairs, including entering into contracts, using your new name.<sup>3</sup> The only requirements are that you do this for a sufficiently long enough time and that using your new name does not result in fraud, confusion, or offense to common decency and good taste.<sup>4</sup>

## Vicious Propensities in Domestic Animals

In recent weeks there were two Appellate Division decisions that dealt with the issue of whether the plaintiffs, who sustained injuries caused by dogs, could recover damages on the theory of negligence.

This article will discuss these two decisions, Bloom v. Lenten, [AD 3rd Dept.] and Doerr v. Goldsmith, [AD 1st Dept.] as well as highlight the leading Court of Appeals cases that the lower courts relied on pertaining to injuries caused by domestic animals.

In Bloom, the plaintiff was a photographer and the defendants had a dog breeding business



at their home. In 2007, plaintiff went to defendants' home to photograph puppies of their English Labrador retriever, including a puppy named Delilah. Approximately three years later, the plaintiff again went to defendants' home to photograph new puppies. While in the backyard on her

second visit that year, three full grown dogs were running around playing and chasing after Delilah, who had now grown substantially and weighed about 50 pounds. As she was being chased, Delilah "ran into the back of plaintiff's leg, knocking her forward and onto the ground" causing plaintiff to sustain serious injuries.

## S Corp Sales, Built-In Gain, and 2013

Last year saw many taxpayers selling appreciated assets. The primary reason for this activity was the imminent increase, in 2013, of the long term capital gain rate, and the imposition (in some cases) of a 3.8% tax on net investment income, both of which would impact sales of assets owned directly by individuals or by pass-through entities owned by such individuals, including S corporations.


Notwithstanding the foregoing tax rate increases, 2013 may be a good time for certain S corporations to consider a sale of assets.

#### **Built-in Gain Tax**

Unlike C corporations, S corporations generally pay no corporate-level tax. Instead, items of income and loss of an S corporation pass through to its shareholders. Each shareholder takes into account its share of these items on its individual income tax return. Thus, any gain recognized by an S corporation on the sale of assets is passed through and taxed to its shareholders.

There is an exception to this rule for asset sales by S corporations that were previously taxed as C corporations. Specifically, under Section 1374 of the Internal Revenue Code (the "Code"), a corporation level tax, at the

(the "Code"), a corporation level tax, at the highest marginal rate applicable to corporations (currently 35%), is imposed on that portion of an S corporation's gain that arose prior to the conversion of the C corporation to an S corporation (the "built-in gain" inherent in its assets at that time; "BIG") and that is recognized by the S corporation during a specified period of time following the conversion (the "recognition period").
