REPORT CARD 2026



+ SB 1106/HB 2153 Internal revenue code; conformity; deductions. Updates Arizona tax code to align with federal tax law and revises deductions, credits, and conformity provisions.

- SB 1293 GPLET; abatement; limitation. Limits Government Property Lease Excise Tax (GPLET) abatements, reducing the incentive available for qualifying development projects.

+ SB 1336 State land department; continuation; oversight. Continues the Arizona State Land Department, maintaining agency operations and legislative oversight.

+ SB 1429 Ballot measures; circulators; disclosure. Requires additional disclosure requirements for ballot measure petition circulators to increase transparency.

- SB 1431 Municipalities; planned communities; design; prohibition. Restricts municipalities from requiring certain design standards in planned communities, limiting local zoning authority.

+ SB 1847/HB 4154 General appropriations act; 2026-2027. Funds state government operations and essential public services for fiscal year 2026-2027.

+ SB 1861/HB 4168 Taxation; omnibus; 2026-2027. Enacts annual tax law changes, updating tax policy and implementing budget-related tax provisions.

+ HB 2601 Interstate 11; environmental; engineering; study. Advances planning for Interstate 11 by funding environmental review and engineering studies.

+ HB 2785/SB 1638 Conformity; internal revenue code; deductions. Updates Arizona tax conformity with the Internal Revenue Code and revises deductions to reflect recent federal tax changes.

+ HB 4026 Public infrastructure improvements; distribution limit. Adjusts limits on distributions for public infrastructure improvements to support local infrastructure financing.

+ HB 4115/SB 1489 Ballot measures; circulators; revenue; disclosure. Requires ballot measure petitions to disclose major funding sources for signature gathering and campaign activities.

+ HCR 2051 Ballot measures; circulators; revenue; disclosure. Refers to voters a constitutional amendment requiring additional financial disclosure for ballot measure petition campaigns.
