This includes posters related to discrimination, harassment, and other employment rights. 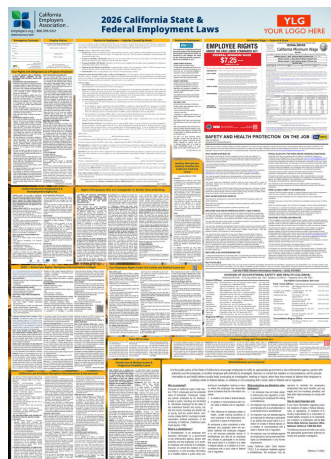
