He told the crowd in January that the Aurora base continues to expand their mission and will contribute more than \$1.1 billion to the economy.

Buckley's economic impact increases \$18 million

Buckley AFB continued to be one of Colorado's major economic engines according to data released by the Aurora base in January. The base's economic impact to the City of Aurora and the surrounding community increased by \$18 million last year and remains above the \$1 billion mark for the third year in a row.

According to the 460th Comptroller Squadron, Buckley's

impact for fiscal year 2006 is at \$1,090,906,789. The fiscal year ran from Oct. 1, 2005 to Sept. 30, 2006.

Buckley's annual payroll paid more \$409.41 million to Department of Defense personnel and \$211.38 million to contractors and non-appropriated fund civilians, who include workers at the Base Exchange, commissary and private businesses operating at or on the base. "We're both proud and

fortunate to be economic partners with a community that gives us such tremendous support," said Col Dave Ziegler, 406th Space Wing and Buckley base commander.

"We are proud that Buckley is a strong member of the Aurora Chamber," said Kevin Hougen, President and CEO. "We have always understood the value—both monetary and in terms of people and mission—the military brings to

Board takes stand on key issues

The system works! The Government Affairs/Education Committee under the leadership of *Jim Suss* (**Suss Pontiac/GMC**) and Bob LeGare has been doing a great deal of work during the early part of the year. In the last three months they developed and approved five Legislative Policy White Papers including ones on Integrated P-16 Education, Higher Education, Economic Development, Healthcare Costs/Insurance and Water. In addition, the Transportation Committee led by *Dave Frazier* (**Merrick & Company**) put together a comprehensive Transportation Policy White Paper. The GA/E Committee also continued to review pending legislation and recommended to the Board that The Chamber oppose House Bill 07-1072, the proposed change to the Colorado Labor Peace Act (which the Governor vetoed on Feb. 9) and oppose Senate Bill 07-10, Nurse Staffing Ratios; and support Senate Bill 07-97 which would use a portion tobacco settlement money to help fund University of Colorado Health Science Center projects. The Board accepted the recommendations voting to instruct the Chamber lobby group, **Axiom Strategies**, to take our concerns to our legislators. And rest assured, your Chamber will continue to work for you at all levels of government.

Keep Employees Safe this Winter

Preventing Winter Slips, Trips, and Falls

You might have noticed after several straight weekends of snow that here in the Eastern Metro area, winter is upon us! And with it comes the hazards of snow and ice around the workplace. The most common winter injuries are slips, trips, and falls caused by wet and slick conditions. Here are a few prevention tips:

- Wear slip-resistant, insulated footwear.
- Take small steps on slippery surfaces.
- Avoid walking too fast, running, quickly changing directions, or coming to a sudden stop.
- While walking, keep hands out of pockets to catch yourself if you fall.
- Use handrails.
- Avoid carrying materials that obstruct vision.
- Use three points of contact when entering and exiting vehicles.

Dress for Cold-Weather

For outdoor workers, proper clothing is essential to protect against hypothermia, frostbite, and other winter hazards.

A few recommendations are:

- Dress in layers that can be added or removed as needed. OSHA recommends a minimum of three layers:
 - ~ The outer layer should deflect wind and allow ventilation
 - ~ The middle layer should absorb sweat and retain insulating properties in a damp environment.
 - ~ The inner layer should allow ventilation and provide warmth.
- Keep a change of clothing available, including socks, in case work clothes become wet.
- Wear insulated, waterproof, slip-resistant footwear.
- Keep hands covered; if practical, wear mittens instead of gloves.
- Keep head covered; up to 40 percent of body heat can be lost when the head is exposed.

Leadership Aurora Class Explores Healthcare In Aurora

On Thursday, December 14 the Leadership Aurora Class 2007 was given a unique opportunity to experience first hand some of the aspects that goes into today's healthcare system. The day started at the Medical Center of Aurora (North Campus) with a wonderful breakfast and a twist. Each student was "given" a disability for the meal. For many this meant the use of a walker or oxygen. Others could not speak or were easily fatigued. For all it meant a new approach to everyday tasks and the loss of some independence and a newfound appreciation for those living with disabilities and those that help them.

From there the class experienced a simulated cardiac arrest situation and the rapid response of the Emergency Medical Team. The class was then transported via ambulance to see where future paramedics receive some of their training and advanced simulations they go through before hitting the streets. The ambulance ride gave the students an opportunity to ask questions and learn about the coordination involved when transporting a patient.

After lunch the class was treated to an insightful

discussion by Dr. Joel Levine from the University Of Colorado School Of Medicine. In his discussion Dr. Levine presented numerous facts about today's healthcare system and why we are in our current predicament as a country when it comes to healthcare. His presentation created some lively discussions between classmates during break.

The day was capped off with an entertaining presentation of the "Visible Human" by Dr. Vic Spitzer from the University of Colorado at Denver and Health Sciences Center. Dr. Spitzer

demonstrated how modern technology was being used to help students with anatomy without actually using a cadaver. The final presentation was an overview of the new Children's Hospital with its impressive architecture and state of the art medical facilities. What a coup for the City of Aurora to get such an impressive hospital after being in its current location for nearly 100 years!

The day turned out to be very educational and each classmate, regardless of their background, was able to take something away from the day.

Leadership Aurora grads sought to support class project at Excelsior

The Leadership Aurora Class of 2007 has chosen to partner with Excelsior Youth Center for their class project – but they are reaching out for some financial and material help.

They said their plan is to refurbish the auditorium and multi-purpose room on the campus of the residential treatment program for young women. To accomplish their project the class estimates it will need to raise a combined total of \$35,000 in cash and contributed materials.

Class member Kirk Downing said they were looking for everything from paint and stain to lighting fixtures and carpet. "We would like to upgrade lighting, the sound

our community. We've been partners with them for more than 80 years."

The base spent \$79.48 million in construction contracts and activities during the past year. The addition of the second child development center, Army aviation support facility and other projects all contributed to Buckley's economic impact.

With more than three dozen tenant organizations on the installation, Buckley continues to be the fastest growing Air Force base in the nation. It provides everything from family services for military members and their families to superior global surveillance, worldwide missile warning and expeditionary forces for combatant commanders, and support to Homeland Defense missions.

Data shows that Buckley contributed to the creation of 6,137 jobs in the community, which added approximately \$290.10 million to the local economy.

In addition to construction, indirect jobs and payroll dollars, the base contributed to the local area by purchasing goods and services from businesses throughout the Front Range community. The commissary spent \$12.19 million, the Base Exchange \$170, 958 and locally-provided health care added up to \$12.42 million. Service contracts were at \$43.96 million. Education costs for local training was at \$1.06 million, travel costs were at \$647,000 and more than \$30.04 million was spent on actual materials, supplies and equipment.

The Great High Line Canal Clean Up

Volunteers 8 years of age and older are needed for this year's Great High Line Canal Clean Up on Sat., March 17, 2006 (rain/snow date Sat., March 24) from 8 a.m. to noon. Registration will take place at the Community College of Aurora, 16000 E. Centre Tech Parkway, on event day.

Sponsored by Aurora Water, volunteers remove trash from the 11 miles of the canal that runs through Aurora before Denver Water's spring release of water, which turns the channel into a free-flowing stream leading into Sand and Tollgate Creeks.

The clean up protects a vital resource from pollution while improving the landscape for this high-use recreational area. This is also an opportunity to learn about the problems caused by littering and the importance of protecting and caring for our waterways by preventing pollution.

University of Colorado Cancer Center Names New Administrator
