## Prepare for attack on small business community — Employee Free Choice Act

Federal legislators including Colorado Senators and Representatives are under pressure to rewrite labor law that will have a huge impact on the way small business is conducted. The impact? Your employees will no longer be able to hear from you regarding matters that affect their jobs. Half of your employees will lose their right to speak up for themselves. As a business owner, you will lose the ability to give your employees raises for a job well done, provide health care benefits you can afford and discuss workplace standards with your employees in order to meet their needs. How can Congress even consider a bill that sounds this bad? Simple - call it the Employee Free Choice Act.

President Obama's hard-charging chief of staff, Rahm Emanuel, says that you should "never allow a crisis to go to waste." Big labor appears to be heeding that advice. It's trying to sell the badly misnamed Employee Free Choice Act (EFCA) — better known as card check — as a cure to rising unemployment and the ticket to a better life for the middle class.

The unions are also insisting that the legislation be

rammed through Congress as quickly as possible before the economic crisis passes or Americans discover the real facts about what it would do. Namely, it would effectively eliminate secret ballot elections in unionization votes and, through binding arbitration, give government authorities the power to dictate wages, benefits, and other

fundamental business operations.

"We think the legislation as currently written would curtail the rights of both employees and employers and would hamper economic recovery and growth," said Kevin Hougen, Chamber President and CEO. "As an organization representing hundreds of businesses from across the eastern metro area, we are encouraging our membership to oppose EFCA." Hougen said Colorado made the right choice when it chose to continue under the Labor Peace Act. "I think the cooler heads in Colorado understood that businesses and labor unions both could work well under this great umbrella that has covered our relations for more than 65 years."

A new study, which was conducted by the nonpartisan consulting firm LECG, determined that card check

## Arapahoe/Douglas Works! receives the National Theodore E. Small Workforce Partnership Award

The **Arapahoe/Douglas Workforce** Board was recognized as a Distinguished Honoree of the Theodore E. Small Workforce Partnership Award by the National Association of Workforce Boards at its annual Forum on March 8, in Washington, D.C.

The award recognizes top quality workforce investment boards around the nation that advance innovative partnerships with their business communities.

In early 2008, because of increasing environmental and energy concerns, Arapahoe/Douglas Works! formed a partnership with the Colorado Governor's Energy Office, the **Arapahoe County** Weatherization program, other local, state and federal agencies, and the Association of Home Appliance Manufacturers

Alliance to Save Energy.

The partnership, called the Youth Energy Conservation Corps, seeks to develop young men and women by providing paid and volunteer hands-on experiences in the emergent energy industry, and comprehensive education on career pathways within the new energy industry.

"This award demonstrates the ongoing creativity and innovation of our workforce center," said **Arapahoe County** Commissioner Jim Dyer. "It's partnerships like these that give our youth a head start in securing a bright and successful future."

Over the course of the year, the Youth Energy Conservation Corps will serve 37 young people with hands-on training and education in Energy career pathways. With each crew making three service calls per day, four days per week, nearly 470 Arapahoe and Adams County homes will be touched each year with Tier 1 energy audits generating annual energy savings of \$913,680.

legislation would negatively impact the landscape of the U.S. economy, increasing unemployment and stifling job growth for all Americans. In fact, the predicted increase of 1.5 million new union members in one year would lead to the loss of 600,000 jobs by the following year.

Additionally, a recent analysis conducted by labor experts at the U.S. Chamber found that increased unionization is anything but a ticket to the middle class. The states with the highest rates of union membership also have the lowest rates of job growth.

Why would Congress even consider passing such legislation? "I can give

you 450 million reasons," said Hougen. "That's how many dollars big labor shoveled into the 2008 elections. Now, it's payback time.

The U.S. Chamber in partnership with the Aurora Chamber is leading the fight against this power grab by the unions. "In these troubling and uncertain times, we know one thing for sure," Hougen stated. "When you find yourself in a hole, stop digging. Card check would delay and undermine economic recovery, and that's why it must be defeated. Every worker should have the right to join or leave a union under fair rules. Card check is not fair—and it's not right for Colorado, nor for America."
