Agreement on DIA development to go to voters

At the August Government Affairs Committee meeting, Adams County Commissioner Erik Hansen provided an update about proposed changes to the 1988 New Airport and Annexation Intergovernmental Agreement. The 1988 agreement resulted in the opening of Denver International Airport in 1995.

Nearly 20 years later, in April 2012, Denver Mayor Michael Hancock laid out a concept for an "Airport City." This prompted lengthy discussions and formal mediation, resulting in an "Aerotropolis" vision for the region.

The changes proposed to the Intergovernmental Agreement will go to a vote in both Denver and Adams Counties in November 2015.

Below, are changes to the original agreement, as well as initiatives that have not been changed.

What has changed:

- Creates 1,500-acre commercial development program with opportunity for expansion
- Adams County and Denver share any and all tax revenues 50/50 percent from program

Following official retirement, Ken went back to work to follow his passion for veterans and community, serving as an officer and/or member of innumerable veteran organizations, community boards/committees where he received many well-deserved awards for his service, dedication, and countless contributions.

As a member of the Chamber family, Ken served as an Ambassador for 21 years, and can be seen in almost every Chamber ribbon cutting photo. He was a very active member of the Defense Council where he served on the executive committee. He also served on the Government Affairs and Transportation Committees. His involvement in The Chamber was second to none! His commitment and passion were acknowledged through many Chamber awards, including the Community Leader Award (2003), the Bob Cardenas Award for

Military Support (2005), and the Ambassador of the Year Award (2002 and 2013).

Ken continued to serve his fellow veterans, his country, his community, and his family until his death on July 31, 2015. He will be missed deeply by his family, his friends, and all those he touched through his tireless efforts and kind heart. ■

DIA DEVELOPMENT (con't)

- Denver provides Adams County with upfront payment of \$10 million
 - DIA retains all lease revenue from new commercial businesses
 - Denver and Adams County communities create a regional entity to jointly market Aerotropolis
 - DIA does not seek new commercial businesses that would compete with the nearby Anschutz Medical Campus and Fitzsimons Innovation Campus in Aurora
 - Residential development restrictions
 - Denver may still develop accessory uses and natural resources
 - Noise restrictions
- Economic benefits of the new agreement include an estimated tax revenue of \$150-\$270 million in the first 30 years and 12,000 jobs. Colorado will also see an increased opportunity for development on and off airport by removing some protectionist restrictions and risk of litigation, ensuring a world-class competitive international airport for decades to come. ■

Personnel Center commander, the group travelled to Nellis in a KC-135 strato-tanker, getting an impressive view of the Grand Canyon along the way.

Once at the base, all of the hard working military were very proud to show off the great work they are doing. Nellis was a frenzy of activity due to the Red Flag air to air combat exercises being held. Varying types of aircraft — including F-15s, F-16s, F-22s, F-35s, AWACs, and B1 Bombers — were launching throughout the visit as part of the exercises.

A highlight of the tour was meeting the pilots and maintenance crews of the world famous Thunderbirds, and watching them launch. In addition, the group learned about the role of Remotely Piloted Aircraft (RPA) — don't call them drones — in combat support. RPA pilots work demanding eight hour shifts, and have been involved in every engagement at some level for more than a decade.

The participating leaders valued the experience, attaining a greater respect and appreciation for the behind-the-scenes operations that keep our nation safe and secure. ■

Two councils, one mission: economic impact

The Aurora Chamber's Defense Council (ADC) and the Colorado Springs Military Affairs Committee (MAC) held a joint meeting at the Colorado Army National Guard Training Facility on June 25.

ADC Chair Lisa Buckley and MAC Chair Major General (retired) Mark Volcheff, provided overviews of their respective areas. The keynote speaker was Colorado's Adjutant General, Major General Mike Edwards, who gave a summary on the April 2015 Military Value and Economic Impact of Department of Defense Activities in Colorado.

Gen. Edwards communicated that Department of Defense (DOD) investment and spending provide Colorado with a defense-oriented "industry," generating significant economic impact. The report shows that the DOD is responsible for 5-7.5 percent of the State's total economy in terms of employment, earnings, and state tax revenues.

DOD-related employment in Colorado is nearly 170,000.

At the end of the meeting, Lisa Buckley received a plaque of gratitude from Chamber President/CEO Kevin Hougen, for serving as the Defense Council Chair June 2012-June 2015.



More than 125 people from the ADC and MAC attended the joint meeting, along with local/state elected officials, business and community leaders, and U.S. Congressional representatives.

Xcel Energy seeks public input about transmission line

As part of a comprehensive plan to strengthen electric service and continue integration of cleaner and renewable energy sources along Colorado's Front Range, **Xcel Energy** is proposing construction of a new, 345-kilovolt (kV) transmission line



to connect its existing Pawnee Substation near Brush, Colo., to its Daniels Park Substation south of the Denver metro-area. The 125-mile project is part of the company's Senate Bill 07-100 portfolio and is a critical component of Colorado's long-range transmission plan. It will allow for the interconnection and delivery of new generation resources, including wind power and natural gas, to Front Range customers to meet new load growth and improve local system reliability.

The Colorado Public Utilities Commission (CPUC) approved a Certificate of Public Convenience and Necessity application for the project on April 9, 2015. The company seeks public input at three open houses, Sept. 29, 30 and Oct. 1, 2015.
