- **Community Engagement:** Meaningful involvement in the Dana Point community through volunteerism, support of local organizations, education initiatives, and charitable or in-kind contributions.
- **Business Excellence:** Demonstrated commitment to strong ethics, support of the local business community, and excellent customer service.

Nominations may be submitted by Chamber members, community members, customers, and business supporters. Applications will be reviewed by the Business of the Year Committee, comprised of past award recipients. Submissions should reflect contributions made during the 2025 calendar year and not lifetime achievement.
