- Displays strong fiscal management with diversified revenue sources
- Maintains a team of professional staff/volunteers and leadership
- Shown stability or growth in services or expanded programs and services
- Proven contribution to enhancing the community's overall quality of life
- Demonstrated commitment to ethical business practices and employee support and development

Eligibility Criteria

To be eligible for the Nonprofit of the Year Award, organizations must:

- Be a Chamber Member in good-standing
- Be a registered 501c organization or service group as defined by the IRS
- Possess attributes as listed above
