POLICY PLATFORM

AGRICULTURE:

We support policies that promote modern, profitable farming practices and strengthen the agriculture businesses that connect producers to markets.

Top Platform Connections: Taxes and Fees, Regulation, Economic Development.

1. We support a competitive tax and regulatory environment which includes efforts to diversify government revenue streams and intergovernmental cooperative savings to mitigate the need for higher taxes.
2. We support regionally consistent and streamlined processes that fast-track economic development.
3. We support responsible policy that leads to reduced operating costs.

WORKFORCE GROWTH & RETENTION:

1. We support efforts to make us an affordable place to live for the employees who currently work here.

1. We support transformational projects including but not limited to the Downtown Bloomington Streetscape Project, mixed-use redevelopment of Eastland Mall, Uptown North development, and community gateway improvements along Route 150 off I-55, Along Veterans Parkway off I-55, Along Business 51 off I-55 and I-74, Along Route 150 Coming from Downs, Along Route 9 Coming from the Central Illinois Regional Airport.
2. We support standard and fair tax incentives or otherwise appropriate public investments for economically viable projects that enhance the overall quality of life for McLean County residents that may not otherwise occur without a public-private partnership.
3. We support exploring the economic viability of transformational projects our most recent RAMP event participants identified as aspirational for the next decade including a multi-sports complex with an outdoor entertainment venue component, an aesthetically vibrant Midtown Corridor from Uptown to Downtown, and a designated and enhanced entertainment district.
