LEADERSHIP GRAND PRAIRIE is a learning experience and requires the following commitments by the participant:

- 1) Mandatory attendance at the Meet & Greet Orientation on August 27<sup>th</sup>, 2025.
- 2) This program will include a lot of walking, accessing a school bus (stairs), and may also include stairs at venues we visit. All attendees will travel together to maintain the daily schedule.
- 3) Please wear your LGP Polo shirts to class each month; business casual/business attire is recommended. Please wear comfortable shoes (no sandals or open-toed shoes).
- 4) Attendance at monthly sessions (8 hours each) is mandatory. Class dates will be September 4, 2025; October 2, 2025; November 6, 2025; December 4, 2025; January 8, 2026; February 5, 2026; March 5, 2026; April 2, 2026, and Graduation will be on May 7, 2026.
- 5) Timeliness. This requirement is not only a demonstration of proper business etiquette; it will allow all participants to gain the most benefit from the program.
- 6) **Tuition for the program is \$800**. A \$400 deposit is required by August 8, 2025. Payment in full is due by August 27, 2025.

Any program participant who is absent from the retreat or from more than 12 hours of class meetings will not graduate (we reserve the right to make exceptions in special circumstances). Tuition refunds must be requested in writing by September 1, 2025. No tuition refunds will be considered after that date. A \$50 processing fee will be deducted from each tuition refund.
