### What to Expect

There is no cost to participate in the IHCA Illinois Leaders program. There may be some incidental program or travel expenses the participants may have to pay, but they should be minimal. You must be employed by an IHCA member in good standing to be considered part of this program.

Participants in the Illinois Leaders program will receive reading materials at the initial class meeting and are expected to participate in all meetings in person. If meetings are missed without correspondence with the class liaison, participants may be asked to step down from the program.

Participants will receive complimentary reading material that will be discussed during the in-person meetings to help instill leadership qualities.
