Flights into Montreal is another excellent option, however, you will need to rent a car for the beautiful 2-2 ? hour road trip along the St. Lawrence Seaway to Quebec City. 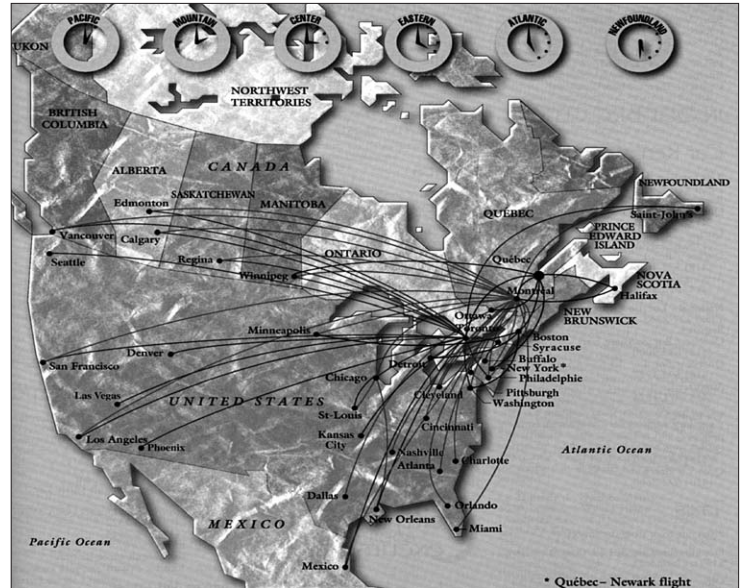

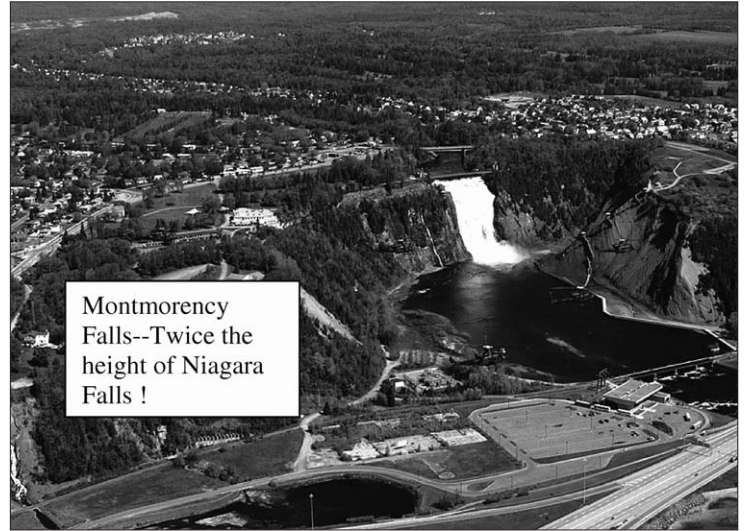

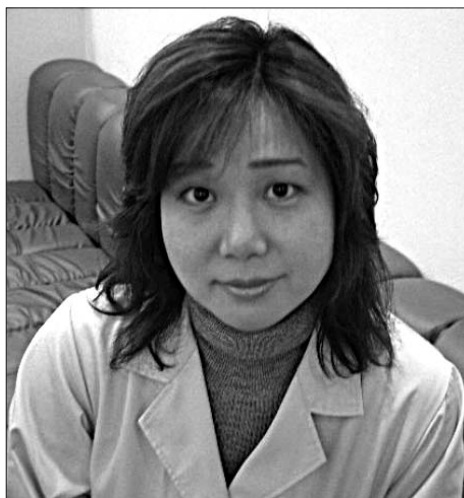

**Meeting Site:**

Fairmont Le Chateau Frontenac: at the beginning of the 17th century, a castle was constructed atop the commanding vantage point overlooking the St. Lawrence River. In 1620, this served to house the troops of Samuel de Champlain, official representative of Louis XII and founder of Quebec. Later it became the official residence of the first governor of Nouvelle-France and was called Chateau Saint-Louis. Finally, in 1893, it was purchased by Sir William Van Horne, president of the Canadian Pacific Railway, and turned into a luxury hotel. The hotel has been renovated numerous times, most recently four years ago and is one of the premier resort destinations in the world. Our board will convene in the salon where, in 1943 and '44, Prime Minister Mackenzie King hosted Roosevelt, Churchill and the
