Honoring the Memory of Dr. Robert S. Jackson, 1942-2023

Whereas: Dr. Robin Jackson was a member and Past President of the Northwest component of the Edward H.

Angle Society of Orthodontists; and

Whereas: We have learned with profound regret and sense of loss, of his death on August 30, 2023 at the age of

81 after a battle with Parkinson's disease; and

Whereas: Dr. Jackson was born in Montreal to parents Maurice and Marjorie Jackson. He grew up in the NDG

neighborhood along with older sister Sue, his twin sister Pam, and his stepbrother, Mike. Robin

excelled in football in high school and as an adult enjoyed swimming skiing, biking; and

Whereas: Robin graduated from the Dental School at McGill University in 1968. He then obtained his Master's

and Orthodontic degree at University of New York in Buffalo. Throughout his university years, Robin worked at the Manoir Richelieu Hotel in Quebec, rising to become the assistant guest services manager at the Hotel. He made lifelong connections at the hotel and could always be counted upon to find a

hotel job to fellow students and family members; and

Whereas: Dr. Jackson left Montreal in 1970 with his wife Joan for the west coast where Robin established his very successful Orthodontic offices in Richmond and Vancouver. Robin lived and breathed

Orthodontics and was considered an expert in the orthodontic care of children affected by Cleft Palate

and other craniofacial birth defects. He worked at the BC Children's Hospital in Vancouver; and

Whereas: Dr. Jackson was past president of the British Columbia Society of Orthodontics, he was the first

Canadian President of the Pacific Coast Society of Orthodontist. He was a Diplomat of the American Board of Orthodontists. He taught in the undergraduate Orthodontic program at UBC and later in the graduate program. He was the Social Chairman of the Biennial Meeting of our National Body when

the Biennial was held in Vancouver. He was involved in many AAO committees; and

Whereas: Dr. Jackson was much loved by his colleagues. He always knew the right person for the job, and

heavily encouraged younger Orthodontists to get involved, whether that was academically or politically. He would just tap you on the shoulder and say "you need to do this", and he was never

denied; and

Whereas: Robin had a strong connection with Pender Island where he and Joan bought land and built a vacation

home. He loved being with family, fishing and tinkering with whatever needed fixing. Over the past seven years with his new wife Lorine sought warmer climates and found a niche on the island of Maui

where Robin enjoyed snorkeling the sun and making new friends; and

Whereas: Dr. Jackson leaves behind his sons, Kibben (Danielle) and Tristen (Jennifer), his much-loved wife and partner, Lorine, his stepchildren, Collin (Angela) and Heather (Steven), and his grandchildren,

Tanner, Severin, Kai, Quin, Caleb, Cooper, and Margot. He was predeceased by his first wife, Joan,

who passed away in 1997; and

Therefore, Be It Resolved:

That this resolution be presented before the Board of Directors of the Edward H. Angle Society of Orthodontists as an expression of our deep sense of loss and that it be entered into the minutes of this Forty-fifth Biennial Meeting and that a copy of this resolution be sent to his wife, Lorine, and his sons, Kibben and Tristen, as an indication of our profound sense of loss and our admiration and gratitude for his many years of distinguished service and friendship.
