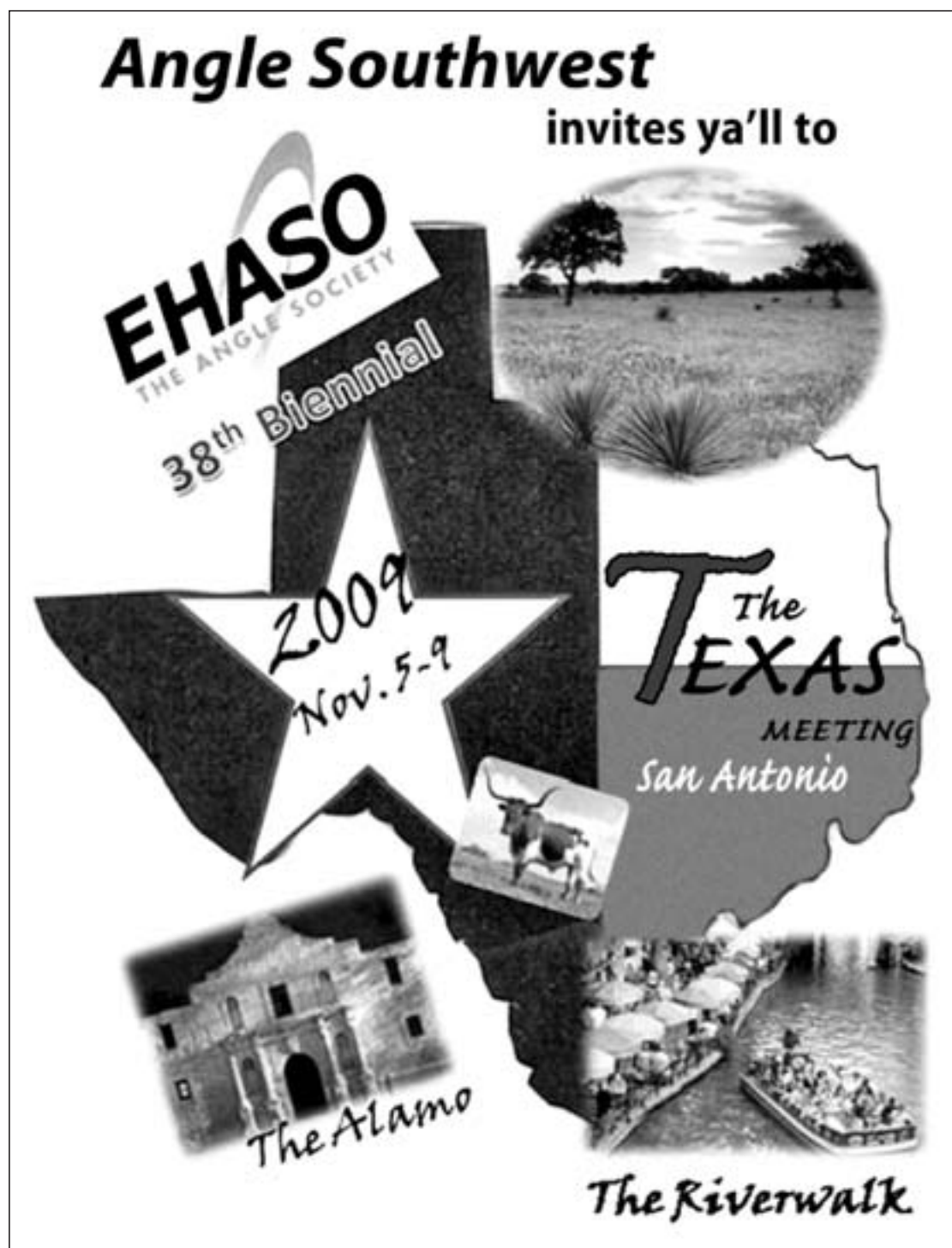

## ANGLE HERITAGE CAMPAIGN UPDATE

Thanks to the many Angle Society members and friends from around the world who have made a pledge to provide access to The Angle Orthodontist to anyone seeking orthodontic information, complimentary via our website. Our mission has been to:

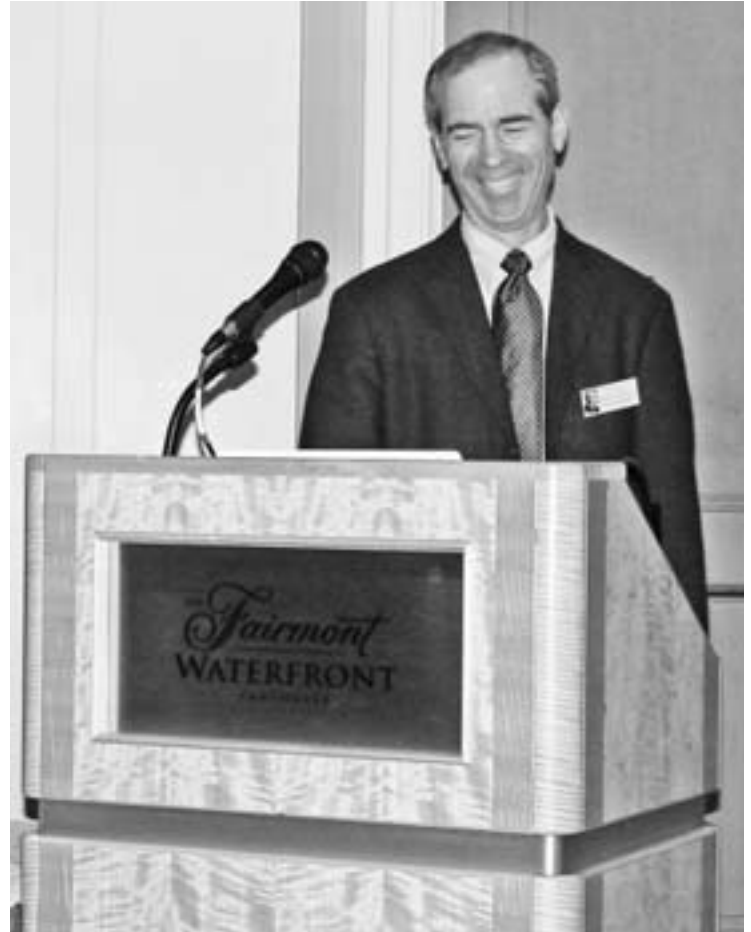
This June saw the Angle Northwest component meet in Seattle for their traditional one day scientific session at the prestigious Fair-
