

Obituary

It is with sadness that we report the passing of Marshall Deeney, DDS, in June 2010, after a brief bout with pancreatic cancer. Marshal is a past president of the Angle North Atlantic Component and was a part-time faculty member at the Eastman Institute of Oral Health (EIOH, formerly the Eastman Dental Center) for 33 years—beginning immediately after completing his residency in 1977. For the last couple of years, after leaving private practice, Marshall served as the Orthodontic Program Director

of EIOH. He received many Part-time Faculty Awards and the Iranpour Award for Excellence in Clinical Education at EIOH. In 2008, he received the AAOF Faculty Development Award.

Immediately after receiving his B.S. and D.D.S. degrees from the University of Toronto he practiced general dentistry with his father for four years.

Marshall led by gently nudging you in the right direction. He started as the captain of three varsity teams in high school. As the instructor of the Biomechanics course, he would lead you to the correct answer by building on what you already knew. He relished teaching and orthodontics and his enthusiasm was contagious.

Marshall is survived by his wife Marie-Elena, children Beth, Drew, and Patrick, and grandchildren. Of course all of us will miss his easy-going strength of character. ■




The second presentation of the morning was given by Dr. Doug Ramsay and entitled, "Thumb and Finger Sucking Habits

In Memoriam

Robert F. Schoenwetter

1915-2010

Dr. Robert Schoenwetter passed away on April 28, 2010, in Oshkosh, Wisconsin. He was born on January 11, 1915, in Beaver Dam, Wisconsin, the son of Dr. Albrecht and Leona Schoenwetter. After graduating from Beaver Dam High School, he attended the University of Wisconsin at Madison for his pre-dental education. Following graduation, he entered the Marquette University School of Dentistry, then entered the University of Illinois Department of Orthodontics, graduating with a Master of Science degree. Upon completing his education, he started his practice of orthodontics in Oshkosh in 1940.

Two years after starting his practice, World War II was raging and he entered the US Navy, serving at the Submarine Base at Pearl Harbor and at the Wisconsin General Hospital of the University of Wisconsin-Madison. He married Sue Viering in 1944 with whom he shared his life for 62 years until her passing in 2007.

Dr. Schoenwetter actively pursued his education throughout his career, attending post-graduate courses at the University of Minnesota, Northwestern University and the University of Illinois. He published 18 original research papers and presented two papers to the European Orthodontic Society in Paris. He was equally active in professional and civic associations, serving as president of the Oshkosh Chamber of Commerce, Oshkosh Downtown Rotary Club, the Winnebago County Dental Society, and the Fox Valley Dental Society. He was a long-time member of the Midwestern Component of the Edward H. Angle Society (now Angle Midwest) and served as its president in 1961. His one son-in-law, Dr. Thomas Sperry, now deceased, also was a member of Angel Midwest. Another son-in-law, Dr. Larry Johnson, is an orthodontist in Oshkosh.

Bob was a much-loved and loving father and grandfather, leaving three daughters, Jody (Bob) Orthey, Jill Sperry (wife of Tom Sperry, now deceased), and Jane (Larry), nine cherished grandchildren, and nine beloved great-grandchildren. He will be missed by his wonderful family and his many friends and colleagues.


