

The 2014 Angle East meeting was held in Paris, France from April 11 to April 15 at the Université Paris Diderot, UFR d'Odontologie Garancière. Robert Garcia, the Dean of the Dental School and Active Member of Angle East made arrangements for the scientific meetings as well as the social events. The University is situated on the Left Bank of Paris near Saint Germain des Prés, one of the touristic capitals of the world with old Parisian charm, museums, shops, restaurants and cafés. President Marcel Korn and Program Chairman Kolman Apt put together an interesting meeting of scientific research papers, critiques, clinical case presentations

and pearls. The same presentation format of last year's meeting was used. The academic evidence-based presentations and clinical papers were followed by a critique and then a general discussion period. The case presentations and pearls were nicely interspersed in the program between the scientific papers.

Guided tours, organized by the President's wife Gail Korn, were available for Angle East members after each scientific session. The tours included Louvre and Wine Man Tour, Paris Must-See Tour, Paris Montmartre Tour and Chateau de Versailles Tour.

Populations) and Anil Ardeshna (Three Dimensional Assessment of Morphological Changes of Constricted Maxillary Arches Treated with Rapid Maxillary Expansion and Damon System).



The Saturday session featured Dr Greg Huang, Chairman and Professor of the Department of Orthodontics, University of

Typically of Dr Vaden, we saw many, many treated cases demonstrating evidence based technique and orthodontic excellence.

Member Portrait: RICHARD P McLAUGHLIN, DDS




Rick was born in Seattle, WA and moved to Billings, MT when he was 6 months. His mom was a housewife; his father was a B-17 pilot in WW II and died on his 25th mission. He flew the very dangerous, difficult bombing runs from Foggia, Italy to the Ploiestie oilfields in Romania with just enough fuel aboard for the round trip. He was awarded a Gold Star Purple Heart. His mother remarried when Rick was 5. His stepfather was in charge of the Safety Pro-

gram for Standard Oil Company in Billings, MT.

Rick is the oldest of 2 sisters and a brother. He went to Billings Central High School and was both an outstanding student and baseball player. He was awarded a four year baseball scholarship to Georgetown University as an outfielder and graduated four years later with a Bachelor of Science in Chemistry. He was then offered a baseball contract by the Washington Senators, but instead, chose to attend Georgetown University's School of Dentistry. After graduation, he spent 4 years as a Dental Officer in the US Navy, stationed in San Diego and then Japan.

While in San Diego he became friends with Larry Andrews, spending time in his office. This relationship sparked his interest in

Orthodontics. Upon his discharge from the Navy, Rick attended the University of Southern California, School of Dentistry, Department of Orthodontics. He was mentored by Angle members: Harry Dougherty, department chairman; Terry Root, Don Tuverson, Sky Joyner, Bob Schacter as well as others.

While an undergraduate at Georgetown University, Rick met his wife, Dorene who has a Masters degree in Marriage and Family Therapy as well as a doctorate in Leadership from the University of San Diego. They have 3 grown children: son John, a stockbroker; daughter Cindy, an aesthetician; and daughter Casey, a secretary at a local high school. All live nearby in San Diego. Rick and Dorene are also proud grandparents to two grandsons.

In 1985, Rick was interested in becoming a member in the Angle Society, Southern California. The normal procedure then to become an Affiliate member, was to present 5 cases that would hopefully be approved after careful scrutiny by the case graders. Then within the next 2 years to become a Regular Member, 10 additional cases would be shown, as well as a paper suitable

for publication in the Angle Orthodontist. Occasionally, the 2 year interim between Affiliate and Regular Membership would go to 3 and 4 years and finally an ultimatum would be given to the candidate, to complete the requirements or be dropped from membership.

In Rick's case, he presented all 15 cases and gave a brilliant all-day presentation on Malocclusion and the TMJ—An Historical Perspective; he was of course awarded his Regular Membership in Angle Southern California, and as hosts for the 1987 Biennial meeting in Newport Beach, gave the paper again in September of that year.

Rick served as President of Angle Southern California, 1994-1996, is our Component Director and is currently President of the National Edward H Angle Society. At the end of his tenure, 2015, Angle Southern California hosts the 41st Biennial meeting, September 24-29, at the Langham Huntington Hotel, Pasadena, CA.


Early in Rick's career he was an associate of Larry Andrews in San Diego. He now is in full time practice in San Diego with his partner, Paul Upatham, a former graduate orthodontic student from USC. 
