Biennial Meeting: ANGLE RETURNS TO PASADENA

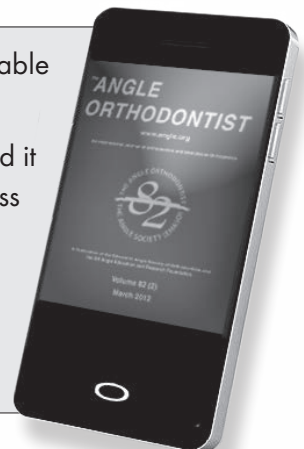

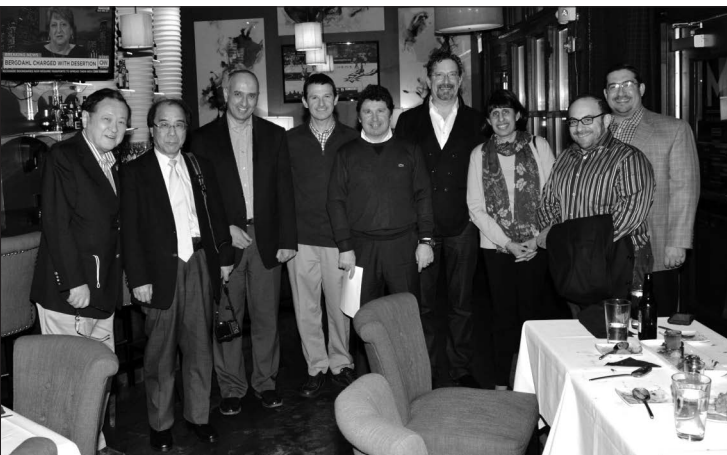

Scientific Sessions

President Harry Legan opened the meeting by welcoming our guests Dr. Carlos H Guimaraes, Brasilia, Brazil, Jr., Dr. Himawan, Halim, Jakarta, Indonesia, Dr. Kenji Hiura, Tyuoku Fukuoka, Japan, Dr. Eric W Howard, Lancaster, PA, Dr. Eung-Kwon Pae, Baltimore, MD, Dr. Roger M Selden III, Huntersville, NC, and Dr. Carlos Villegas Bateman, Medellin, Colombia.

Dr. Ron Bellohusen arranged a wonderfully varied and robust scientific program. It commenced Thursday morning with the opening paper by Dr. Bhavna Shroff, "Current Trends in the Angle Society" which focused on membership trends and influences of generational differences between baby boomers, gen x's, gen y's, and millennials.

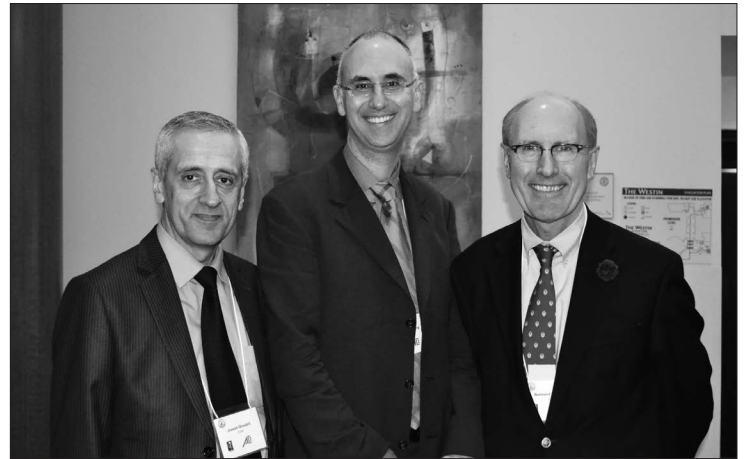

Takashi Yamashiro was voted by Angle East members to receive the 2015 Brainerd "Barney" Swain Award of Excellence for the best paper presented at the 2015 annual meeting in Washington, D.C. The title of his paper was "Effects of Maxillary Anterior Segmental Distraction Osteogenesis in Patients with Cleft Lip and Palate". He evaluated patients with cleft lip and palate who were treated with distraction osteogenesis in the maxillary anterior segment. The winner of this award receives a certificate and the prestigious nomination to be speaker at the next EHASO International Biennial Meeting which will take place this coming September in Pasadena, California.

Other Angle East awards were presented at the Saturday evening Grand Dinner Banquet. Howard Anstendig received posthumously the 2015 Distinguished Service Award. The award was given to Howard's wife Dr. Linda Anstendig and his daughter Ms. Karin Mosk. Howard served as President from 2007 to 2008

Dr. Thomas Butterfoss chaired our Friday morning session and Dr. Gary Opin presented "The Benefits of Animal Assisted Therapy in an Orthodontic Office". Reviewer: Dr. Peter Bronsky.

Dr. Eser Tufekci presented "Headgear - Blast from the Past" an informative survey (with a very impressive response rate) of practicing orthodontists and their current views and use of Headgear. Reviewer: Dr. Hilton Wasilewsky.

Dr. Michael Woods presented "An Assessment of Surgical and 10 Year Follow-up changes in Vertical Facial Pattern with Class II and Class III Orthognathic Surgery" Reviewer: Dr. Bruce Haskell. Dr. Woods demonstrated that even with surgical correc-

tion, long term the vertical facial patterns that were present at the beginning of treatment, tend to recur over time.

Dr. Alex Bottrel presented "Esthetic Archwire Preference and Maintenance of Clinical Appearance after Repeated Brushing cycles" Reviewer: Dr. Robert Miller. Dr. Bottrel found that most wires perform poorly when judged by clinical appearance after repeat exposure to tooth brushing and that the best wire still had much room for performance improvement.

Friday's session ended with memorial remembrances of Dr. Dan Subtelny and Dr. Charles Burstone, both truly significant contributors to the profession and both important members of our component who both passed away since our last annual meeting.

Dr. Ron Bellohusen presented a montage of photographs throughout Dan's life accompanied with music. Ron narrated some of the photographs with colorful and entertaining anecdotes about Dan's life. It was a very moving tribute. Dr. Rich Faber also presented a wonderful tribute to Charley Burstone with photos from throughout his life. Dr. Majourau-Bouriez shared her experience with multiple CLP patients and her team's approach to ensuring all aspects of treatment planning and execution were cohesive in order to obtain a patient's needs centered result.

Dr. Kazunori Yamaguchi presented "Effects of Mouth Breathing on Masticatory Efficiency" Reviewer: Dr. Yukio Kitafusa.

The final presentation of the meeting was Dr. Sunil Wadhwa on "The Role of Estrogen in Mediating TMJ Disorders" Reviewer: Dr. Antonino Russo. ■

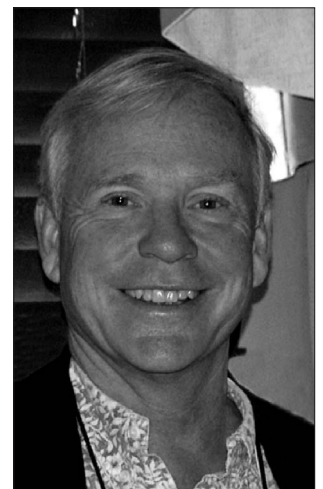

Member Portrait:

ERIC LOBERG

Eric was born in Jacksonville, NY, about 10 miles outside of Ithaca. He was the youngest of 4 boys. Outdoor activities, camping, hunting and fishing were a large part of their growing up. Along with these experiences, Eric became an Eagle Scout.

Eric attended elementary school in a 2 room school house until the 5th grade when the family moved to Cayuga Heights, closer to Ithaca and Cornell University, where his father, Harry J Loberg, was Dean of the School of Me-



chanical Engineering. Eric graduated from Ithaca High School and went on to Cornell to major in Economics and Psychology, in addition to a pre-dental curriculum. Like many boys of this era he had a paper route while growing up and saved enough money to purchase his 1st car, a 1960 MGA 1600 by the time he arrived at Cornell.

Of Eric's 3 brothers, two became engineers following their dad's footsteps, and the other was a Judge in Santa Barbara. Their mom, Aline Loberg, had the most difficult job of all, staying home and raising 4 boys.

At Ithaca High School Eric participated in soccer, swimming, tennis and was on the rifle team. He excelled in swimming: 7th best in the East in 100yd breaststroke, 1st in the section in singles tennis and his soccer team was 1st in league. Academically, he participated in the Latin Club, Spanish Club and debating society. This latter speaking skill is apparent when Eric presents scientific papers.

As a freshman at Cornell, Eric went out for a new sport: crew. Out of 160 other freshmen, Eric made 1st boat as the 3 man, and made Varsity again as the 3 man, his sophomore year. They were undefeated in Intercollegiate competition and were sent to England by the University to row in the Royal Henley Regatta, held at Henley-on-the-Thames, England, established in 1839; a very prestigious, colorful event.

After competing at Henley, he stayed in northern Europe, bought a Triumph motorcycle and toured for the Summer. Sadly, Eric's father passed away during his sophomore year at Cornell, so he felt the necessity of being serious about his professional career. He applied to Tufts Dental School and was accepted after 3 years at Cornell.

During dental school to help make ends meet, he worked various odd jobs from bartender at a local watering hole to phlebotomist at Boston Floating Hospital.

After graduating from Tufts in 1970, Eric was influenced by Dr Robert Baker, past Angle Society President, to become an orthodontist rather than going into oral surgery of which he had had considerable experience. Eric says: "I owe my orthodontic life to Dr Baker".

As most orthodontic departments at the time, Eastman Dental Center did not take graduates directly out of dental school, so Eric did a rotating internship before being accepted to the Orthodontic Department headed by Dr Dan Subtelny.

Eric graduated from Eastman in 1973; Dr Baker immediately introduced him to his close friend and study club member, Dr Howard Lang, of West Los Angeles, 3000 miles away. Eric promptly took and passed the California Dental Boards, and began as an associate/partner with Dr Lang in 1973. He and Howard, the consummate orthodontist, Angle member, and gentleman worked together for 8 years until Howard retired to Newport Beach. Eric states that these 8 years were very special between him and Howard. Their diagnosis and treatment planning were very compatible. They were their own study club.

Howard was Eric's sponsor in Angle Southern California; Eric joined, became a Regular Member in the early 80's and was past President for the year 1992-1993. Eric also became a Diplomate of the American Board of Orthodontics in 1981.

At the request of Dr Pat Turley, Eric began teaching at the UCLA Graduate Orthodontic Department in 1989 and is an assistant professor and clinical instructor one-half day every 2





weeks. He has been honored by the residents being voted 'Instructor of the year' numerous times during his 25+ years teaching at UCLA.

While at Eastman in Rochester, Eric completed in the Flying Dutchman Class sailboatout of the Pultneyville Yacht Club and raced in the Nationals of that class which were held in Rochester. He also began playing rugby for the Rochester Rugby football Club which won the Upstate New York Championships at Syracuse in 1972. Later, after moving to the West Coast, Eric played outside center for the Los Angeles Rugby Club. His rugby career ended after suffering a displaced mandibular mid-symphyseal fracture with the right condyle fractured from the inferior border of the sigmoid notch to 1/3 of the way down the posterior border of the ramus at a match in San Diego. After initial fixation by Dr Frank Pavel, San Diego, he had additional treatment by Dr Marsh Robinson of USC. Fortunately, from such a horrendous fracture, Eric has had no residual problems.

Eric presently is a member of the California Yacht Club, having been a member since 1973. He has raced aboard several 'high end', racing sailboats such as the Cal 40, Reichel-Pugh 42, and the Farr 40. He raced in the Kenwood Cup in Hawaii, the Big Boat series in San Francisco and the Key West Race Week. His duties as crew would be jib and spinnaker trimmer.

Eric also competed in small boats, 470's, the aforementioned Flying Dutchman, Etchell's, Stars and Thistles. More recently, Eric has returned to his first love from his days at Cornell, crew. He competes now, in Masters Rowing, where he has been US National Champion 8 times, Canadian National Champion 7 times and Intercollegiate Rowing Association masters National Champion in an alumni boat from Cornell, 12 times.

He is still competing; his latest victory was in 2013, and he is preparing for another campaign and victory this year. To stay in shape, Eric follows a rigorous schedule averaging 6 days a week beginning most mornings at 5:30 am. At the California Yacht Club, he has two, pair/double shells and also a single that he rows; or at home where he has a Concept 2 ergometer rowing machine. He averages about 7,000 meters per day.

Eric met Mary Fogarty while he was in Dental School at Tufts, and they have now been married 46 years. Mary graduated from Emmanuel College in Boston with a BA degree and taught art in Junior High and High School until they began their family. They have 3 daughters: Kristin, a graduate of her dad's alma mater, Cornell, and a successful ghostwriter; Erica, a graduate of Columbia and also an author, poet and mental health advocate; and Dana, a graduate of Yale and co-founder of a social media networking and marketing platform for the movie industry. Eric and Mary have done a outstanding job of educating their gorgeous daughters! Kristin is married with 2 children.

Eric has been and is an active member of the Westwood Village Rotary Club, having served as President in 1982-3.

When not rowing or practicing Orthodontics, Eric and his ladies enjoy fishing for King Salmon off of Vancouver Island.

Eric credits the 3 most influential people in his orthodontic career, all 3 being Angle members from years past: Dr Robert Baker, Dr Dan Subtely and Dr Howard Lang. Carrying on their leadership, Eric has also been a strong thought provoking voice in orthodontics and the Angle Society. He publishes frequently in *The Angle Orthodontist* and *The American Journal of Orthodontics and Orthopedics*. He has been a presenter at the Angle

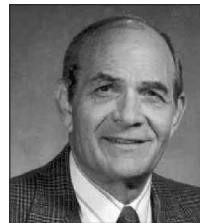

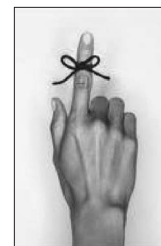

I first met Sal while teaching at Univ. of Pittsburgh 1962-1972 after finishing my orthodontics at Temple in 1961 while building my practice in Butler 40 miles north. He came to teach at Pitt after Harvard in 1964 and we became good friends from that time forward. His practice was in the North Hills suburb of Pittsburgh. Sal was a talented and conscientious orthodontist with a very interesting background and wide sphere of life activities. His father, born in Italy was a Presbyterian minister in the Homewood-Brushton (primarily black) area of Pittsburgh where he sometimes gave the sermon in Latin or Italian! His twin brother is a physician In Texas and another brother a professor

at Princeton Theological Seminary. For a number of years Sal flew his own plane and had a Harley D motorcycle. A good story he related was one day two nuns in a car forced him into a ditch and never stopped.....he uprighted the bike and followed them back to the convent where he gave them a real piece of his mind! He thought about calling the police but didn't. Sal was a dedicated husband and father, and a highly ethical individual I always respected. ■

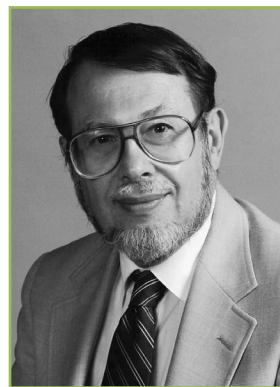

SAYING "GOOD-BYE" AND "THANK YOU" TO A LEGENDARY FIGURE IN ORTHODONTICS

I can close my eyes and still see him standing in front of me but, most of all, I can hear him speaking. So clearly that I would swear he is here.

I got news of the passing of Dr. Charles Burstone in an email on February 11, 2015. To me, he will always be Dr. Burstone. He was my teacher and mentor. I could talk about him to others as "Charlie" and I could address him as "Charlie" in an email but, in my mind and to his face, he was always "Dr. Burstone". He did not demand that respect but he commanded it. It was what he deserved.

The news caught me totally off-guard. Of course, it was possible. Dr. Burstone was 86 years old, almost 87. But it just never occurred to me that it could happen...ever. He was always there and he would always be there. I watched him get older but he never seemed to fade in any way. I saw him at every AAO meeting, at Angle meetings, at University of Connecticut (UConn) alumni events, and I corresponded with him occasionally for various reasons. My last communication with him had been only 2 weeks earlier when he had agreed to be a speaker at the AAO annual session **for 2016!** I often heard what he was doing and where he was going. He was everywhere. Whenever I saw him, there was always a crowd gathered around. He was legendary.

I was a dental student at UConn when I first met Dr. Burstone. He had given lectures to our dental class that no one understood. He was the department chair and I made an appointment with him to discuss my interest in pursuing specialization. He asked me what it was that interested me about orthodontics. I didn't know what the "right answer" should be but, surprisingly at that time, I wasn't nervous. I said that orthodontics offered the opportunity to apply physical principles to biological systems and that I thought that was particularly exciting. Could you have come up with a more perfect answer?

Staying on at UConn to obtain my certificate in orthodontics and Master's degree, I was able to spend many more hours with Dr. Burstone: in seminar, treatment planning, analyzing treatment outcomes, and in clinic. He posed challenging questions and, over time, I became increasingly doubtful that I would be

able to produce the "right answer." Dr. Burstone would give you a certain grimace when the answer was wrong and you would know that it was time to straighten up. The more I learned, the less confident I became that I knew the right answer. There was always more to know.

As his students, one thing that we, the Class of '89, knew for sure, was that Dr. Burstone knew everything and that he was always right. It didn't matter what the topic was, whether it was orthodontics, or European history, or current events. Even when we were sure he was wrong, he was always proven right. Sometimes it would be weeks later that we would find out. After a while, there was no point in arguing. We knew he was right.

Dr. Burstone is certainly one of the people most responsible for my decision to pursue academics as a career. I joined the orthodontic postgraduate program with every intention to enter private practice upon graduation. He convinced me, and maybe even forced me into academics. He persuaded me to give it a try. I remember when he took me aside and comforted me, confiding that it was indeed possible to be successful in orthodontic academics without obtaining a PhD. Obviously, I was not the only one. UConn's orthodontic program produced more orthodontic academicians than I am able to count. Credit that to a vision and well-thought-out planning. Credit that to Dr. Burstone himself.

I am claiming Dr. Burstone as my own but, of course, there are many others who can do the same. To me, he personified UConn's orthodontic program. But, he was a native of St. Louis, and certainly Indiana University justifiably claims him as well. Indeed, most of the world can legitimately claim him as theirs. His passion was orthodontics and he loved to travel, he loved to lecture, and he loved to spend time with students all over the world. He was on sabbatical in Germany when we completed the orthodontic program at UConn in 1989, and Bhavna Shroff and I traveled there to visit him after graduation. When we arrived, his first words were enthusiastic expressions of the positive experiences he was having with the students there. Indeed, he was overseas lecturing when he passed away in February.

It is tragic that Dr. Burstone is gone but I think he would have planned for it to happen the way that it did. He was active to the end and he died doing what he loved the most: sharing his knowledge with those who shared his passion. ■

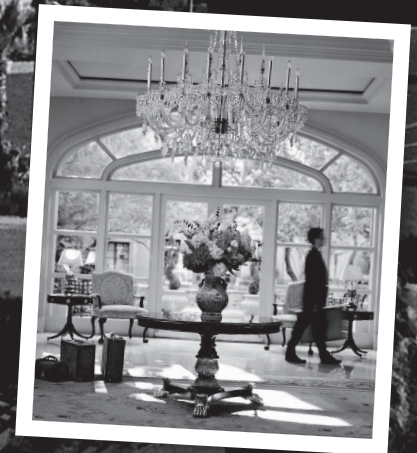
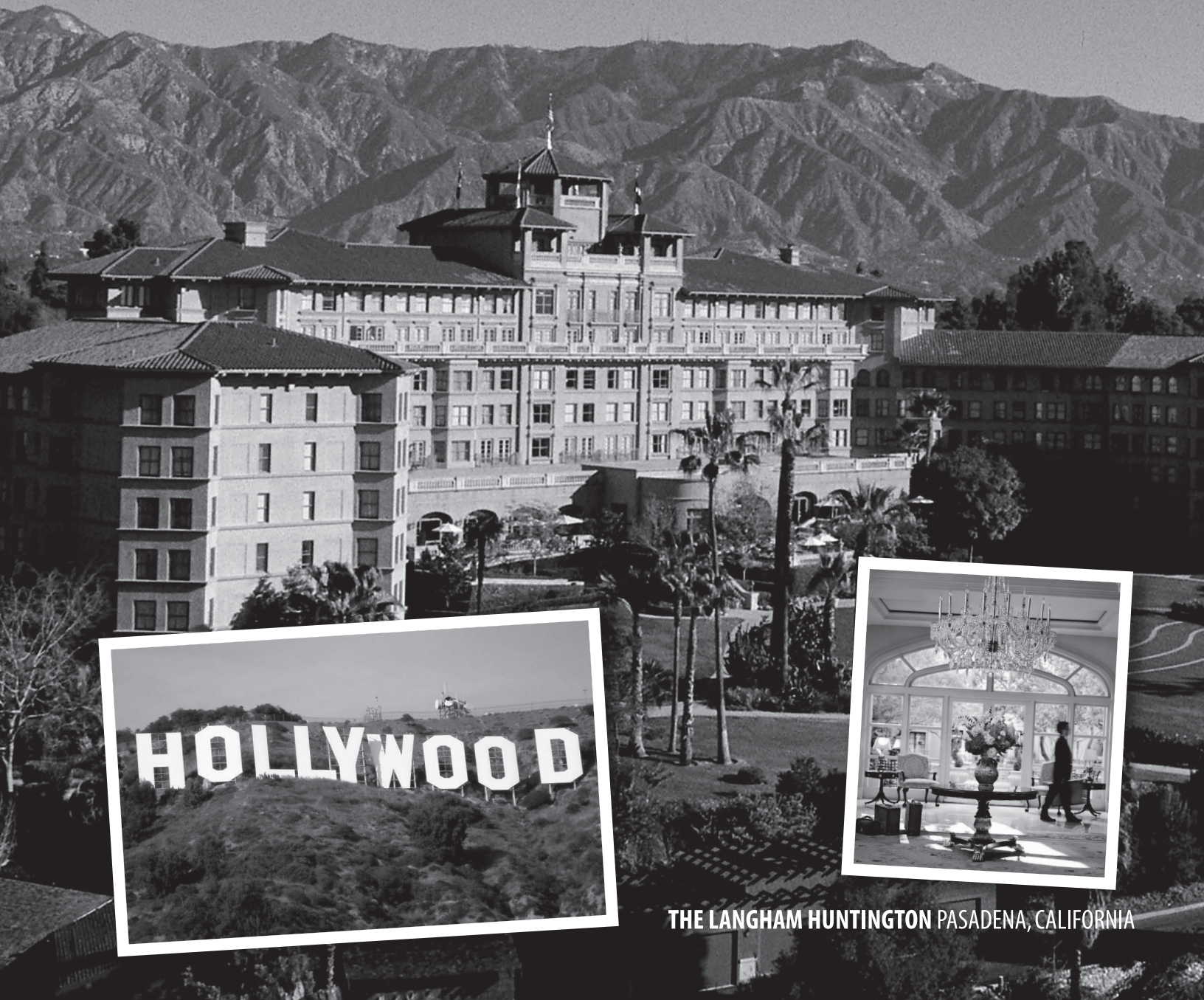
