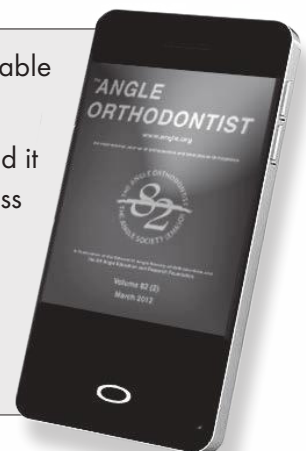

2016 – 52nd Annual Meeting, April 13-17, Windsor Barra Hotel, Rio de Janeiro, Brazil

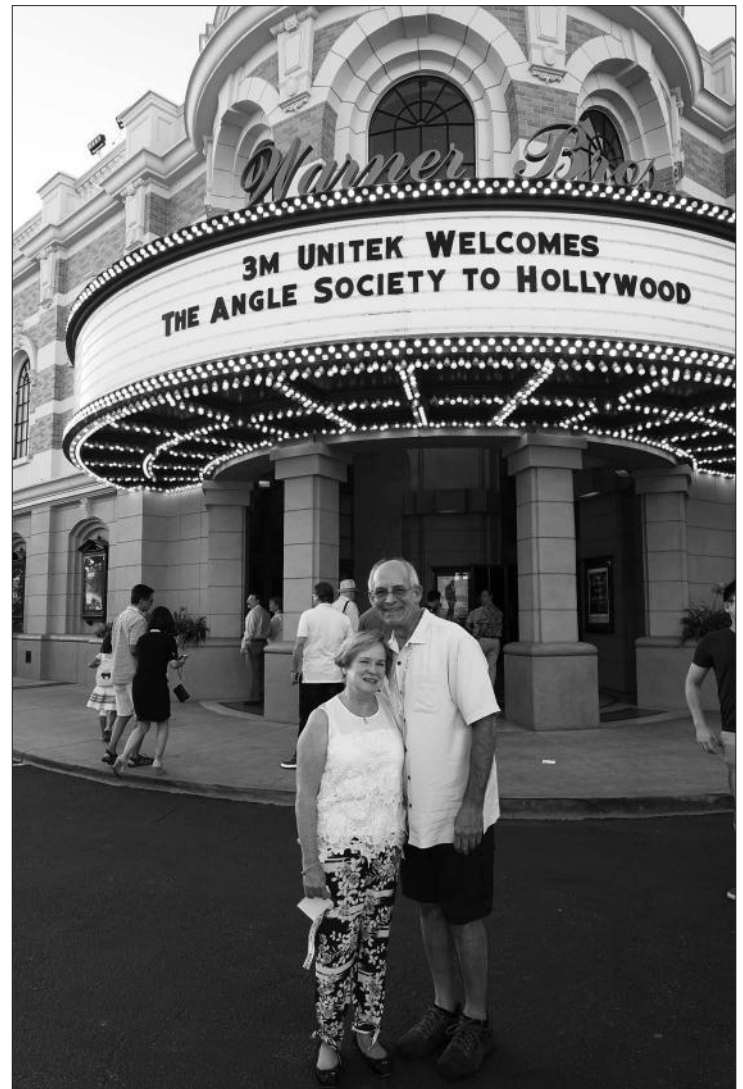
Our president, Dr Harry Legan, has coordinated with member Dr Alex Bottrel to arrange our meeting in Rio at the Windsor Barra hotel. Rio is located in the southeast region of Brazil and has a population of 6.5 million in the city proper and 12 million in the metropolitan area. The Carioca Landscapes of Rio were designated by UNESCO as a World Heritage Cultural Landscape in 2012. This area includes the Tijuca Mountains (largest urban forest in the world) down to the sea, the botanical gardens, Corcovado Mountain with its celebrated statue of Christ, the hills around Guanabara Bay, and the extensive landscapes along Copacabana Bay. Rio is Brazil's best known city and lays claim to Carnival, choro, samba & bossa nova (Brazilian musical genres), & world famous beaches such as Arpoador, Ipanema, and Copacabana. Rio is also home to numerous major works of art and public buildings, such as the National Museum of Fine Art, the Itamaraty Palace, National Museum at Quinta da Boa Vista, National History Museum and the National Library, as well as the Candelária (Roman Catholic Church) and the São Bento Monastery.

The Barra neighborhood, location of the Windsor Barra Hotel, is one of the most developed places in Brazil with a mix of modernity, sustainability and nature. It is considered a cultural, economic and administrative hub of the city and will play host to most of the venues of the 2016 Summer Olympics. The Windsor Barra is located across the street from the beach of Barra da Tijuca and is virtually oceanfront. International and regional restaurants are a couple minutes walk from the hotel, as well as shopping venues 2.5 miles away.

Members of course are looking forward to the scientific program (courtesy of Ron Bellohusen), the new member presentations, and meeting our invited guests.

News from the EHASO International Biennial- Pasadena, California, September 25-29, 2015

Report from Peter M. Greco - Director - Angle East

The 41st Biennial Meeting of the E.H. Angle Society of Orthodontists was hosted by the Southern California Component at the Langham Hotel in sunny Pasadena, California. There were more than 130 Active, Affiliate and Guest members of the Society in attendance, including 10 attendees from our Component.

A pre-meeting Board of Directors conference on Friday, September 25 was followed by a visit by the Executive Board and the Southern California's planning committee to the final home of Dr and Mrs Edward H. Angle in Pasadena. The property's owner graciously opened her home to welcome us. Dr Sheldon Peck was a most enthusiastic tour guide as the entourage viewed the actual sites where orthodontic greats such as Tweed, Steiner, Hahn, Begg, Brodie and many others received their orthodontic specialty education. We also walked the grounds of the last Angle School, which is adjacent to the Angles' home but serves as a family dwelling. Both structures bear remarkable resemblance to those depicted in century old photographs. Even the front steps, the front door and the house numbers on the home are original. The landscape of the home and school, as well as that of the neighborhood, retains its original grace and affluence of the early 1900s. Everyone who attended felt as if time had stood still as we pictured Dr and Mrs Angle soon to appear standing tall in their natty clothing of the early 1900s as we moved from room to room.

The Scientific Meeting began on Saturday, September 26, and opened with a keynote address by Mr Randy Shulman of the Huntington Library, Art and Gardens. Mr Shulman described the rise of Southern California as a haven for the wealthy of the East and Mid-West, and the region's subsequent boom to economic prosperity and cultural renown. He described the vast influence of Mr Henry E. Huntington, who was seminal in developing a viable railroad network in the region. This innovation greatly contributed to Southern California's financial development. The presentation described Mr Huntington's expansive estate in Pasadena, that same site which the attendees toured on Sunday afternoon. It is impossible to describe the magnitude and beauty of this estate, but try to picture a 50,000 square foot home with an adjacent (and comparably sized) library that resembles the Parthenon. There are also internationally-themed gardens (China and Japan, for example), a massive rose garden and flora from all corners of the globe, and more artwork than is found in some museums. A few minutes search on the Internet will give the reader a flavor of the expanse of the estate, but will not give it justice. There was also a golf tournament held at the Angeles

National Golf Club. Several walking tours through Old Pasadena and the elegant neighborhood surrounding the hotel allowed the attendees to enjoy the California sunshine and the camaraderie that typifies our Angle family.

One of the outstanding highlights of the meeting was The Angle Memorial Lecture which was delivered by both Drs Patrick Turley and our own Sheldon Peck. This was an enthralling presentation comprised first of Dr Turley's review of Dr Angle's letters to Dr Albin Oppenheim and another colleague, Dr Rolf Grunberg. The account provided ample insight into the character and motivation of Dr Angle and his mutual respect of Drs Oppenheim and Rolf Grunberg. Dr Peck followed with an inspiring, pictorial look at Angle's migration throughout the United States. Dr Angle's motivation and impact on each community in which he lived and taught

was portrayed by an illustrative series of vignettes that only Sheldon could deliver. Both presentations delighted the members and well as their guests.

Drs Takashi Yamashiro and Sylvain Chamberlain represented our Component nobly in their scientific presentations, as did Dr Bill Cole and John Voudouris in leading discussions of speaker's presentations. As usual, the Scientific Program represented the "Crème de la Crème" of the Best Papers from our own and the nation's other components.

The Society was treated to a guided tour of The Warner Brothers' Studio, with an on-site buffet dinner and drinks, donated by 3M Unitek. Filming sites that are currently used for "The Big Bang Theory" and many other television and movie favorites were viewed.

The next Biennial Meeting will be hosted by Angle Midwest at The Drake Hotel in Chicago from September 6-10, 2017. The Drake Hotel is significant as it was the site of the First Angle Meeting held by widow of the late Dr Angle, Mrs Anna Hopkins Angle. You won't want to miss this one either!

News

Sylvain Chamberland and Takashi Yamashiro were selected - respectively in 2014 and 2015- to be the recipients of the Brainerd "Barney" Swain Award of Excellence, and represented the Angle East at the EHASO International Biennial Meeting.

Takashi Yamashiro study was titled "Effects of Maxillary Anterior Segmental Distraction Osteogenesis in Patients with Cleft Lip and Palate". Patients with a cleft lip and palate (CLP) typically show a high incidence of Class III malocclusion and mid-facial retrusion. LeFort I osteotomies have conventionally been used to achieve maxillary advancement in CLP patients, and the procedures improve occlusal relationships, enhance speech articulation and favor nasal breathing. Yamashiro's paper described the recently developed technique of MASDO, which facilitates the forward advancement of the anterior maxillary segments without affecting the patient's velopharyngeal function. MASDO also corrects anteriorly-flattened dental arches that are characteristically observed in cleft palate patients with severely retruded maxillae. The purpose of the study was to evaluate the long-term effects of MASDO in CLP patients and identify risk factors for an increased relapse rate. The results show that MASDO is effective for correcting skeletal Class III problems with mid-facial deficiencies, and that an increased relapse rate is considered to be related to the counterclockwise rotation of the maxilla during surgery.

Sylvain Chamberland's paper was titled "Functional Genioplasty in Growing Patients", and evaluated the role of age as a moderator of bone regeneration patterns and symphysis remodeling after genioplasty. Symphysis thickness increased significantly during the 2-year postsurgery interval especially in patients younger than 15 y.o. Remodeling above and behind the repositioned chin also was greater in the younger patients. This was related to greater vertical growth of the dentoalveolar process in the younger patients. There was no evidence of a deleterious effect on mandibular growth. The paper concludes that when indications for this type of genioplasty are recognized, early surgical correction (before age 15) produces a better outcome in terms of bone remodeling.

Both papers were well received and are being submitted for publication in peer reviewed scientific journals.

Friday evening we will be sampling some of the famous Portland food and wine experience at the Uptown Billiards Club.



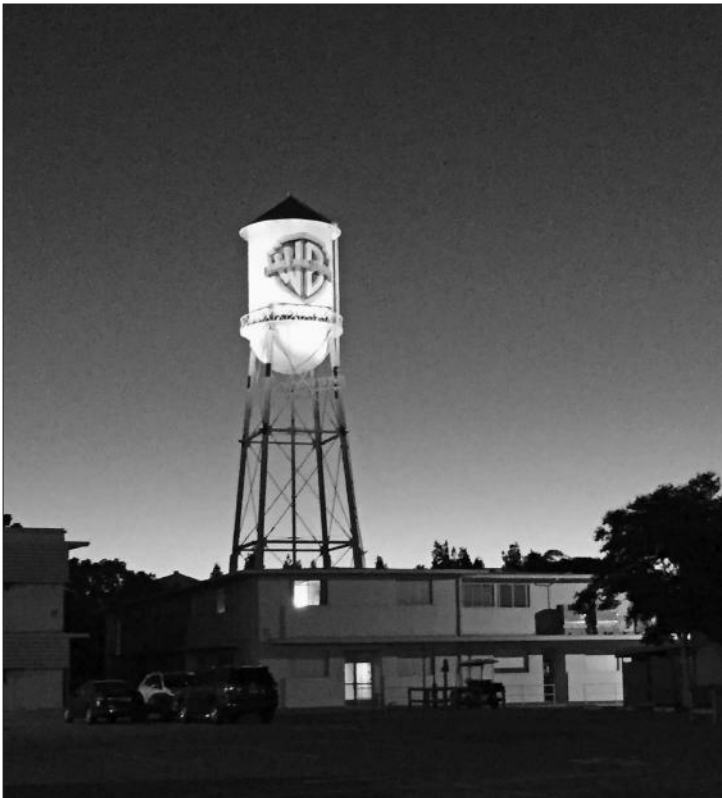

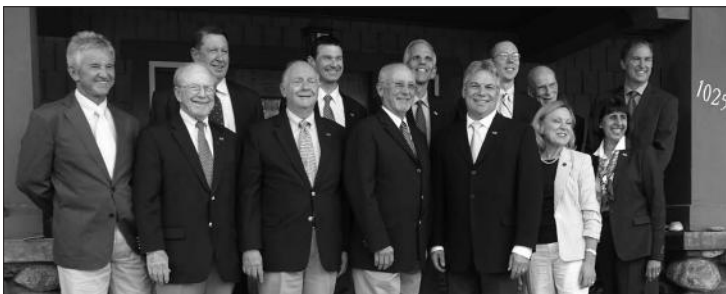
Angle Southern California also had recently treated cases from our component on display in one of the meeting rooms for members to study treatment plans and the results attained.

DR JAMES MORRIS REYNOLDS

Dr James Morris Reynolds, 97, of Lubbock passed away on October 14, 2015 after a brief illness following a fall. A resident of Lubbock for almost 70 years, Jim was orthodontist to legions of young people in West Texas, a civic leader and devoted husband and father.

His practice was also the basis for a life-long role in the profession, culminating in a trustee role and his election as President of the American Association of Orthodontists in 1981-1982. He was a founding member of the Angle Society Southwest and a lifelong member of the Tweed Foundation and other leading professional groups. Jim's professional skills extended to reconstructive orthodontics and patents with ceramic braces, widely adopted in the profession. He was an authority and active writer and speaker on practice management. He also founded orthodontic supply companies Zulauf, Inc., ClassOne Orthodontics and Element 34 Technologies.

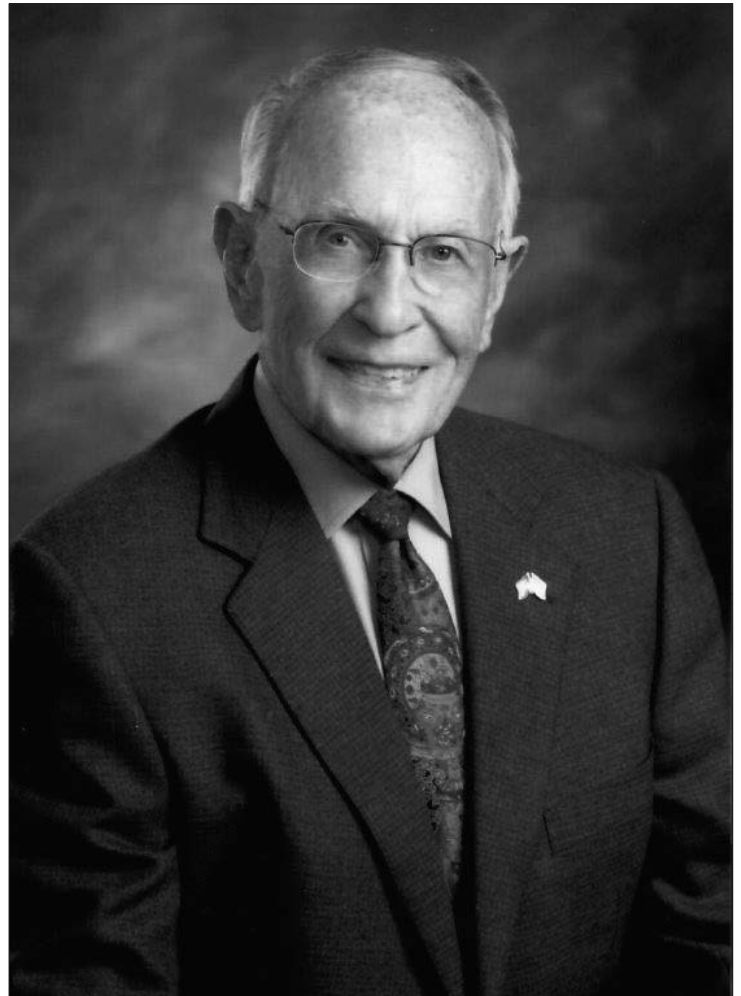
Jim was born in 1919 in Prairie Grove, Arkansas, the son of James Anderson Reynolds, a Methodist minister, and Lucy Wilborn Morris Reynolds, a teacher. He attended Hendrix College in Arkansas and graduated from Baylor College of Dentistry in 1944. During this period he met and married Elizabeth Keesling Eiffert, and served during WW II as a dentist in the Navy in California. He also served a similar role in the USAF in Amarillo during the Korean War.

Jim and Beth moved to Lubbock in 1945 where they became active in civic affairs. Among other roles, he served for 11 years on the Lubbock Independent School District Board of Education (three as president) and had a life-long affiliation with the First United Methodist Church, where he and Beth were church school teachers. Jim served as a scout master and maintained great respect for scouting. Jim and Beth were great hosts and made close friends wherever they travelled. He was active in Rotary International, leading a number of group study exchange programs, notably to London, a city that he and Beth loved and adopted as a second home over many years.

Jim was a committed sportsman with a love of skiing and tennis and was an avid fan of the Red Raiders. Jim and Beth remained in love for 67 years and his care and encouragement supported her following an untimely stroke until 2010, when she pre-deceased him. His later years were rejuvenated and enlightened by the affection and fun provided by Mrs Josie Sterling, a longtime friend. He was devoted to his children and passed his values and many enthusiasms on to them. He is survived by his

children: James Mikel, his wife Candi and children Ashley and Jonathan; Peter Rutledge, his wife Sandra and daughter Alex; Elizabeth Ann, her husband Tom Coleman and daughters Mary-Anna and Margaret; and Margaret Lea, her husband Bill Clark and children Matthew and Jane. He is also survived by 4 great grandchildren Max, Vivian, Cole and Elizabeth.

We seldom consider death as kind, but when it takes one so engaged and prolific, it seems unusually unkind even in the twilight of a splendid life. I first came to know Jim as an adolescent whose only dental experience heretofore had been the extraction of a tooth by a local dentist without benefit of anesthesia. I vowed never again to visit any dentist, but, of course, my mother had other ideas about that. She had heard good reports about a new dentist in Lubbock, TX, and I was soon sitting in Jim's treat-



ment chair. The experience was so pleasant and enjoyable that on the way home I told my mother, "When I grow up, I want to be like that man." I still aspire to that goal.

That was the beginning of a life-long friendship that has enriched my life since that first meeting. He was a personal never-seasonal North Star to whom all could turn for wise counsel, encouragement and knowledge, and he had the personality and generosity that could enlarge our victories and diminish our defeats. Jim could always bring a clarity and joy about dentistry and make one proud and anxious to participate in it to the fullest.

Jim literally transformed the esthetics of orthodontics with his invention of ceramic brackets and provided the profession with astute leadership as President of the American Association of Orthodontics. He recently submitted a paper to an orthodontic journal that will soon be published, which guaranteed that he would go out with a bang and not a whimper. His enduring and unselfish service made him an icon to his professional colleagues.

Of all his admirable traits, and there were many, his authenticity and fidelity to friends, family and colleagues had the biggest influence. His reliable and unpretentious personality made him a faithful and dependable source of support and sound advice, which continually nourished all who knew and depended on him.

In my own weak way, I have tried to capture what made Jim so special, but words can never capture the essence of what made Jim Reynolds so remarkable. Certainly his complete devotion to his wife, Beth, and the intense love for his family, his commitment to his patients, his generosity in service to his profession and fidelity to friends all collaborated to make him an extraordinary man whose friendship we cherished.

Jim was the pillar of fire before the camp, and now his family, friends and professional colleagues, chastened by the dimensions of the void that will replace him, stand bereaved and chilled in the dark - for awhile - but fully confident that his legacy of kindness, fidelity, high purpose and generosity will reignite our own personal commitments and enliven our service to others. ■
