## PRESIDENT'S MESSAGE FALL 2016

As the summer is winding down, I hope that all our members and their families had the time to enjoy the sunshine and the brightness that the summer months bring.

Our esteemed Edward H. Angle Society is growing thanks, to you, the members that are bringing new and younger practitioners as guest or candidates to the components. Many of our educators are members of the Angle Society and we are asking all of them to participate in the EHASO Advocacy program to spread the word to the residents about the " **best study club that they can belong to**". The residents are our future. We should encourage them to embrace and sustain the delivery of quality orthodontic treatment from the beginning of their professional careers.

The changes in practice modality and delivery of care demand that standards of care be implemented, for the protection of our patients. The 2016 AAO House of Delegates approved updates to the Practice Guidelines document and they are now available at [aaoinfo.org](http://aaoinfo.org). One of the major changes was in the adoption of initial records as a standard of care. The Angle Society of Orthodontists has always been in the forefront of advocating the need for gathering appropriate records. Both initial and final records for developing a treatment plan and assessing the outcome of orthodontic therapy should be encouraged. The American Board of Orthodontics also supports the need for quality orthodontic records. We all know that, if our profession is going to survive the pressures placed on it, by entities that do not value quality but quantity, we may cease to practice orthodontics as we have enjoyed it for all these years. Our Angle Orthodontist Journal is a highly regarded source for dissemination of scientific information around the world. The need for quality scientific research on which to base our knowledge and translate it into practice should be supported. This is necessary to dispel the inaccuracies presented by other publications not based on proper scientific evidence. Therefore, the support of our journal and the Heritage Campaign is now needed more than ever!!



The EHASO Board of Directors is delighted to announce that **Dr. Sheldon Peck** is the 2017 recipient of the highest American Board of Orthodontics Award, the Albert H. Ketcham Award. 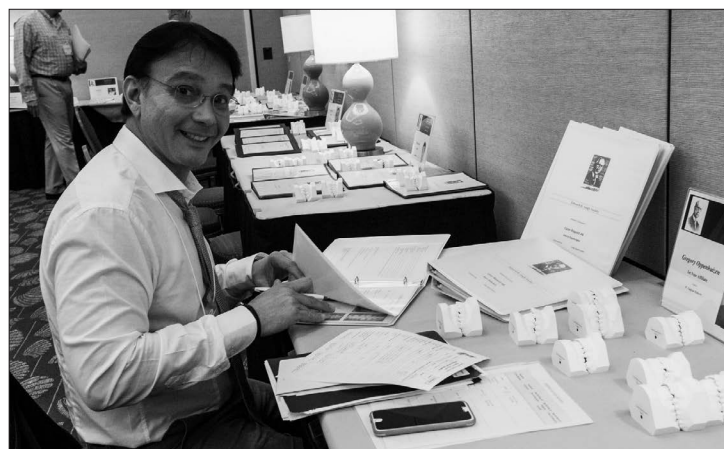

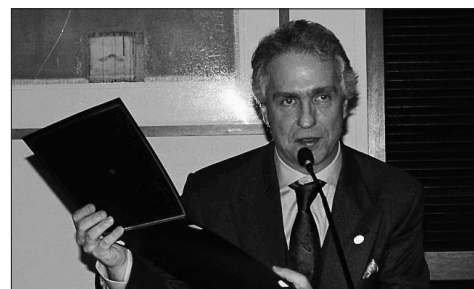
