## PRESIDENT'S MESSAGE

All of the members of EHASO, especially those in attendance of the 42<sup>nd</sup> Biennial, appreciate the hard work that the members of our Midwest component put forth to make their Biennial a truly fabulous meeting. The glamorous sophistication, history, diversity and excitement of Chicago provided a spectacular backdrop for the social programs and for spouses/guests enjoyment while members attended the scientific presentations in the classically grand Drake Hotel. Past president, Dr. Valmy Pangrazio-Kulbersh, along with meeting general chair, Dr. Ron Snyder and their committee made every effort to make this another memorable gathering of our Angle family and it certainly was just that. His knowledge and mastery of our history is truly amazing. It was particularly moving to witness the Honorees presentations. Drs. Paul Castelein, Andrew Haas, Baily Jacobson and Sheldon Rosenstein were each honored in individual and touching fashion for their lifetime of work and achievement in contributing to the Angle Society and the overall betterment of orthodontics.

The very first and three of the first six Angle Society Biennial meetings were held in Chicago where Mrs. Anna Hopkins Angle presided over five of the first six meetings and two of the three that were held in Chicago. It is fitting that Valmy, following in Mother Angle's footsteps, should lead our organization as the second woman to do so and finish her term in such a storied locale of great historical significance to our Angle Society. I cannot say enough

about Valmy's leadership. She and I first met at the 2007 Biennial in Quebec City, with both of us attending our first Biennial as our respective component representatives. Over these past years, she has been a true delight to work with and she really knows how to organize and get things done. She is a dynamo and one of those rare and talented people who could successfully run a major corporation. I only hope I can come close to filling her stilettos.

Angle Midwest has set a very high bar for Angle Northern California and the 43<sup>rd</sup> Biennial. From November 1<sup>st</sup> to November 5<sup>th</sup>, 2019 we will host the Biennial in beautiful Napa Valley. This will be a departure from the urban sophistication of Chicago as we experience the pastoral indulgences of Napa Valley life with its renowned setting, world class wines, fabulous cuisine and assorted recreational activities. We have just begun to formulate our plans and I will inform you of our progress in future messages. Our venue will be The Meritage Resort and Spa which is currently undergoing a one hundred million dollar expansion covering 9.3 acres which will be completed in 2018. They are adding 145 guest rooms and suites to the existing 322 and building a wine tasting "village", demonstration kitchen, boutique market, expansive artificial turf event lawn of 9,450 square feet with fireplaces and a water feature and an outdoor swimming pool. Please save those dates and plan to join in the fun, camaraderie and great scientific exchange that are the hallmarks of Angle Society Biennial gatherings.

Our journal editor, Dr. Steven Lindauer, gave a report to the Board of Directors at the Chicago meeting. With annual submissions hovering a little above 900 for the past five years and the Journal publishing 140-150 articles per year, the acceptance rate over the previous five years has ranged 10.4%-17.2%. Thus, only the very best papers make the cut. Much credit goes to Dr. Lindauer and the hard working Associate Editors, Assistant Editors and Editorial Board Members who all put in enormous amounts of time and effort to maintain the highest of standards. We will always be indebted to Editor-in-Chief Emeritus, Dr. Robert Isaacson, who served as Editor in Chief for many years and his wife

Delores and who took the journal to great heights by significantly improving the selection and presentation of articles. Bob also had the insight to provide all of the past, present and future editions of the journal online and free of charge to anyone who wished to review the many topics related to the science and art of orthodontics. What a fabulous contribution to orthodontic education this has provided! Last August alone, Google Analytics data showed the journal had 43,895 visits by 30,591 unique visitors. This is the Angle Society's gift to science and orthodontics and one of the key reasons for our existence. The Angle Heritage Campaign was launched at our 2005 Biennial meeting at Lake Tahoe to support the journal in anticipation of declining paid subscriptions. Inevitably, this is occurring and at some point in time the importance of the endowment will become critical. The original goal was to build the fund to \$2,000,000 in anticipation of an annual 5% return on investment to be used to subsidize the costs of the journal. Currently, we have pledges totaling \$1,640,000 and

have collected \$1,484,000. It should be understood that some pledges are in the form of estate commitments and will be fulfilled in the future. In light of today's interest rates, the original plan has proven to be unrealistic. Also, the original request was for each Angle member to donate the equivalent of one treatment case or \$5,000. If this were to actually happen, there would be more than enough funds to protect the future of the journal. The campaign is ongoing, the need is there and I encourage all of us to look for opportunities to add to it. One avenue is to think of occasions where those of us in active practice do not want to collect a fee for services from a friend, colleague or relative and instead ask for a potentially tax deductible contribution be made to the Heritage Campaign in our name. This can be a win-win-win situation for all involved.

Thank you for allowing me to be your president, 2017-2019 and I look forward to seeing you in Napa in 2019. ■

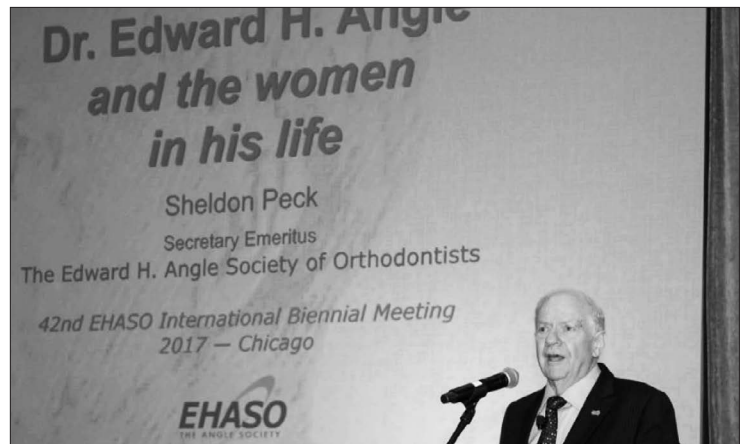

#### **Standing rules additions:**

1) The admission manual has been revised to amend our clinical requirements for full time faculty with no intra mural or extramural practice opportunity. The new guidelines follow the ABO requirements: full time faculty are allowed to present supervised cases for ABO certification.

2) With the large number of affiliates in our component the number of members on the study committee will be increased from 3 to 6 and the position of study secretary has been created to be appointed by the Board of Directors from that committee.

3) Due to rising meeting costs our component will continue to charge retired members and retired spouses the spouse fee for meeting attendance. This will be a year to year Board of Director's decision based upon the prior year's meeting budget.

#### **Bylaws Changes**

The Board of Directors recommended an amendment to the bylaws to state: The minimum time one must practice orthodontics to be considered for membership into the Midwest Component of the Angle Society is four years, which includes the time in the orthodontic residency.

Shepard's outstanding accomplishments and to show appreciation for his many contributions as first Executive Director of the ABO. Upon Wilma S. Shepard's death in 1989, the award name was changed to include Mrs. Shepard inasmuch as she was so integrated in her husband's many efforts toward fulfilling the goals of the Board. This award recognizes an individual for outstanding dedication and advancement of the ideals and mission of The American Board of Orthodontics. Nominations for this award are submitted by the ABO Directors.

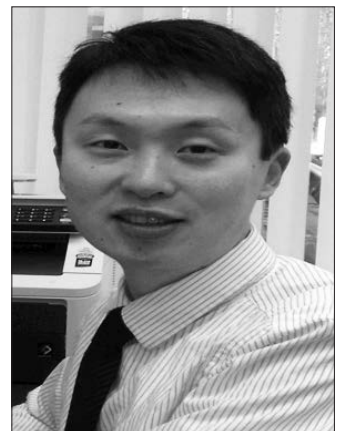

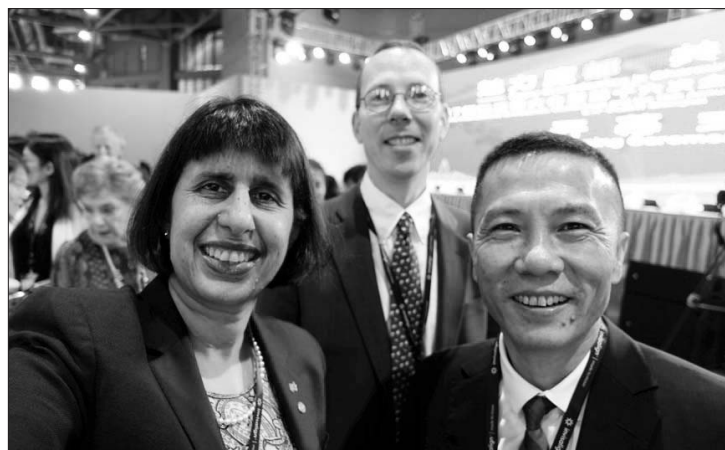

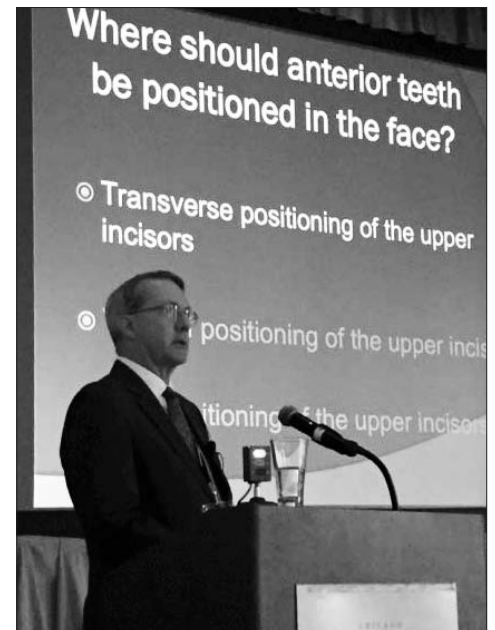

Following the breakfast presentation by Dr Bolin, we are fortunate to be able to listen to a presentation by Dr James Mah entitled "Insights into Chronic Bruxism and Management". 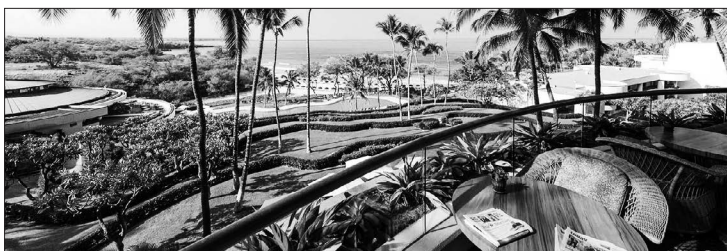

### Meeting News

The May 5, 2017, meeting was held at the Claremont Country Club in Oakland, California. The day was filled with a number

of interesting presentations by both affiliates and guests. Residents from both UOP and UCSF were in attendance along with a number of guests invited by our members. Dr. Marta Baird presented her case report as a requirement to become an affiliate member. Dr. Baird attended UOP for dental school and her orthodontic residency and is a Diplomate of the American Board of Orthodontics. She presented a well-treated case with excellent records. Rebecca Keller served as discussor for her case. Dr. Toshihito Sato presented his thesis "Bracket Repositioning Without Debonding Using an Ultrasonic Scaler: an in vitro study" as part of his Angle membership requirements. Dr. Sato received his dental school, orthodontic specialty certificate, and his PHD from the Tokyo Medical and Dental University. He also completed Board certification for the Japanese Orthodontic Specialty. Dr. Sato's lecture generated a great deal of interest from the members and residents. His study utilized a piezoelectric ultrasonic scaler to heat the base of the bracket and adjacent adhesive to a softened state followed by repositioning of the bracket and cooling of the adhesive. The study included measurements of the heating time, repositioning time as well the heat generated at the bracket, enamel surface and the pulp canal of bovine teeth.

The morning was complete with a lecture by Dr. Benjamin Pliska. "Sleep Disordered Breathing in the Growing Patient: The Orthodontics Perspective. Dr. Pliska is a full time Assistant Professor at the University of British Columbia and an affiliate member of

the Northwest Component of EHASO. His presentation reviewed the pathophysiology of obstructive sleep apnea in children as well as some differences in OSA in children and adults. He dispelled some of the myths and assumptions regarding diagnosis and treatment of OSA in children. This is certainly an area of interest for all orthodontists and his ongoing research in OSA was well received.

Our lunchtime program included a short presentation by Karen Segovia the territory manager for Propel Orthodontics. A number of our members also presented "Orthodontic Pearls" during lunch as is our custom.

The afternoon began with a presentation by Sunil Kapila, Professor and Eugene E. West Endowed Chair of Orthodontics, UCSF. "The Myths and Realities of Expedited Orthodontic Treatment." Dr. Kapila's lecture was an extensive review of expedited tooth movement from the 1890's to the present. Members received clarification on the merits of appliances and claims of faster tooth movement as well as alternative methods using surgically facilitated techniques and devices designed to increase the velocity of tooth movement. He is a Diplomate of the American Board of Orthodontics and has received the Excellence in Academic Teaching Award.
