PRESIDENT'S MESSAGE

Remembering

In last fall's Angle Newsletter we paid homage to Dr. Robert Isaacson's passing and his incredible contributions to our profession, specialty and Angle Society. In this issue, two additional stellar Angle Society members are who have recently passed are

recognized. The orthodontic world felt a deep loss with the sudden death of Dr. William Proffit at the age of 82 on September, 30, 2018. He was a prolific researcher and orthodontic educator who taught generations of orthodontists and was still actively involved in lecturing at the University of North Carolina at Chapel Hill orthodontic residency program and worldwide at the time of his death. Having served as chairman of the UNC School of Dentistry orthodontic department for 26 years, he continued with service as an adjunct falculty member. He was the coauthor with Dr. Henry Fields Jr. of the widely used orthodontic text book Contemporary Orthodontics which has been published in 12 languages and recently completed its

sixth printing. Additionally, he published more than 200 scientific articles and book chapters. An alumnus of the UNC orthodontic residency program, Dr. Brent Larson, the current president of the AAO, knew Dr. Proffit well. "Dr. Proffit was my teacher, my mentor and friend. He had a passion for the science of orthodontics which continues to motivate me every day and I know there are thousands of orthodontists around the world who feel the same way."

Recently, we learned of the passing of Dr. Leena Peck. Dr. Leena Kataja Peck was 73 when she died on January 13, 2019 in Helsinki, Finland, the country of her birth and where she first studied dentistry. Her husband, Angle Society Secretary Emeritus and past Historian, Dr. Sheldon Peck, described her as the consummate teacher even though her work involved treating patients, research, teaching dental students and service to professional organizations. "Her patience, diligence and knowledge-based ability to teach students concepts and methods were without peer," he has said. Early on, according to Sheldon, she "was a little shocked" at the barriers that women in dentistry faced and by how men in the program treated their female colleagues.

However, she did not let that bother her and immediately commanded the respect of her male constituencies on the professional and academic levels and opened doors for other women. For more than 20 years she was a lecturer and assistant clinical professor in orthodontics and developmental biology at the Harvard School of Dental Medicine. Additionally, she was a pioneering

woman not only in dental education, but also in the Angle Society by becoming the first woman to be elected president of a component - Angle East, in 2003. Elected to membership in 1990, she was the co-recipient three years later of the Edward H. Angle Research Prize for excellence in published orthodontic research.

We are grateful for the contributions and friendship of these two brilliant, dynamic and gifted members who in their own individual ways have made both our orthodontic specialty and our Angle Society better. They will be remembered in our hearts forever.





tations to the component, as well as three residents from the orthodontic residency program of the University of Toronto.



LEENA PECK 1945-2019— A BRIEF CELEBRATION OF A WONDERFUL LIFE

Leena Peck was born in Finland in 1945 and died peacefully in Finland on January 13, 2019.

From her early days Leena was destined to be a high achiever:

- Skipped 2 primary school grades
- Advised by Dr. Koski of Turku, Finland to study orthodontics at U of Minnesota chaired by Dr. Robert Isaacson—after receiving her MSD degree in '76 Leena returned to Finland and engaged in research and teaching at the U of Helsinki.
- Sheldon and Leena met in 1973 at an international orthodontic meeting, and again, serendipitously, in 1985. Six months later Leena and Sheldon were married in Boston.

"By 1993, Leena had a full and vibrant life: mother of two young children, Mark and Anya; partner in the Peck and Peck practice in Boston and Newton, Mass.; educator as an assistant clinical professor of ortho at Harvard. Despite these commitments, s continued her annual work with her Helsinki colleagues to collect clinical records and data for the legendary U of Helsinki longitudinal child growth study.

Leena was author or co-author of 40 peer reviewed research articles.

She was a member of many professional organizations in both USA and Finland. She was most proud and committed to EHASO. In 2003 she became the first woman to be elected president of Angle East in the 73 history of that EHASO component."



In summary, Dr. Leena Peck led an exemplary and vivacious life, tragically cut short by an incurable illness. She was a beautiful person in every sense of the word. She was loved by all who were lucky enough to know her – family, friends, colleagues, students, patients – and she loved each back. Leena contributed to society and humanity in so many special and extraordinary ways. Her family, friends and Angle East members miss her deeply and shall remember her dearly."





The first morning's speakers, were the winners from our 3-day in 2018, presenting their winning cases, diagnosis, treatment and results via powerpoint. The afternoon was free for an organized group activity: ziplining.

The 2nd morning Dr Will Andrews presented: *Incisor positions* that contribute to health, function and appearance. Dr Andrews emphasized that diagnostic priority should be placed on the positions of the incisors rather than the molars. This concept is believed to be universally applicable regardless of age, gender or ethnicity.

Dr Sinan Hamadeh discussed: Maxillary molar distalizaton with the Topjet appliance: a skeletal anchorage device. The Top-

jet is a non-sliding device utilizing palatal implants and can be placed chairside in one appointment.

Dr Min-Ho-Jung presented: Unusual extraction—What should we consider. This paper discussed what should be considered when teeth other than those used for extraction are missing or lost. How can this unusual space be used for patient's benefit.

There were 2 activities in the afternoon: golf at a local course or a visit to National Tropical Botanical Garden.

The last morning, Dr. Ryuzo Fukawa presented: Innovative challenge for the various types of malocclusion with lingual orthodontics. Dr Fukawa discussed the characteristics, treatment planning and finishing with lingual orthodontics and demonstrated via the use of CBCT, TADs and skeletal maxillary expansion.

Dr Sivabalan Vasudavan presented, Implant anchorage and CAD-CAM technology: a match made in heaven. Dr Vasu-



davan explored contemporary treatment strategies involving skeletal anchorage using mini-implants and skeletal fixation incorporating digital technologies, i.e. 3D digital casts, bracket set-ups, aligners and customized arch wires.

Our final speaker, Dr John Pham presented: A paradigm shift in aesthetic orthodontic treatment. Dr Pham, discussed

his continuing research at USC, collaborating with the Viterbi School of Engineering, to develop a novel invisible lingual orthodontic system: INBRACE, of which he serves as CEO. Dr Pham introduced a viable fixed system that gives an alternative method of treatment in the face of removable aligners in a challenging orthodontic landscape.

There was another group activity for the afternoon: backcountry tubing or just relaxing on the beach. ■

MEMBER PORTRAIT:

Norman Wahl, DDS, MS, MA by Dr. Richard Mays, Historian

Dr. Wahl is an honorary member of the Edward H. Angle Society, awarded to him at the 1999 Sun River, Oregon Biennial Meeting. He has written four books and numerous papers on dentistry, which has been mostly orthodontics. Dr. Tom M. Graber called him an 'eminent historian.'

From his earliest years in Chicago, through high school, West Point, film school at the University of Southern Califor-

nia, the University of Illinois College of Dentistry, the Northwestern University orthodontic program to obtaining a Master of Arts in History with distinction from California State University Northridge, Dr. Wahl has excelled in all of the academic pursuits that he has undertaken.

Norm was born in Chicago and raised by his mother, step-father and grandparents. These were difficult times during the depths of the U.S. Great Depression. A sister, Tamara was born when Norm was 7 $\frac{1}{2}$ years old. His religious grandfather, who was from the 'Old Country', was very proud when Norm underwent the bar mitzvah ceremony at age 13.

Norm entered Lake View High School and immediately joined the ROTC. Little did he know that this would be the beginning of an on-again-off-again love affair with the military for 35 year's. He excelled academically achieving the Gold Honor Society and graduating in 1942 he enrolled at the University of Illinois as an electrical engineering major. He pledged the Phi Epsilon Pi Fraternity and was also a member of the ROTC.

Norman's stepfather had always wanted Norm to follow a military career and through his political connections, got Norm an appointment to West Point. Norm knew it would be a tough go, but he also saw it as an opportunity to make up for his lack of 'machismo' he had thus far exhibited. Plus there was a war on, so after passing the qualifying exams, Norm reported to the U.S. Military Academy on July 1, 1943 prepared to start at the bottom of the totem pole all over again.

Not exactly a 'Stormin Norman' Norm was nevertheless determined not to disgrace his family by being washed out. He managed to tolerate the verbal assaults, subjugation, apprehension and stress by gradating in the upper 20% of his class. Playing the bass for 2 years in the Cadet Dance Band gave him one of the few opportunities to relax. He was the number one student in Portuguese and in English he discovered his talent for writing, relying

heavily on his U. of I. experiences in the fraternity, although his professor told him that he was in 'a Greek-letter rut.'

He graduated in 1946 as a U.S. Army 2nd Lieutenant, along with such soon-to-be illustrious classmates as the future governor of Missouri, president of Holiday Inns, chancellor of the University of Pittsburgh and president of Nicaragua. Football Hall-of-Famer Glenn Davis was a classmate but was turned back a year on academics. The other half of the 'Touchdown Twins,' Doc Blanchard (both were Heisman Trophy awardees) was in the Class of '47. It was a great time for the undefeated Army football team.

After graduation, Norm's first assignment was bakery officer at Fort Richardson, Alaska where he was responsible for turning out 4,000 loaves of bread every day with the assist of some good sergeants. After hours Norm got involved in Soldier Shows. It was here that he decided to try his luck in Hollywood after serving his obligatory 3 years in the service.

Soon after discharge in 1949, he entered the USC School of Cinema, restless to start knocking on Hollywood studio doors. In November 1950, he began working for the studios and going to school at night. As he continued this routine, he also produced a documentary film of Los Angeles titled **The Story of a Pueblo**, which consisted of then-and-now shots of historic sites. In addition to print sales, Norm received \$50. to run it on KTTV. This was an exciting time in Norm's life, having met such celebrities as Mario Lanza, Charlton Heston, Frank Sinatra and Lauren Bacall. But after much soul-searching, he realized that he really belonged in a more stable line of work, such as health care and dentistry began to look more attractive.

So it was back to square one, as the future Dr. Wahl switched his major at USC to predental. He was accepted at the University of Illinois School of Dentistry at Chicago to enter in 1955 as the oldest member of the Class of 1959. At this point in time, it seemed as though Norm would never settle down and his family began calling him a perpetual student.

While in dental school, Norm had a friend that was an orthodontic student who pointed out the advantages of ortho over general dentistry.

Consequently, by the end of his dental school training, Norm had been accepted by the Northwestern University Orthodontic Department and by a lovely woman named Marie. Fortunately, his bride Marie was new to the 'waiting game' that his family had endured all these years and so was willing to work as an R.N. to help achieve his goal of graduating with an M.S. in Orthodontics in 1962.

Despite his receiving an M.S. in Orthodontics, Norm never got the movie bug out of his system, so 30 years after **The Story of a Pueblo**, he did the same documentary in color with actor Tom Bosley as the narrator (they were distant cousins). The colored and narrated film was renamed **Secrets of the City** and it received honorable mention at the 1983 American Film Festival and can be viewed on You Tube.

After living in Southern California for 5 years, Norm had no difficulty deciding on a practice location, nor any trouble persuading his wife, Marie. After all, they met in San Francisco while Norm was seeking a patient for his California Dental Board Exam. Not being the competitive sort, Norm selected an area

thus far (1963) lacking an orthodontist: Thousand Oaks. That luxury expired 2 years later when another orthodontist established his practice there. Then, two more came in 1967, one of which was yours truly. Initially competitors, Norm and I have been friends for more than half a century.

The mid-sixties were a turbulent time in Norm's life. Not long after he opened his office in Thousand Oaks, he and Marie were blessed with the arrival of a son, Michael in August 1963. In May 1967 she suddenly passed away leaving a 3 year and 6-monthsold boy in Norm's care. It was painful for Norm to hear his son ask for 'another mommy.' But the 1960's story had a happy ending when in May 1969 he married Betty. It was inevitable that the two should meet as she and Norm lived in the same apartment complex and Betty was the office manager for a medical group across the hall from Norm's office and finally because he was a patient at that office. At age 5 years and 6-months-old Michael got a new mommy. A few years later (1978) Betty persuaded Norm to join a bicycle group that toured from Great Britain to Austria. In 1989, they took another important trip to Provo, Utah where they saw Michael wedded to a lovely redheaded BYU classmate, Keri who eventually bore Norm and Betty five grandchildren.

Instead of spending his spare time promoting his practice Norm took to writing. In 1972, Norm's first article to appear in a dental journal, **Dental Photography – Some New Benefits** was published in *The Journal of Clinical Orthodontics*. In 1988 Dr. David Turpin then editor of the *Pacific Coast Society of Orthodontists Bulletin*, published Norm's **The Last Graduate** about Dr. Matt Lasher. Norm's classic article entitled, **A Little House in Pasadena** was published in 1989 in the *Angle Orthodontist*. This article tells how in 1922 Dr. Angle's former students raised sufficient money and hired a well-known Pasadena builder to erect a 'little house' that served as Dr. Angles school and which still stands at 550 Jackson Street adjacent to Dr. Angles residence.

From 2005–2008, Norm wrote a 16-chapter work that Dr. Dave Turpin published serially every other month in the American Journal of Orthodontics and Dentofacial Orthopedics. The work was entitled **Orthodontics in 3 Millennia** reviewing the history of orthodontics from antiquity to the modern era. It seemed that

wherever Norm submitted a manuscript there was Dr. Dave Turpin seated in the editor's chair.

In September of 2017 Norm published in book entitled: **The Golden Age of Orthodontics: Decline and Aftermath**. This material was from his Masters thesis for an MA in History from California State University at Northridge, which he was awarded in 1993. This book gives the reader a carefully researched history of the business of orthodontics in the 19th, 20th and 21st centuries. In the latter part of the book, he discuses the increasingly complex problems practicing orthodontists face managing a successful practice today. Dr. James Vaden, prominent orthodontist and former chairman, Department of Orthodontics at the University of Tennessee stated "This book will be an invaluable resource for anyone who is currently establishing a practice or becoming an associate in a practice. I highly recommend the book for young and old alike."

As the 20th Century drew to a close, Norm and Betty decided to retire and move to Sequim, Washington. They bought a small house on the Straight of Juan de Fuca, across the bay from Victoria, Canada. Continuing to exercise regularly, Norm loved the mild climate and remoteness of Sequim and the opportunities to swim, bicycle and work out at the local gym. Betty had introduced Norm to hiking, backpacking in the Sierras, skiing and bicycling but ironically she had to give up these activities because of worsening infirmities. Her health continued to decline and she passed away in 2018. She had been Norm's sweetheart, companion and helpmate for 49 years and mother to Michael since age 5 years and 6-months-old. Norm now lives with Michael and Keri in Provo, Utah.

The author of this brief profile of Norm's amazing and many-faceted career has known him since 1967 and has been a witness as a fellow orthodontic practitioner in Thousand Oaks, CA and considers him a very dear friend. How does one sum up the life of a man who jumped from West Point officer to documentary filmmaker to orthodontist to historian with excursions into writing and editing? Ask Norm and he'd probably say "Unstable." I'd rather say that orthodontics gave him a living, but writing gave him a life!

Dr. Peter Buschang will be recognized at the 20109 AAO Annual Session with the "Lifetime Achievement Award in Orthodontic Research" award.

An anthropologist with a PhD degree, Dr. Buschang is Regents Professor and director of orthodontic research at Texas A&M Uni-

versity Baylor College of Dentistry. A faculty member at Baylor since 1988, he has guided hundreds of student research projects, the majority of which have been published in refereed journals. Dr. Buschang has published over 300 peer-reviewed articles, numerous book chapters, and several books, with his achievements having garnered honorary memberships in both the AAO and the Edward H. Angle Society. His earlier research focused on craniofacial growth, the evaluation of treatment effects, and motor-oral function, while his more recent research addresses the effects of distraction osteogenesis, especially dentoalveolar distraction.

In addition to receiving the Research Award during Annual Session, Dr. Buschang will present the 2019 Angle Lecture, "30 Years of Achievements – Our Proudest Moments."
