President's Message Fall 2019

At the time I wrote this message, I was still serving as president. However, by the time this Newsletter reaches our membership, I will have passed the president's baton to Dr. Peter Greco. For the spring of 2019 issue and what I believed at the time was the last President's Message I would pen, I closed with a quote from Dr. George Hahn's paper - "The History and Philosophy of the Edward

H. Angle Society of Orthodontia" which he gave at the Twenty-Fifth Anniversary Meeting of the Edward H. Angle Society of Orthodontia held in Chicago in 1955. This is a milestone paper and every member or aspiring member of our esteemed Angle Society would benefit from reading it and occasionally revisiting it for an inspirational recharge. One has to ask, why is there an Angle Society? Is the Angle Society still relevant in today's world? I had a dental school GP classmate of mine recently express surprise the Angle Society was still in existence. I became an Affiliate member in 1989 and at that time, I recall our President, Dr. Lee Boese, reporting on the 1989 Angle Biennial Meeting that was held at the Drake Hotel, in Chicago and the serious con-

cern at the time for the relevance and future of the Angle Society. At the 2013 Biennial Meeting in Vancouver, BC a committee was convened to discuss the problem of membership recruitment and how we might generate interest in joining among the new generation of orthodontists. And once again, I go back to Dr. Hahn's paper and quote -"If we are to emulate the ideals of Angle we must remain a working society. He (Dr. Angle) had no time for sloths." This Society is not for everyone. It is as our Secretary Emeritus

Dr. Sheldon Peck has stated - "a select and elect" organization. We can all be proud of the success and stability of the Angle Society. We have the membership numbers to sustain us and we are financially in incredibly good standing. Happily, as I reported in the fall 2018 Newsletter, we are in a position for our Angle Society to grant each hosting component \$20,000 to use for their Biennial. We have committed to one round and will reassess after that. In times past, the Central Body would Ioan \$10,000 and expect repayment of the majority of the funds. I believe we are as strong and stable as ever and that we have a great future. I will close with an excerpt from Dr. Hahn's paper. However, please keep in mind this was 1955 and the writing, in character to that era, was gender biased.

"What is the glue, the cementing substance, the bond that brings and holds the members of the society together? Several months ago I wrote twelve members of this society and asked them two questions. First, why should there be an Angle Society? Second, what does the Angle Society mean to you? These men were selected from among our oldest as well as from our youngest

> members, from the East and from the West. I wish I could read their letters, but I promised them that their replies would not be made public. Some of them could not express their feelings in words. It was akin to asking a man what faith in God meant to him. I will try to give you a composite interpretation of the replies. "The Angle Society should continue to live because it means there is an ideal over and above the average that is worth living and striving to attain. There is in the society a fellowship, not as the word is commonly used, but a fellowship in which there is no selfishness, no jealousy, no deceit, but an honesty of purpose in which every man is held in that esteem which gives him a feeling of pride tempered by humility. It of-

fers an opportunity for the full and open exchange of knowledge and ideas eagerly offered with nothing held back. It takes one out of the realm and routine of mediocrity which is so common today and into a standard of conduct which makes living and working a pleasure. There is an inspiration that comes from personal contact with men whose object is not self-glorification but a willingness to give freely of what they have learned with only the thought of helping others. It is the maintenance of the ideal of perfection which in our profession originated with Angle and which is rapidly disappearing in the philosophy of present day living and thinking. In the Angle Society there is a feeling of pride in the accomplishments of, or the honors bestowed on a fellow member which creates in each of us a desire to become better orthodontists ourselves."

These words ring as true today as they did almost 65 years ago. It is a testament to its relevance that the Angle Society has survived nearly 90 years and is today as strong as ever.

Thank you for allowing me the opportunity to serve as your President. ■

Dr. Hahn graduated from the Angle School in Pasadena in 1922 and along with Drs George Atkinson and Cecil Steiner he became mainstays of Angle's teaching staff. In 1925, he joined the faculty of the University of California and taught orthodontics for the rest of his career. He was a charter member of the 1930 rebirth and reorganization of the Edward H. Angle Society of Orthodontia. He became treasurer of the society in 1938 until 1953 when he became Secretary.







Mike Chaffee has been working hard to put together another excellent program. This year's meeting includes membership presentations by three of our Affiliates: **Dr. Howard Freedman, Dr. Reid Winkler and Dr. Ben Pliska. Dr. Keiji Moriyama,** Professor and Chair, Maxillofacial Orthognathics, Tokyo Medical and Dental University, will be presenting "Dental equilibrium revisited: Soft tissue considerations in treatment of dentoskeletal discrepancies" as he transfers his membership to our component. We are looking forward to welcoming each of them as Regular Members.



Our special presenter will be Dr. Hyo-Sang Park, coming to talk to us from Daegu, South Korea, where he serves as Clinical Professor and Chair at Kyung-Pook National University. Dr. Park is a pioneer in skeletal anchorage, beginning microimplant development and research in 1998. He has published more than a hundred articles on the subject, as well as six text books. He serves as a reviewer for the AJODO, the Angle Ortho-

dontist, European Journal of Orthodontics, Orthodontics and Craniofacial Research, and the Korean Journal of Orthodontics. Dr. Park will present "Ensuring maximum profile changes in extraction cases treated with microimplants", emphasizing how to maximize profile improvement in hyperdivergent patients, focusing on the soft tissue dimension on facial esthetic improvement, using microimplants for vertical control.

Dr. Park will also present "Non-extraction treatment with molar distalization using microimplants". The distalization of molars in non-extraction treatment can reduce the extraction of premolars in borderline cases. However, there are many things to be considered in diagnosis, treatment planning, and biomechanics for successful treatment. In addition, he will discuss microimplant anchorage with sliding mechanics and possible biologic limits.


Seuss Kassisieh was recently appointed by the College of Diplomates of the American Board of Orthodontics as the Co-chair of the Resident Advocacy program in North America. The committee ensures that each graduate orthodontic residency program in the United States and Canada has an ABO Diplomate who advocates to residents to become board certified. He has served this committee for several years as an advocate at the Graduate Orthodontic Department at the Arizona School of Dentistry and Oral Health (A.S.D.O.H. a.k.a. A.T. Still University in the Phoenix area). Seuss has been a part-time clinical professor in the graduate program and an Advocate for ABO, and the Angle Society, since the departments' inception in 2008.
