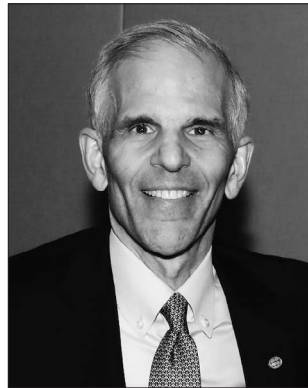
PRESIDENT'S ADDRESS

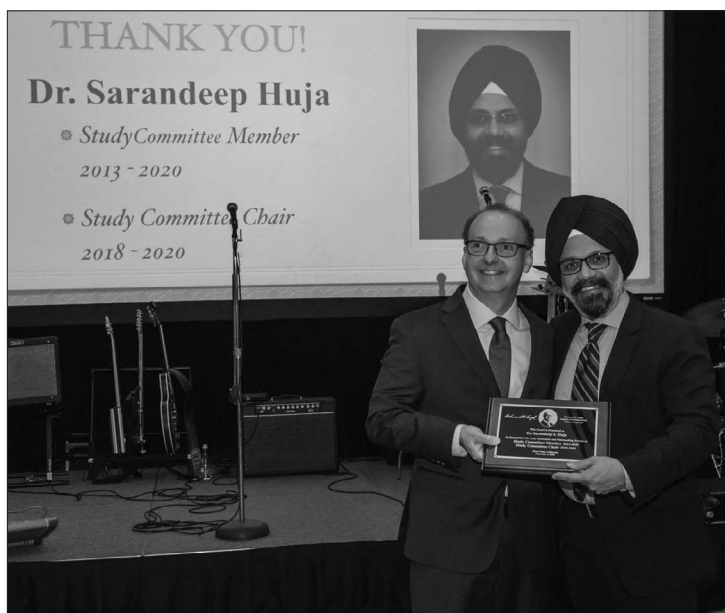

Greetings from your Editor! I hope this newsletter finds you and your loved ones safe and well!

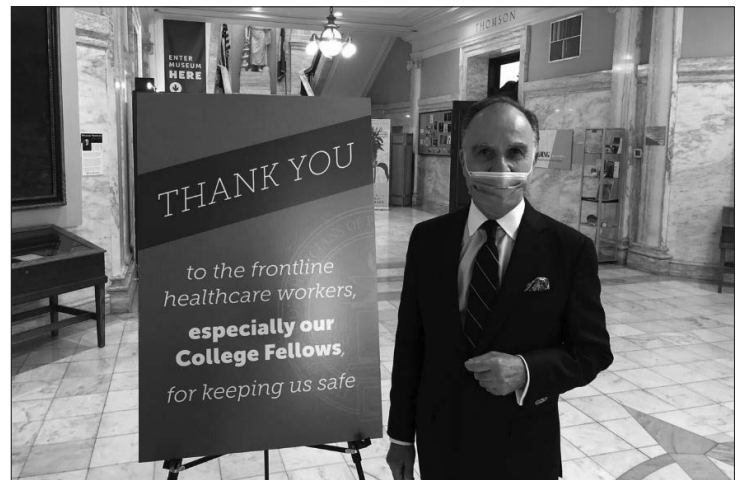

The 9th IOC was the largest-scale international orthodontic congress ever held, with a line-up of 130 world-renowned speakers, including several Angle North Atlantic Component Members. North Atlantic speakers included Ravi Nanda, Martyn Coburne, Steven Lindauer, Junji Sugawara, Scott Conley, Mithran Goonewardene, M. Ali Darendeliler, Letizia Perillo, and Stella Chaushu. Many other members of the Edward H. Angle Society participated in this virtual congress. Ravi Nanda received Honorary Membership in the World Federation of Orthodontics on October 4, 2020. Every

five years, the WFO confers this honor on only one or two individuals who receive it after nominations from all over the world.

Orhan Tuncay, Fellow of the Philadelphia College of Physicians, opened an exhibit called "Spit Spreads Death" in April at the College. The Philadelphia College of Physicians is the oldest medical college in the country. It goes back to the era of Benjamin Rush 1787, who was a fellow.



Bruce Haskell presented a series of five 2 hour virtual lectures on various orthodontic subjects from "Airway Management" to "Bracket Prescription Selection for the Practice...Pros and Cons" at the Stony Brook University of New York. Angle Net Launched

As we entered a new era with the COVID-19 pandemic at the beginning of this year, Angle East and the Angle Society of Europe ASE started a new initiative to support the worldwide orthodontic programs entitled **Angle Net**. During the lockdown period between March 30 and May 21, world-class speakers and moderators of both societies shared their knowledge and expertise with more than three hundred orthodontic programs and with the members of our societies on the ZOOM platform. The program was not only highly appreciated by the postgraduate community and associated faculty, but it has also boosted the collaboration between ASE and Angle East during these globally challenging times. We would like to take the opportunity to thank all of you for having either presented, moderated or watched the first webinars series and for all the enthusiastic and appreciate comments which have confirmed the success of this first ever ASE-Angle East joint venture initiated by Renato Cocconi, Giuliano Maino, Thor Henrikson, Karin Becktor, Peter Greco, Sercan Akyalcin, and Ute Schneider-Moser during the lockdown.

Continuation of the webinars on specific topics was highly requested by the audience, and the ASE and the Angle East Planning Committees have worked diligently over the summer to prepare a new, diverse, and robust program. We have agreed to engage more and more speakers from both our national body and ASE to contribute to our effort. For Season II we have extended our invitation to all components of the EHASO which have readily embraced our project.

The primary purpose of the **Angle Net** webinars is to provide attendees with clinical information that enables strategic thinking and compliments their diagnostic and therapeutic skills. What differentiates the **Angle Net** from the plethora of urbi-et-orbi webinars is the coupling of sound evidence-based knowledge with consistent excellent therapeutic results as the epitome of the Angle Society.

Today's orthodontic residents are the future of our profession. Unfortunately, their training experience was adversely affected by the pandemic. Hence, we consider serving the postgraduate community with our **Angle Net** a top priority which evidences the true spirit of the Angle Society: a commitment to lifelong learning and reciprocal sharing of experience. Furthermore, our joint endeavors will create a great pool of passionate new candidates for our society among the new orthodontic generation.

The format is either a 60 minute-lecture, a tandem 30 minute-duet lecture, or a presentation of clinical cases, followed by a 30 minute-discussion (Q&A) to keep the program varied and stimulating. The webinars will be recorded and broadcasted on-demand for the registered postgraduates and faculty, and for all Angle

members who will not be able to attend the LIVE session due to existing time differences. When the next webinar is hosted, the previous session will be deleted.

The course is free for all Angle Society members and the registered residents and faculty of the postgraduate orthodontic programs. It is our hope to keep the series as a non-commercial initiative. Therefore, the voluntary support of our speakers and moderators is greatly appreciated.

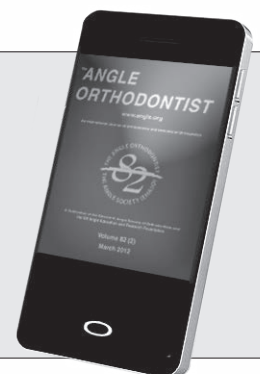

The Covid-19 Pandemic took its toll on Angle Southern California's ability to meet for our annual SPRING 3-DAY SCIENTIFIC MEETING, which was slated for March 13-15, 2020 at the Hilton Los Angeles / Universal Studios. Our format for the Friday session of each annual Spring 3-Day Scientific Meeting is that for membership in Angle Southern California, each of our Regular and Affiliate members must bring two ABO style cases to be displayed for viewing and shared learning. 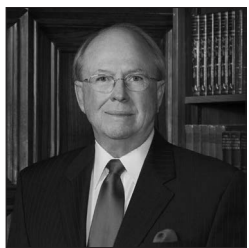

New Orthodontic Clinic named in honor of Dr. Phillip M. Campbell

The Texas A&M College of Dentistry (formerly Baylor University College of Dentistry) officially opened a new clinical building on January 23, 2020 in Dallas, Texas. The new nine story clinical education building is a separate structure devoted solely to the clinical sciences. The beautiful new 24 chair orthodontic clinic was named for former Chair, Dr. Phillip M. Campbell, Professor Emeritus. The official dedication of the orthodontic clinic was scheduled for April 3, 2020 but due to the COVID-19 pandemic has been postponed to a later date.



Dr. Campbell is Professor Emeritus of Orthodontics at Texas A&M University College of Dentistry. He received his undergraduate education at the University of Texas at Austin (BA) and Southwest Texas State College at San Marcos (MA). He then received his DDS and MSD in Orthodontics from Baylor University College of Dentistry in Dallas. He was in private practice of Orthodontics for 32 years in Huntsville, Livingston, Madisonville and Crockett, Texas as well as Anchorage, Wasilla and Dillingham, Alaska. He served the Department of Orthodontics as Clinic Director from 2005 until 2010 when he became Chair. He was honored by being named as holder of the Robert E. Gaylord Endowed Chair in Orthodontics in 2006, and granted Emeritus status in 2017.

Dr. Campbell serves as an Associate Editor of *The Angle Orthodontist* and on the Editorial Board of the *Texas Den-*

tal Journal. He has served as Treasurer and member of the board of the Edward H. Angle Education and Research Foundation since 1995 and was recognized as the winner of the Angle Research Prize in the same year. He served as a member of the Board of Directors of the College of Dentistry until the merger with Texas A&M University in 1995 and then served a 9 year term on the Board of Directors of the Baylor Oral Health Foundation.

Dr. Campbell was the Founder of the Robert E. Gaylord Endowed Chair in Orthodontics, the Tom Matthews Lectureship in Orthodontics and the Peter H. Buschang Endowed Professorship for Orthodontic Research. He was elected to membership in the College of Dentistry Hall of Fame and as a Distinguished Alumnus of both the College of Dentistry and the Department of Orthodontics. He received the Martin Dewey Memorial Award which is the highest award presented annually by the Southwestern Society of Orthodontists in 2014 and the Dale B. Wade Award of Excellence in Orthodontics in 2016. The Dale B. Wade Award is given to an exemplary senior clinician and board-certified orthodontist who demonstrates exceptional dedication to orthodontics through clinical excellence and/or devoted teaching in the image of Dr. Dale B. Wade, a past president of the ABO.

Case Series Report in the JCO

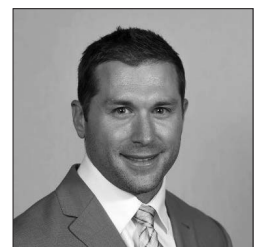
Angle Southwest member Dr. Seuss Kasssieh from Scottsdale, Arizona, has been working on a case series report with two co-authors, Dr. Natasha Bodioga from Portland, Oregon, and Dr. Jay Gousman from Mesa, Arizona. The report is titled "Management of Congenitally Missing Lower Second Premolars via Space Closure Using Temporary Anchorage Devices: A Case Series." It showcases five patients with congenitally absent mandibular second premolars treated with placement of TADs following extraction of retained deciduous second molars. The article discusses how the spaces are closed using contemporary orthodontic biomechanics, resulting in optimal health, function, and esthetics for the patients—without the need of prosthetic dental procedures following orthodontic therapy. The manuscript was accepted for publication in the *Journal of Clinical Orthodontics*, Spring 2021 Issue. The abstract and e-Poster were also accepted for presentation at the 9th International Orthodontic Congress, held virtually on October 4th-6th. ■

ARTHUR A. DUGONI

My father, Dr. Arthur A. Dugoni, Dean Emeritus of the University of the Pacific Dugoni School of Dentistry in San Francisco, died on September 23, 2020 in his home in Palo Alto.

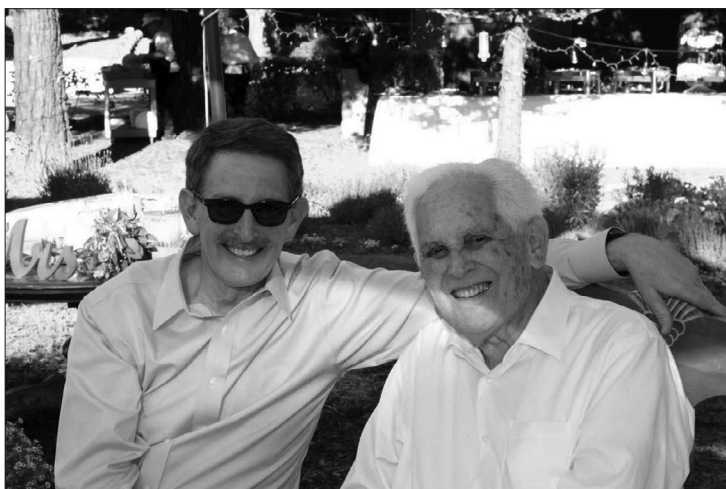
My father served the dental profession and his community with unparalleled impact in modern dental history. He was truly a giant in our midst and was revered by everyone who had the privilege of meeting him. Universally, he was acclaimed for his ability to inspire others to greater achievement and served as a preeminent role model for numerous generations of dentists and dental leaders. While dean at Pacific, he had a saying that "At Pacific we grow people, and along the way they become doctors." No statement could be truer and more emblematic of his character.

My father grew up in the North Beach area of San Francisco, the son of Italian immigrants. He married the love of his life, Kaye, in 1949 after graduating from the College of Physicians and Surgeons (P&S). He served in the US Navy as a dental officer in Bethesda during World War II and as chief oral and maxillofacial surgeon for the 1st Marine Division at Camp Pendleton during the Korean War. My parents were married for 66 years until my mother's passing in 2015. Together they raised seven

children, five sons and two daughters. Four of his children are involved in dentistry today.

In 1948, my father graduated from Physicians and Surgeons Dental School in San Francisco, now known as the University of the Pacific Arthur A. Dugoni School of Dentistry, and eventually limited his practice to pediatric dentistry while teaching at P&S. In 1960, at the age of 35, he entered the orthodontic program at the University of Washington, returning to San Francisco upon graduation.

His many accomplishments include presidencies of the California Dental Association, the American Dental Association, the

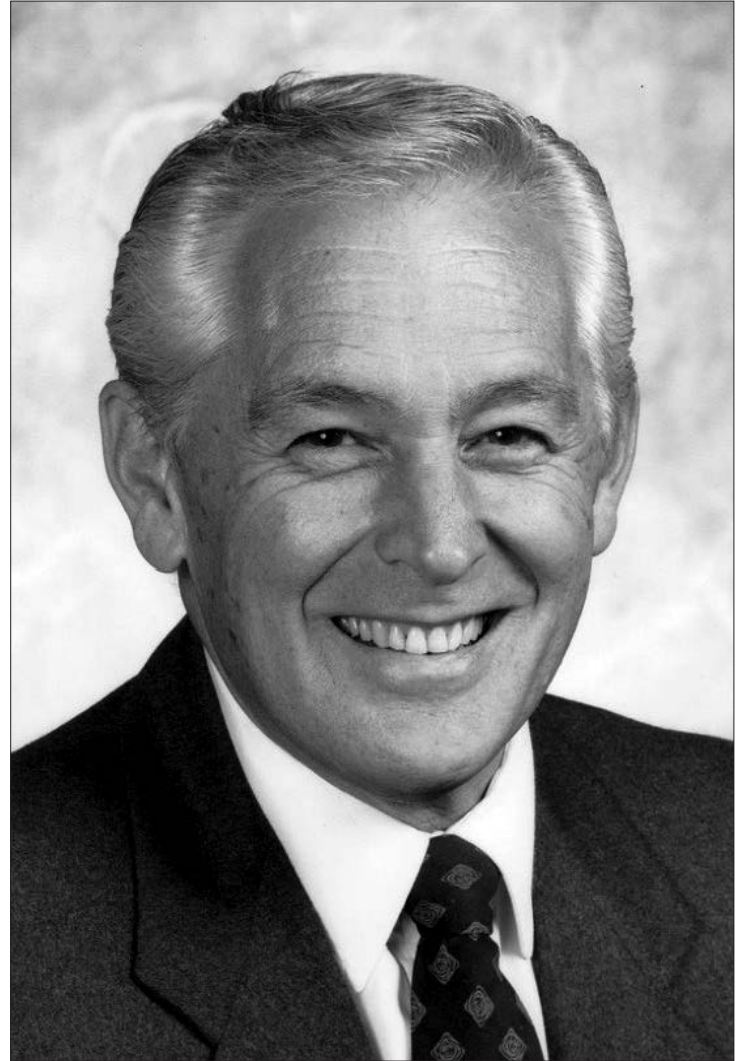

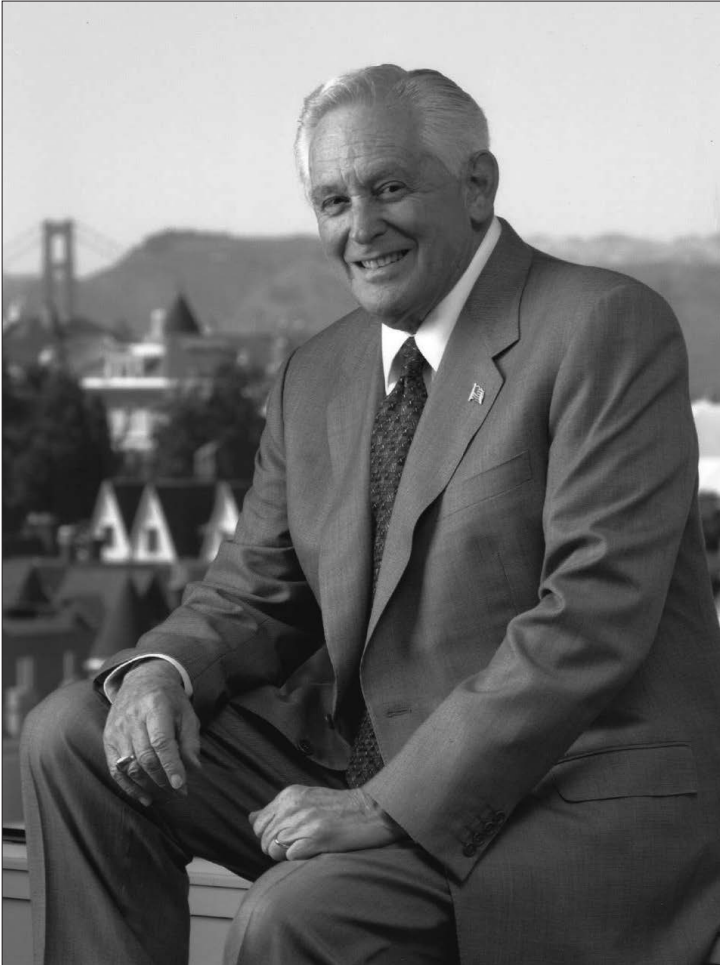
American Board of Orthodontics, the American Association of Dental Schools and the American Dental Association Foundation, to name a few. He served for more than 20 years each as a Delegate to the CDA and the ADA. He was the recipient of the AAO Ketcham Memorial Award, the highest award presented to a member educator. He also delivered both the Mershon and Salzman lectures at the AAO Annual Sessions. He became dean at Pacific in 1978 and served in that capacity for the next 28 years. He was a brilliant administrator who related well to all of his students and residents. He loved to teach, and he brought to dental education a new "humanistic" instruction model based on his belief that learning should be a respectful and empowering experience for everyone, including students, staff, and faculty. The dental school was renamed the University of the Pacific Ar-

thur A. Dugoni School of Dentistry in 2004, the first time in American history that a dental school was renamed after a sitting dean. My father was a proud member of the Edward H. Angle Society and delivered the Angle Memorial Lecture at the Biennial meeting in 2005 at Incline Village, NV. When I was a young orthodontist, my father encouraged me to teach at the dental school, become ABO certified, and join the Angle Society, which he also encouraged many other young orthodontists to do.

In addition to his dental life, my father was a devoted family man. He loved nothing more than gatherings at home with his many grandchildren and great grandchildren and attending SF Giants, Golden State Warriors, and SF 49ers games with the family.

Two terms are used repeatedly to describe my father—role model and inspirational leader. He intuitively knew that by being positive, people would be challenged to live up to worthy expectations, and he had faith that they would meet that challenge. He was proud to have nurtured young graduates to serve

in organized dentistry as well as leadership positions in dental politics and their communities. He believed in giving back to the profession which has given so much to each of us and supporting our respective dental schools. My father and mother personally established two endowment funds at Pacific Dugoni and contributed more than \$1 million to each. Now a third fund, the Art Dugoni Scholar Award, has been established with the expectation that, when funded, it will provide a full scholarship for one deserving dental student each year. My father was altruistic; he never mentored for personal gain, but always for the betterment of those he mentored. He was the definition of an outstanding leader.

His presence made the world a better place, and his death is a loss for all of us. However, he optimistically prepared each of us to carry on successfully. The rest is up to us. Rest in peace, dad. ■

OBITUARY FOR DR. HARRY CARL KIZER

Dr. Harry Carl Kizer, age 89, of Rockwall, TX, passed away Saturday, July 25, 2020. He was born September 27, 1930, in Hugo, OK, to Harry Cern and Thelma May (Walker) Kizer. Harry was the second youngest of eight children and graduated from Hugo High School before serving in the United States Air Force during the Korean War as a top turret gunner in a B-29 Superfortress. While serving in the military, Harry married Dorothy Elizabeth Murphy of Hulen, OK on December 2, 1952. After the military, Harry attended Oklahoma A&M in Stillwater, OK before moving to Dallas to attend the Baylor College of Dentistry. Harry practiced orthodontics for 61 years and truly loved his patients, especially children. He was very active in the Texas Dental Association, the Dallas County Dental Society, and the Angle Society of Orthodontics, serving as president of the latter from 1975 to 1977.

In 1970, the Kizers moved to Heath, and Harry served on the Board of Trustees of the Rockwall Independent School District, including a period as president, and as a Deacon at the First Baptist Church of Heath.

Dr. Kizer was preceded in death by his parents, five of seven siblings and his son: Karl Kizer. Harry is survived by his loving wife of 67 years: Dorothy Kizer; children: Gregory Kizer and

Brant Kizer; grandchildren: Shelby Bragg, Lawson Kizer and Travis Kizer; and great grandsons: Mason Bragg and Madden Bragg.

Harry was one of the smartest people I have ever known and unlike so many of those gifted with intelligence, he had a common touch that invited friendships and camaraderie plus an unusual sense of humor. We were classmates and formed a lasting bond that first year in Baylor Dental College that has enriched my life forever. His authentic personality made him well-suited for our present age because of his contrast to it. The current presence of so much uncivilized, censorious and accusatory behavior makes Harry's self-effacing reserve, morality and fidelity especially refreshing and valued.

Few have ever combined their devotion and commitment to family, friends, community, business and faith so extravagantly as Harry and, like Michelangelo, adorned whatever he touched. His clinical skills were more than admirable; they were extraordinary, and he was so fortunate to love orthodontics and continued doing it until the time of his death, which brings to mind the Psalmist's perception, "Those that be planted in the house of the Lord shall flourish in the courts of our God. They shall still bring forth fruit in old age." ■
