Dear Friends and Family,

On behalf of the Pueblo of Acoma, it is my esteemed pleasure to welcome you to Albuquerque, New Mexico, for the 26th Annual NATHPO Conference. The Pueblo of Acoma is sincerely honored to host this year’s conference and hopes it will be an experience to remember.

As we gather, we recognize that New Mexico is the ancestral homelands of the 19 Pueblos, the Apache, and the Navajo Peoples, whose enduring stewardship, cultural traditions, and deep connections to these lands continue to shape the "Land of Enchantment". We offer our respect and gratitude to the ancestral communities and acknowledge the privilege of convening on their ancestral homelands.

The Pueblo of Acoma is approximately 60 miles west of Albuquerque and is considered to be one of the "Oldest Continuously Inhabited Cities" in the United States. To the Acoma people this place is called "Haak'u" meaning a place prepared. Acoma Pueblo sits atop a 367-foot sandstone bluff. Today the people that live there still survive without modern amenities such as running water or electricity.

For the Acoma People, and for many Pueblo Nations, migration and origin stories are not simply stories of the past—they are living histories that continue to guide our identity, responsibilities, and relationship with the land. The Acoma migration story, like those of other Pueblo Peoples, touches many sacred places across the Southwest, including Chaco Canyon, Mesa Verde, Bears Ears, and the canyons and landscapes that connect our ancestral homelands. These places are not relics of history; they are living cultural landscapes where our ancestors lived, prayed, and left their footprints. Our people continue to journey to those homelands today to fulfill our cultural and spiritual responsibilities.

As Tribal Nations, we continue to advocate for the protection of these sacred places from oil and gas company exploration teams and other development organizations that could disrupt the land. We do so because these landscapes remain alive in our traditions and continue to sustain our ceremonies, teachings, and migrations. Protecting the land is not only about preserving the past—it is about safeguarding living cultures and ensuring that future generations can maintain their connections to our ancestral homelands.

The NATHPO Conference brings together Tribal Historic Preservation Officers, Tribal leaders, cultural practitioners, preservation professionals, federal and state partners, scholars, and



advocates who share a common purpose: Protecting Tribal cultural heritage, preserving sacred places, strengthening Tribal sovereignty, and ensuring that Indigenous voices guide the stewardship of cultural resources for future generations.

In the coming days, we hope you will find opportunities to learn from one another, exchange innovative ideas and best practices, strengthen existing partnerships, and build new relationships. May this conference inspire collaboration and reaffirm our collective commitment to preserving the histories, cultures, languages, and living traditions of Tribal Nations through keynote presentations, workshops, panel discussions, and informal conversations. We welcome you to experience the history of the land and resiliency of the people of Acoma, Sky City, at your scheduled site visit during the conference.

We extend our sincere appreciation to our hosts, presenters, sponsors, volunteers, and planning committee for their dedication in making this gathering possible. Most importantly, we thank each of you for your commitment to protecting Tribal heritage and for the invaluable work you do in your communities every day.

We wish you a meaningful, productive, and enjoyable conference, and we hope your time in New Mexico, "The Land of Enchantment" is filled with education, spiritual connection, and renewed purpose.

SITE VISITS & CULTURE NIGHT

MONDAY OPTIONAL SITE VISITS

X PETROGLYPH NATIONAL MONUMENT

Located in Albuquerque, Petroglyphs National Monument is home to one of North America's largest petroglyph sites. It includes designs and symbols carved into the rock by the region's Indigenous peoples and, later, Spanish settlers. Participants will be able to choose one of three different hikes in the monument area. The Boca Negra Trail (moderate to strenuous difficulty) offers three separate trails with a view of roughly 100 petroglyphs; the Piedras Marcadas Canyon Trail (easy to moderate difficulty) offers views of nearly 400 petroglyphs; and the Rinconada Canyon Trail (moderate difficulty) follows the northern escarpment, allowing the viewing of a variety of petroglyphs.

X SANDIA PEAK TRAMWAY

Located on the outskirts of Albuquerque in the Cibola National Forest, Sandia Peak, also known as "Turtle Mountain" and to others as "Big Mountain," is a sacred place to many Pueblo peoples. Participants will enjoy stunning views as they ride the tramway, the longest aerial tram in the Americas, to the peak. From there they will have a beautiful view of Albuquerque below, and Mount Taylor (known as Kaweshtima to many Pueblo peoples) in the distance. Participants may also have time to take a brief hike along Sandia Crest, where they can enjoy more even more of this rich living cultural landscape.

X INDIAN PUEBLO CULTURAL CENTER

THURSDAY SACRED PLACES SUMMIT

X ACOMA SKY CITY CULTURAL CENTER AND HAAK'U MUSEUM

Located about an hour west of Albuquerque, Acoma, also known as Sky City, is one of the Oldest Continuously Inhabited Communities in the United States. On Thursday, we will stop first to visit the Acoma Sky City Cultural Center and Haak'u Museum, and from there venture up the mesa to Sky City itself, where we will get to experience this historic community still inhabited by members of Pueblo of Acoma and used for ceremonial gatherings throughout the year. From Sky City, we will be treated to another view of Kaweshtima (also known as Mount Taylor) and other parts of the valley that have been home to the Acoma people for generations.

POTENTIAL FOR ALTITUDE SICKNESS:

Altitude sickness occurs when people ascend to high altitudes too rapidly, preventing the body from acclimatizing to the reduced oxygen levels. While it’s more likely to happen above 8,000 feet, some individuals may experience challenges at lower elevations closer to 5,000 ft. The high altitude can cause mild symptoms that include headache, nausea, loss of appetite, fatigue, dizziness, and difficulty sleeping. Primary treatment for mild altitude sickness includes rest, hydration, and over-the-counter pain relievers like ibuprofen. At an average elevation of 5,312 feet (1,619 meters) above sea level, Albuquerque is one of the highest major cities in the United States. If you are feeling unwell, please use your discretion as to what activities you should participate in or if you need to see seek medical attention.

VISITOR ETIQUETTE

Tours of the Pueblo of Acoma are a privilege granted by the Acoma Tribal Council. Visitors must follow all Pueblo laws, rules, and regulations. Smoking is prohibited during tours.

When descending from the mesa top on foot, always remain on the designated path.

PHOTOGRAPHY GUIDELINES

Before taking photographs on Acoma lands, purchase a camera permit at the Sky City Cultural Center. Photography is prohibited inside the church, in the cemetery courtyard, and during feast days. Always obtain permission before photographing Tribal members or their artwork.

Tripods, GoPros, video cameras, digital video cameras, binoculars, and audio recording devices are prohibited. Acoma imagery may not be used commercially or for personal profit.

VIOLATORS OF THESE GUIDELINES WILL HAVE THEIR FILM AND/OR CAMERA CONFISCATED.

DRESS CODE

Dress comfortably and appropriately for the weather. Out of respect for the cultural significance of the Acoma Reservation—especially the village mesa top—please avoid revealing clothing, including short shorts or skirts, and tank tops. Visitors wearing inappropriate attire will be respectfully asked to cover up. Thank you for observing the dress code while visiting the Pueblo of Acoma’s historic and sacred sites.

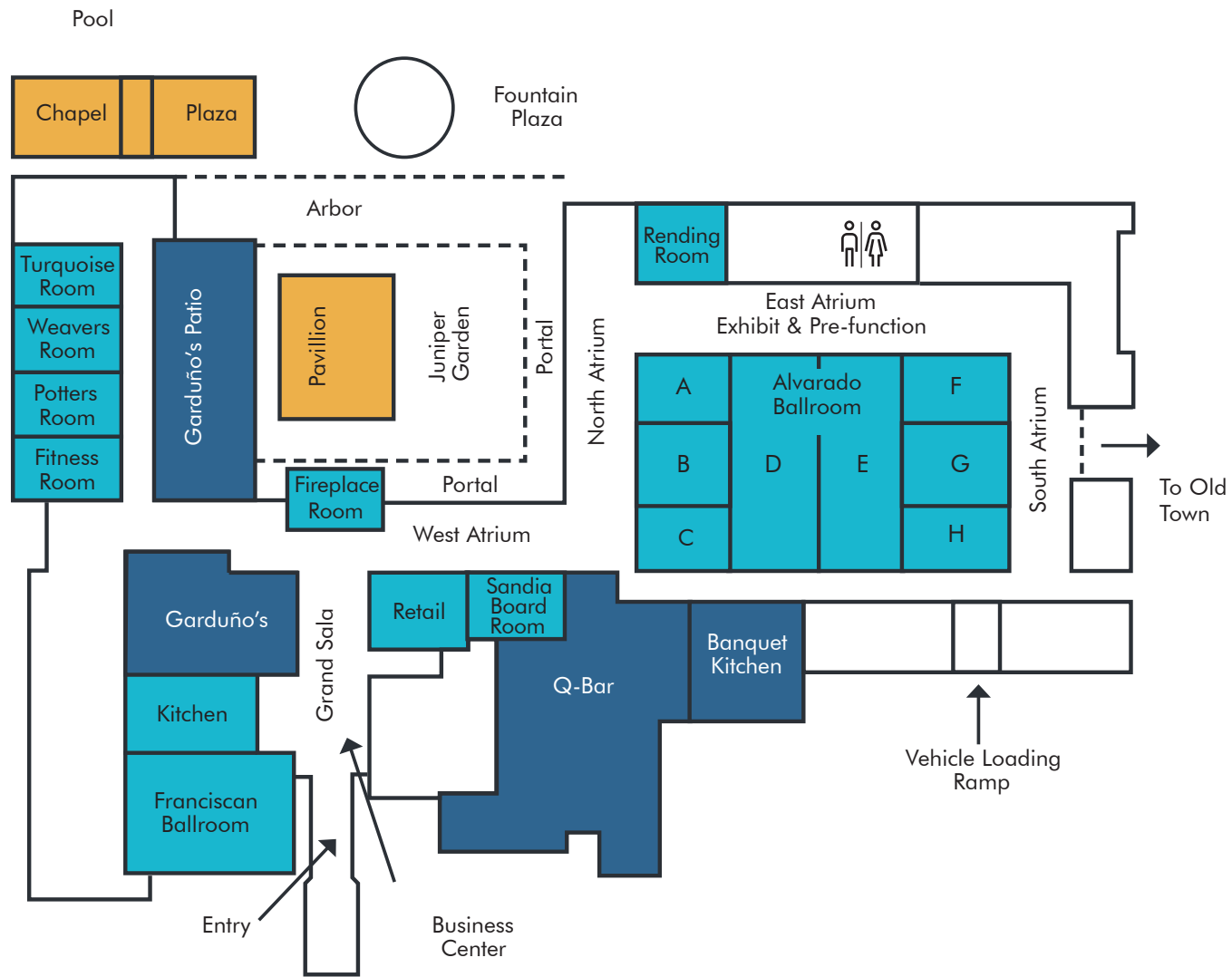

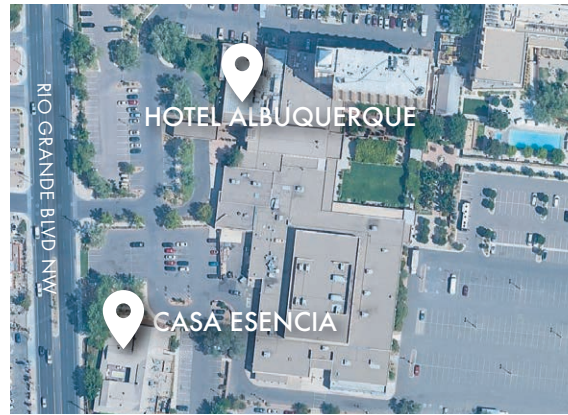

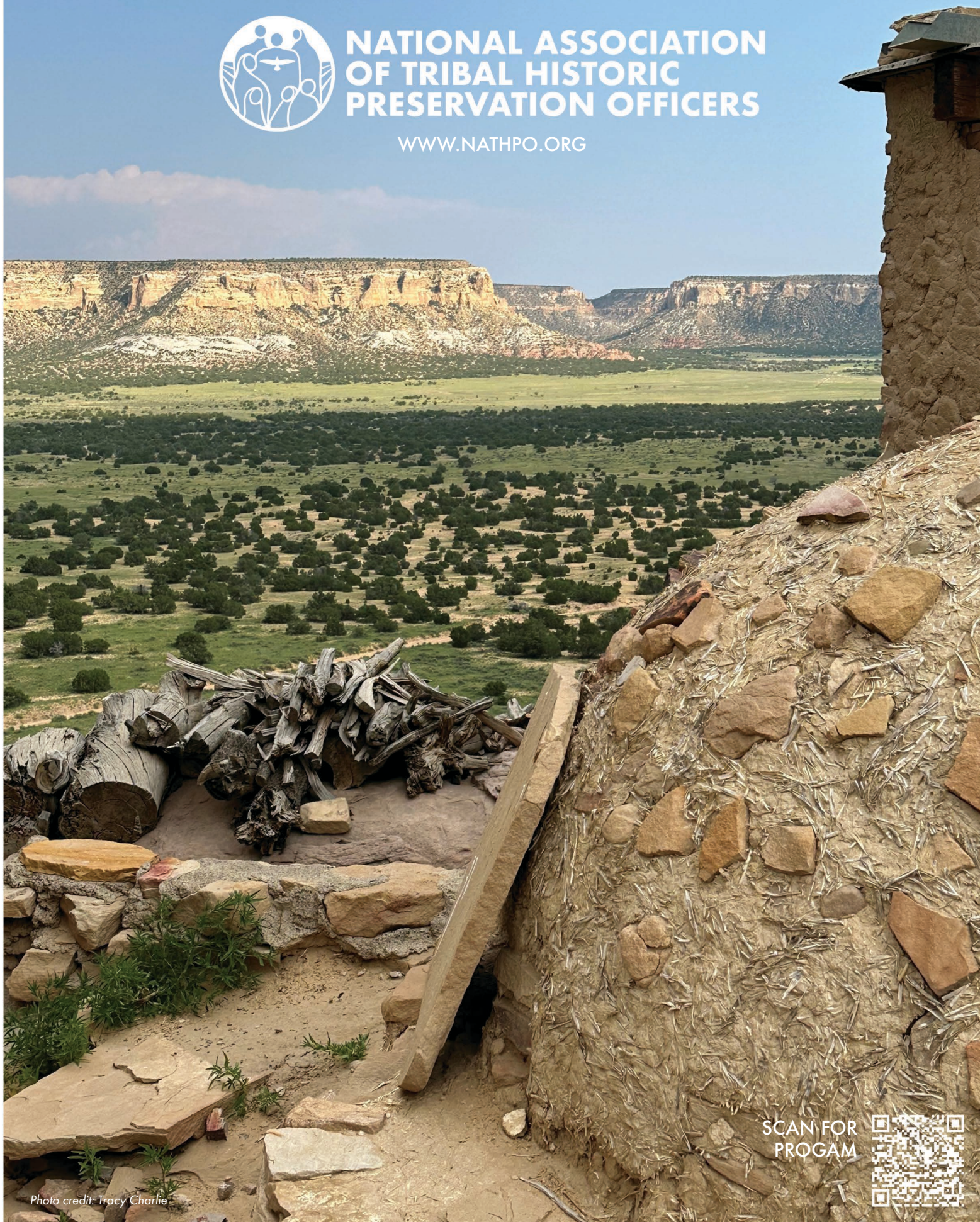
