



## REALTOR MEMBER APPLICATION

I hereby apply for REALTOR® Membership in the Mid-Shore Board of REALTORS (MSBR), enclosing payment in the amount of \$850.00 for full year membership (December 1, 2025, through November 30, 2026) or a prorated amount as advised by MSBR staff. (This includes the dues for National, State, and local, \$25 voluntary contribution to RPAC—Realtor Political Action Committee, and \$25 suggested donation to the Mid-Shore Down Payment Assistance Program). Plus, there is a one-time \$150.00 application fee. Dues and fees are payable to the MSBR.

I understand that my dues will be returned to me in the event of non-election and that the application fee is nonrefundable.

### Initial by Each:

\_\_\_\_ I will attend a new agent orientation training and a Code of Ethics and Predatory Lending continuing education class within 90 days of Association's confirmation of membership. Failure to meet this requirement can result in having my membership terminated.

\_\_\_\_ Membership in MSBR necessarily means that I am also a member of the State and National Associations of REALTORS® and I agree to abide by the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS®, which includes the duty to mediate, and to abide by the Constitution, Bylaws and Rules and Regulations of MSBR and of the State Association and the National Association.

\_\_\_\_ I acknowledge that as a member of the MSBR I will be licensed to use the REALTOR® trademarks to indicate such membership, and I agree to abide by the rules governing use of those trademarks. I understand that REALTOR® is a federally registered trademark of the National Assoc. and use of this designation is subject to rules promulgated by the National Assoc. Upon termination of my membership in MSBR, for any reason, my license to use the term REALTOR® is automatically revoked and I will immediately discontinue use of the term and all trademarks.

\_\_\_\_ Membership is final only upon approval by the Board of Directors and may be revoked should completion of requirements, such as orientation or Code of Ethics and Predatory Lending class not be completed within timeframe established in the association's bylaws.

\_\_\_\_ I acknowledge that the duty to arbitration and/or ethics complaint continues in effect even after membership lapses or is terminated, provided the dispute arose while I was a REALTOR®. Any ensuing discipline will be held in abeyance until such time as I rejoin an association of REALTORS®.

The dues amount is prorated according to month joining unless membership was held the previous year. The dues are based on the following breakdown: NAR, State, Mid-Shore Board of REALTORS, new agent fee, RPAC and the MSBR Down Payment Grant Program.
