## WHAT THEY'RE WORKING ON

**Natalie Jones of [The Star-Democrat](#)** reports that, "...over 500 bills were prefiled ahead of the

session's Wednesday start, with conversations about **public safety, budgetary concerns, health care, climate change and housing** expected to dominate the 90-day legislative session."

**Keep an eye out for:** The **Environment and Transportation Committee**, where the majority of agriculture bills get referred to. Delegate **Marc Korman** [takes the reins](#) as the new **Chairman**, with Delegate **Regina Boyce** serving as **Vice-Chair**, as well as the **Chair of the Subcommittee on Agriculture**.

## WHAT WE'RE MESSAGING ON

A bill is expected to be introduced on [mandating cage-free egg production](#) in Maryland. Here is why that is bad for Maryland farmers:

**Biosecurity risks:** Transitioning to cage-free operations elevate the risk of bacterial contamination, leading to notable increases in hen mortality – especially when avian flu [has been detected in our state](#).

**Loss of contract business:** The vast majority of Maryland poultry farmers are contract growers. Banning caged operations would result in companies terminating their contracts and moving to other states.

**Threat to small-scale egg farms:** Small farms with caged systems may face financial challenges, like needing capital to retrofit their operations, potentially leading to closures.

**Food insecurity:** Eggs are often the most affordable protein for low-income Marylanders. A cage-free mandate would [send egg prices skyrocketing](#) for Marylanders who are already hit hard from inflation.

**Cost/Benefit analysis is needed:** Any regulation should undergo thorough cost/benefit analyses, ensuring that proposals are both scientifically grounded and economically viable for Maryland ag.
