PRESIDENT'S UPDATE

DAVID BURRIER

I would like to wish our Farm Bureau members a Happy New Year. Each new year brings new hope and new opportunities to engage in our priorities to keep our industry and our organization strong.

Our top priority remains property rights, which have been tested this past year. In the 2025 Maryland session, there were severe budget cuts affecting agriculture today and our future.

Our governor cut deep into farmland preservation funds as well as our successful cover crop program funds to balance his budget. The Farm Bureau worked and lobbied on every bill that challenged agriculture.

We also remain at the forefront of opposing the MPRP powerline. We remain committed to defeating this project and continue to explore alternate opportunities for the transmission and generation of power. This project will negatively impact many Frederick County farms.

It is of no benefit to Maryland's self-induced power crisis nor does Frederick County receive any power from the proposed powerline.

Frederick County Farm Bureau also put an enormous effort into the data center bill enacted by our County Council. From the very beginning we engaged to protect our Rural Legacy and our Priority Preservation Acres from being included in the overlay zone.

The County Council voted to enlarge the overlay zone without any regard for our concerns. We feel this sets a dangerous precedent to future county proposals and therefore the future of our industry is very much challenged. We will continue to meet with our county officials to voice our concerns and to diligently advocate for our members to preserve our local agriculture industry.

At our annual meeting in October, Denny Ogg and Jarrod Burall were reappointed to the board of directors. Newly appointed board members were Beth Ahalt and Robert Black.

We have a strong board who works tirelessly on relationships with our legislators at all levels of government, enabling us to have a voice at the table.

At the Maryland Farm Bureau Convention in December, Frederick County had another highly successful year. We worked diligently on our policy proposals affecting our county. Six of the proposed policies were adopted and can now be used by the Maryland Farm Bureau lobbyist in the upcoming legislative session.

Frederick County also received an Activities of Excellence Award for our Safety Fair at the Frederick Fairgrounds. Thank you to all the committee chairs and members for their hard work in our activities, putting together another successful year.

Our committee met on October 6, 2025, with updates on the Spring Luncheon, Farmer & Farmerette Contest, Ambassador Contest, participation in The Great Frederick Fair, and final planning for the Annual Bingo Fundraiser.

Annual Bingo Fundraiser
