What is PCP?

The PCP, or Professional Certification Program, is an industry certification program developed by the Spray Polyurethane Foam Alliance (SPFA). It is designed to create standards for SPF Professionals and to verify the knowledge, skills, abilities and experience needed for success.

PCP Objectives

- Identify and recognize SPF professionals that meet and uphold the highest standards
- Test SPF professional's awareness of best practices and industry standards
- Verify that SPF professionals have the knowledge to work with spray foam effectively, efficiently and safely

PCP Benefits

- Certification shows that an individual has demonstrated the knowledge, skills and abilities to do the job right
- Committing to best practices shows professionalism
- Investing in industry credentials can build credibility and confidence with your customers

SPFA PCP CERTIFIED INDIVIDUALS

- **Demonstrate** their knowledge, skills and abilities via examination, meeting experience criteria and by completing certification requirements.
- **Know** how to work with spray foam, including application, handling, and usage guidelines.
- **Understand** that insulation and roofing projects must be installed properly to ensure they perform at their best.
- **Use** certification credentials to establish professionalism and differentiate themselves from competitors.



The four levels of certification are progressive, beginning with the SPF Assistant (Level 1) to SPF Project Manager (Level 4).

LEVEL 1: SPF ASSISTANT

The SPF Assistant certification level is specifically designed for individuals involved in the assistance of safe and consistent installation of SPF in thermal and/or roofing installation. You are not required to start with SPF Assistant but will be tested on this information in the higher level exams.

Requirements

- Assistant Written Exam*



LEVEL 2: SPF INSTALLER

The SPF Installer level is specifically designed for individuals with limited experience in the spraying of SPF in a safe and consistent manner. It is an apprentice level.

Requirements

- 100,000 BF (Insulation) or sq.ft. (Roofing) minimum spraying experience
- Installer Written Exam: 2 parts (Assistant and Installer)



LEVEL 3: SPF MASTER INSTALLER

The SPF Master Installer has extensive experience spraying SPF in various applications and has demonstrated competence in SPF installation.

Requirements

- 500,000 BF (Insulation) or sq.ft. (Roofing) minimum spraying experience
- Field Exam
- Master Installer Written Exam: 3 parts (Assistant, Installer, Master Installer)



LEVEL 4: SPF PROJECT MANAGER

The SPF Project Manager has extensive project management experience in SPF applications.

Requirements

- 500,000 BF (Insulation) or sq.ft. (Roofing) minimum project management experience
- Project Manager Written Exam: 4 parts (Assistant, Installer, Master Installer, Project Manager)

PCP CERTIFIED: Supplier Representative

Supplier Representative is an individual who has direct advisory contact with a contractor or distributor (as applicable, if the supplier only sells through distribution) involved with SPF related materials, equipment or services, etc. These individuals may include sales representative, technical representative or appropriate staff as determined by supplier.

- All Knowledge Areas From All Contractor Levels (Assistant, Installer, Master Installer, Project Manager)
- Supplier Representative Written Exam*



PCP CERTIFIED: Field Examiner

The SPFA PCP Certified Field Examiner is an individual who conducts the field examination for a candidate seeking to become a Certified Master Installer. The field examination is an over-the-shoulder evaluation of a candidate's abilities in all aspects of SPF application.

- Prequalification Experience Declaration Required
- Field Examiner Training Course is Required
- Field Examiner Written Exam is Required

An SPFA PCP Accredited Contractor Company has fulfilled all the criteria of the Professional Certification Program.
