Nonpartisan Voter Participation Resources for Healthcare Partners

Prepared for Arizona Hospital and Healthcare Association

Purpose

This toolkit provides Arizona-specific voter education materials for hospitals, providers, healthcare employees, community partners, and advocates. It is designed to promote voter readiness, official election resources, and awareness of healthcare as a community issue without supporting or opposing any candidate, political party, or campaign.

Core rule: Keep all materials nonpartisan, Arizona-specific, and grounded in official voter resources.



1. Toolkit Overview

Arizona Hospital and Healthcare Association describes its work around access to quality, 24/7 patient care, coalition-based engagement, data-informed policy, and patient- and clinician-centered advocacy. This toolkit applies to Arizona healthcare's focus on nonpartisan voter education and voter readiness. [1]

The goal is simple: help eligible Arizonans know where to find official voter information, understand key election deadlines, and connect civic participation with healthcare access, workforce stability, and community well-being.

2. How to Use This Toolkit

Use this toolkit as a plug-and-play resource for nonpartisan voter education. Select the sections that match your audience, verify all election dates with official sources before publication, add county-specific links when appropriate, and keep messages neutral and informational.

Graphics may be shared with the provided captions. Email templates and message banks may be adapted for internal, partner, or community use. Before publishing, confirm that all links, dates, and disclaimers are current.

3. Who This Toolkit Serves

- Hospitals and health systems
- Healthcare providers and clinical teams
- Employees and internal communications teams
- Community, business, and provider roundtable participants
- Patients, families, and local partners seeking official voter information
- Coalition partners focused on healthcare access and civic participation

4. Core Messaging Principles

Use clear, neutral language. The message should encourage participation and access to official information, not tell anyone which candidate, party, or campaign to support.

- Healthcare is connected to Arizona families, workers, patients, providers, and local economies.
- Hospitals are major employers and economic anchors across the state.
- Voting is one way eligible Arizonans can participate in decisions that shape public policy.
- Official voter information should come from the Arizona Secretary of State or county election officials.
- All materials should avoid candidate names, party labels, campaign slogans, endorsements, or opposition language.

Arizona Healthcare Impact Message Bank

Use these statewide facts to show why healthcare is a community and economic issue in Arizona. These numbers are presented as reference points for issue education, not campaign messaging.

Source note: The reference deck describes these as 2026 estimates based on the 2024 American Hospital Survey and BEA RIMS multipliers. The deck excludes behavioral health hospitals, Indian Health Service facilities, and 638 Tribally owned or operated facilities.

Sample Healthcare Issue Messaging

- Arizona hospitals support direct jobs and additional jobs across the state, making healthcare a workforce and economic issue as well as a public health issue.
- Healthcare access matters in urban, rural, and underserved communities, where stable provider networks and hospital capacity can affect families and local economies.
- Voter participation helps keep healthcare access, workforce needs, and patient care part of Arizona's public conversation.
- Use data carefully. Facts should inform voters about healthcare issues without suggesting support for or opposition to any candidate.



5. Ready-to-Use Email Templates

Email 1: Employee Voter Readiness Reminder

Healthcare policy affects patients, families, providers, and communities across Arizona. As part of a nonpartisan voter participation effort, we encourage eligible employees to check their voter registration, review election deadlines, and make a plan to vote.

Official voter information is available through the Arizona Secretary of State and county election officials, including registration, voter status, early voting, ballot-by-mail, and Election Day information.

This message is nonpartisan and does not support or oppose any candidate, political party, or campaign.

Thank you for helping keep Arizona's healthcare community informed and engaged.

Email 2: Community Partner Outreach

Subject: Sharing Arizona voter resources with our community

Arizona Hospital and Healthcare Association is sharing Arizona-specific voter resources as part of a nonpartisan effort focused on healthcare, civic participation, and community awareness.

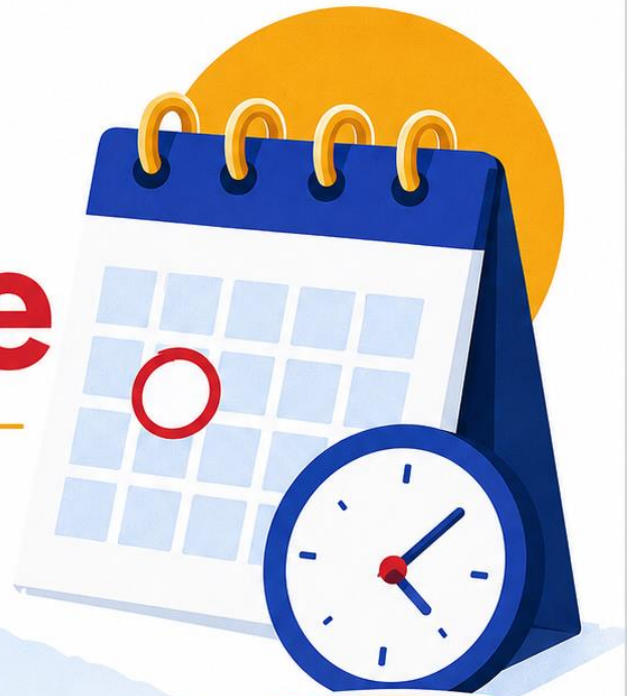

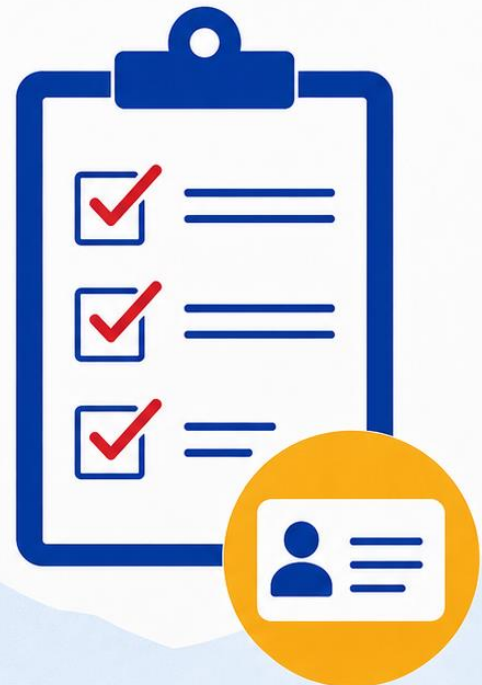

7. Employee-Facing Messages

- Healthcare policy affects the work we do and the communities we serve. Eligible employees are encouraged to check voter information, review Arizona election deadlines, and make a plan to vote.
- Your voice matters. Take a few minutes to confirm your Arizona voter registration status and learn about early voting, ballot-by-mail, and Election Day options through official Arizona election resources.
- Voter participation is one way healthcare employees can help keep healthcare issues visible in Arizona. Please use trusted, nonpartisan voter resources as you prepare for upcoming elections.
- This message is informational and nonpartisan. It does not support or oppose any candidate, political party, or campaign.

8. Community-Facing Messages

- Healthcare affects every Arizona family. Arizona Hospital and Healthcare Association encourages eligible voters to check registration, learn key election deadlines, and make a voting plan.
- Strong healthcare systems support strong communities. Civic participation helps Arizona communities make their voices heard on issues that affect patients, providers, workers, and families.
- Official Arizona voter resources are available through the Arizona Secretary of State and county election officials. Use those sources for current information on registration, early voting, ballot-by-mail, and Election Day requirements.
- Healthcare is connected to Arizona's workforce, economy, and public health. Arizona Hospital and Healthcare Association supports civic participation and voter readiness across Arizona communities.

Arizona Voter Resource Links

Use the Arizona Secretary of State and county election officials as the primary sources for voting information. Add county-specific links when sharing local polling place, ballot drop-off, or county recorder details. [2, 3, 4, 5]

2026 Arizona Election Calendar Planning

Use this calendar for planning content, reminders, and partner outreach. Confirm all deadlines with the Arizona Secretary of State and county election officials before publication. [6, 7, 11]

Primary Election	June 22, 2026 - registration deadline	Registration reminder and direct AZSOS link
Primary Election	June 24, 2026 - early voting begins / early ballots mailed	Early voting and ballot-by-mail education
Primary Election	July 21, 2026 - Primary Election Day	Final in-person voting information
General Election	September 19, 2026 - UOCAVA deadline	Military/overseas voter information awareness
General Election	October 5, 2026 - registration deadline	Last registration reminder
General Election	October 7, 2026 - early voting begins / early ballots mailed	Early voting education
General Election	November 3, 2026 - General Election Day	Final in-person voting information
Voter participation dates	August / Sept. 15 / Oct. 27	Civic Health Month, National Voter Registration Day, and Vote Early Day content

9. Content Timeline for 2026

The uploaded communications plan uses a staged approach: build the resource page, promote registration reminders, explain early voting, remind voters about deadlines, and close with in-person voting information.

Timing	AzHHA content focus
April-May 2026	Prepare toolkit, graphics, landing page copy, QR codes, and internal approval process.
June 2026	Share Primary Election registration reminders and early voting education.
July 2026	Share Primary Election Day information and in-person voting reminders.
August 2026	Use Civic Health Month to connect healthcare, community well-being, and voter readiness.
September 2026	Promote voter registration, National Voter Registration Day, and the upcoming General Election deadline.
October 2026	Explain early voting, ballot-by-mail, ID requirements, and final deadline reminders.
November 2026	Share General Election Day information and link to official Arizona voting resources.

10. Website / Landing Page Structure

A clean website page can live under a policy, advocacy, or voter participation section. The uploaded outline suggested a voting tools page with featured resources, candidate education materials, and a toolkit. The structure below keeps the idea Arizona-specific and removes national campaign references.

11. Roundtable and Partner Activation Plan

Use this toolkit during Community Business & Provider Roundtables, coalition meetings, and partner outreach. The goal is to make official voter information easy to access while keeping materials neutral and issue-focused.

- Add one Arizona voter resource card to each roundtable packet.
- Include a QR code to the Arizona Secretary of State Voters page and a separate QR code to the AzHHA website.
- Use a short speaker note connecting healthcare access, workforce needs, rural and urban care capacity, and community well-being.
- Ask partners to share official Arizona election resources with their networks, not candidate or campaign materials.
- Track distribution numbers, partner participation, and resource requests for internal reporting.

12. Nonpartisan Use Guidance

For hospitals, health systems, and nonprofit partners, keep all voter education and get-out-the-vote activity neutral. The IRS explains that 501(c)(3) organizations may conduct voter registration and get-out-the-vote activity when it is conducted in a neutral, nonpartisan manner. The IRS also states that 501(c)(3) organizations may not directly or indirectly participate in political campaigns for or against candidates. [8, 9]

• Encourage voter registration and participation.	• Endorse or oppose candidates.
• Use official Arizona voter resources.	• Endorse or oppose political parties.
• Use neutral, issue-focused language.	• Coordinate with campaigns.
• Make materials available regardless of political preference.	• Share campaign materials.
• Include a nonpartisan disclaimer.	• Tell people who to vote for or how to vote.

Recommended Nonpartisan Disclaimer

Arizona Hospital and Healthcare Association is providing this information as a nonpartisan voter participation resource. This material does not support or oppose any candidate, political party, or campaign. Voters should consult official Arizona election resources for current information.

13. Quick Copy Bank

- Check your voter information. Make a plan. Use official Arizona election resources.
- Healthcare affects every Arizona community. Civic participation helps keep healthcare part of the conversation.
- Before Election Day, confirm your registration status, review early voting options, and check voter ID requirements.
- Arizona hospitals support jobs, patient care, and local economies across the state.
