1. State Deputy Fire Marshals are inspecting “Full Forward Flow” tests. This is not a backflow preventor test, rather a functional test of your system at full flow. Challenges include how to handle the amount of water involved in this test.
2. Clean Buildings Act is approaching – Challenges exist in additional documentation required in what appears to be an adoption of ASHRAE 100 as law. Requirements include an Operations and Management plan with asset inventories broken into their prescribed categories and an energy management plan including occupant lightings satisfaction survey. Feels like intrusive overreach with no value added.
