Education Session: Facilities Safety Best Practices - Paul Koenig Enterprise Account Manager: Safety Services



Paul provided a fantastic presentation with emphasis on protecting our staff, clients and visitors to our facilities. Paul stressed the importance of conducting risk assessments and keeping documentation of actions taken. Paul discussed Lock-out / Tag-out, Confined Spaces and Hazardous Energy Exposure and the importance of having plans and risk assessments in place. He shared the importance of creating policies and procedures for specific pieces of machinery that all persons would follow when working inside your facility including outside contractors. He also discussed the importance of not relying on memory for these processes. Lastly Paul stated how important it is to review and update these processes and procedures regularly.
