

New Intrastate Requirements GS 20-101

The USDOT intrastate number will be clearly recognized on the vehicles by the letters "NC" preceding the number.

Example: USDOT 1234567 NC

Effective **December 1, 2012** all North Carolina Intrastate Commercial Motor Vehicles in Intrastate Commerce will be required to display a USDOT number followed by the letters "NC".

Failure to be in compliance by **December 1, 2013** will result in a penalty of \$100.00 per each occurrence.

North Carolina Intrastate Commercial Motor Vehicles

Required to Register for a USDOT Number

Effective December 1, 2012

The 2012 North Carolina General Assembly changed General Statute 20-101 requiring North Carolina commercial motor vehicles operating exclusively in North Carolina to register for an USDOT number.

When should you register?

Effective December 1, 2012, your company (if applicable) will be required to obtain an Intrastate USDOT number and display the number on all your Commercial Motor Vehicles in accordance with 49CFR Part 390.21 followed by the letters "NC" as described in GS-20-101.

How do you register?

Commercial motor vehicles may apply for an Intrastate USDOT number on the FMCSA website.

Note: If you have been issued a USDOT number in the past but have been deactivated, you will need to go online and update your registration (MCS-150) to re-activate or to change your status from registrant to intrastate.

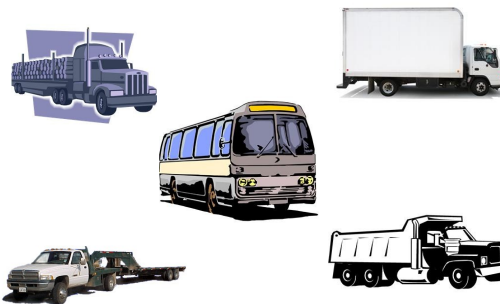


Requirements to Register

You need to register for an Intrastate USDOT number if your company operates a Commercial Motor Vehicle if the:

Gross vehicle weight rating (GVWR) or gross combination weight rating (GCVWR) or gross vehicle weight (GVW) or gross combination weight (GCW)

- ◆ Is 26,001 pounds (11,793 kg) or more which ever is greater
- ◆ Designed or used to transport 16 or more passengers (including the driver) for compensation
- ◆ Used in transporting a hazardous material in a quantity requiring placarding pursuant to 49 C.F.R. Parts 170 through 185.



North Carolina Intrastate Commerce

Effective December 1, 2012, your company (if applicable) will be required to obtain an Intrastate USDOT number and display the number on all your Commercial Motor Vehicles in accordance with 49CFR Part 390.21 followed by the letters "NC" as described in GS-20-101.

Intrastate commerce means Trade, Traffic or Transportation within the borders of North Carolina. Determination of whether a driver/vehicle is engaged in intrastate transportation is made through examination of the shipping papers, labels on the freight, the driver's record of duty status (log book - if applicable), and responses to the appropriate questions.

Example of Intrastate Transportation:

Cargo originates in NC and the destination is another location in NC. The shipment is picked up in Greenville and delivered to Charlotte.
