Message from Our President and Our Chair



For the last three years, the Chamber 2025 Strategic Plan has guided the biggest transformation in our organization's history — and these early months and years are only the beginning.

In 2023, we expanded our existing strengths in policy and advocacy by providing additional opportunities for our members to engage with government decision-makers and influence the policy that will steer Canada into the future. We established four new councils and delivered 10 Executive Summit events, each focused on a key economic sector and headlined by government and industry experts.

We also had the chance to go beyond Canada's borders. Accompanied by government representatives and business leaders, we travelled to India, Japan and the United States to meet with international partners on topics of global trade and investment.

Many of the wins we celebrated this year would not have been possible without the tireless commitment of the Canadian Chamber Network. The 400+ chambers and boards of trade we represent helped us press the government to end the strike at the West Coast ports. The government also announced a further year's extension to the CEBA loan repayment deadline thanks in part to the activation of 250 Network members and other partners.

However, as we reflect on the past year, it's important that we consider not only the successes, but also the challenges. Supply chain issues have eased since 2022 but remain elevated among the businesses affected; a rising share believe conditions will only get worse. Extreme weather events and labour disruptions have highlighted the vulnerability of our trade and transportation infrastructure. Across Canada, inflation, input costs and interest rates are top business concerns, and almost half of small businesses still make below normal pre-pandemic revenue. There is no denying that it has been a difficult year for Canadian businesses.

That's why the Canadian Chamber's work remains as critical as ever — and why we are committed in our mission to drive change, partner broadly and be the undisputed champion and catalyst for the future of business success.

Our members have an essential role to play in hastening green growth, ensuring the economic inheritance of the next generation and solidifying Canada's reputation as a reliable trading partner. It is our honour to represent their needs and work alongside them to create a strong economy and a better life for all Canadians.

On behalf of #TeamChamber and the Canadian Chamber Board, we want to express both our unwavering commitment and our heartfelt thanks to you for joining us on this transformational journey.

We look forward to working with you again in 2024.

Together with Statistics Canada, the Business Data Lab (BDL) has democratized business data in Canada. Through new offerings like the bilingual 🗨️ **Business Conditions Terminal**, tens of thousands of businesses of all sizes in all regions have access to a constant flow of local, future-focused and timely data, some of which has never been seen before:

- Business and management diversity
- Small business
- Environmental practices
- Interprovincial trade
- Supply chains
- Tech adoption, and more!

With over 2,300 indicators drawn from more than 30 different sources updated daily, our Terminal is always on.



Canada's business landscape is at a critical juncture, with the economy adjusting to higher interest rates and an economic slowdown or possible recession.

The Canadian Chamber of Commerce's collaborative initiative to harness existing data and build the Business Data Lab represents a good practice. Working with Statistics Canada and benefiting from federal funding, it brings together data from a variety of sources to track evolving market conditions.

This provides governments, business associations and entrepreneurs with critical information to help them make better decisions, improve their performance and capitalize on business growth opportunities.

The FBC's output is produced by external fellows selected for their expertise. In 2023, two research papers were completed and published — ☺ *Optimal Taxation, the Underground Economy and Government Policy: Recommendations for Tobacco, Vaping, Marijuana* and ☺ *Gaming and Canada and Global Energy Security: The Role of Natural Gas in a Lower Carbon Future*.

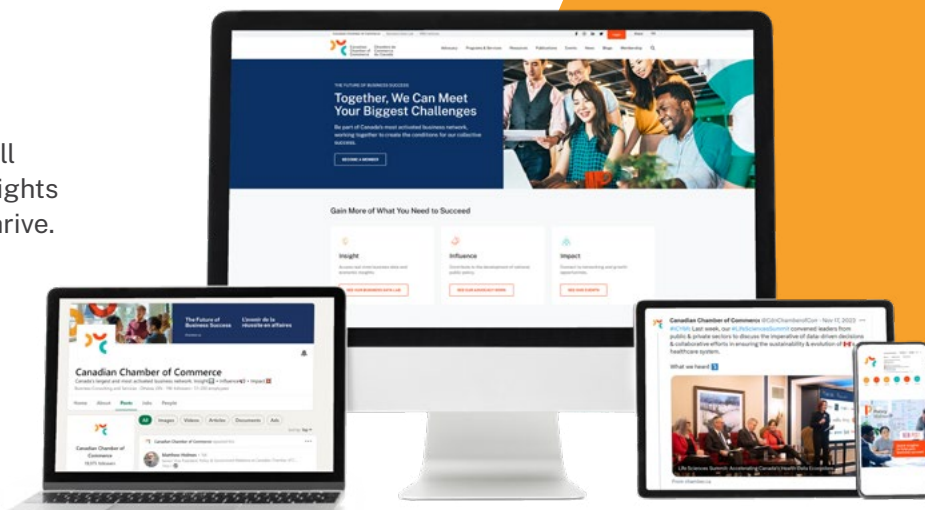

Our policy committees and sector-specific councils are comprised of members representing a diverse cross-section of organizations from across Canada. By adding their voices to the conversation on the challenges and opportunities facing businesses, members are contributing to the development of national public policy.

In 2023, guided by the emerging needs of Canada’s economy and business community, we added several new councils to our roster: the Green and Transition Finance Council, the Net-Zero Council, the Future of AI Council, and the Housing and Development Strategy Council.

We also renewed several councils established in 2022 due to their continued relevance and importance to Canadian businesses: the Western Executive Council, the Life Sciences Strategy Council, the Cyber. Right. Now. Council, and the Critical Minerals Council.

On July 10, we headed west to Calgary to participate in a full day of important meetings with our Western Executive Council and special guests, including the Right Honourable Stephen Harper.

After a day of thoughtful discussion, we grabbed our cowboy hats and moved to the Palomino Steakhouse for a lively reception in collaboration with Parkland Corporation.



We were honoured to have Prime Minister Justin Trudeau and senior government leaders join various council meetings this year, giving members an opportunity to have face-to-face discussions with policy and decision-makers on matters of critical importance.

Across various council meetings we welcomed President of the Treasury Board Anita Anand, Minister of Energy and Natural Resources Jonathan Wilkinson, Minister of Employment, Workforce Development and Official Languages Randy Boissonnault, Deputy Minister of Finance Chris Forbes, the Honourable Dan Vandal, the Honourable Gudie Hutchings, the Honourable Carla Qualtrough, Senator Colin Deacon,

Privacy Commissioner of Canada Philippe Dufresne, the Deputy and Associate Ministers of Innovation, Science and Economic Development Canada, Health Canada, NRCan, and Environment and Climate Change Canada, as well as many others we don't have the space to name!

In addition to our council meetings, members had other opportunities throughout 2023 to connect with Canada's policymakers — like our annual 🌱 **Hill Day**. Over two days, business leaders from various sectors came together to meet and engage with Parliamentarians and government officials to discuss the most pressing policy issues affecting Canadian businesses and the economy.



This year, we celebrated a number of policy wins for business that happened either as a direct result of our advocacy or as recent adoptions of our policy recommendations from pre-budget submissions and resolutions passed at previous AGMs.

- Budget 2023 included the announcement of a National Supply Chain Strategy — a longstanding priority of ours for investment and trade corridor infrastructure — as well as a one-year pause on the significant increase planned for the alcohol escalator tax.
- In May, a new Assistant Deputy Minister role responsible for life sciences was announced at ISSED — a top Life Sciences Council recommendation.
- Following a decade of advocacy and multiple resolutions from the Canadian Chamber Network, the Temporary Foreign Workers Program announced a three-year Recognized Employer Pilot to reduce administrative red tape for repeat employers who meet the highest standards of worker protections.
- Following our participation at the Council of the Federation's summer meeting, premiers ➡ **endorsed the principles** set out in the Canada Trade Infrastructure Plan proposed by a coalition of business organizations.

- Parliament's Finance Committee published its formal recommendations for Budget 2024, which included a number of the Cyber. Right. Now. Council's key asks, including the establishment of a Cabinet-level lead on cybersecurity and supporting a pipeline of cyber commercialization.
- Following resolution of the strike at the West Coast ports, the Minister of Labour and Seniors announced a review of the Canada Labour Code to examine how the government can expand its toolbox to prevent labour disruptions in the future.
- The Fall Economic Statement included two major items we had advocated for: a commitment to labour mobility and credential recognition, and commitments to expedite the rollout of Investment Tax Credits from Budget 2023.

Gateway to the World

In 2023, we assembled our first Gateway to the World (GTW) team, including a new Vice President, Strategic Policy and Global Partnerships, a Senior Director of International Commerce and a Director of International Policy.

The GTW team is developing a comprehensive strategy that will position the Canadian Chamber as the indispensable organization for Canadian companies of all sizes wanting to engage in international policy or global trade and investment. Several missions have already been conducted under the GTW banner:

- **India, August 25-27, 2023:** Our President and CEO, Perrin Beatty, travelled to New Delhi, India, for the B20 summit (the official G20 forum of the global business community), where he led a delegation of senior business leaders in partnership with Export Development Canada. The mission included engagements with Amitabh Kant, India's Sherpa to the G20, and Canada's Minister of Export Promotion, International Trade and Economic Development, Mary Ng.



- **Japan, November 1, 2023:** Alongside the Government of Canada's Team Canada Trade Mission, our representatives participated in the seventh Japan-Canada Chamber Council meeting, joining hundreds of Canadian and Japanese business leaders in Tokyo for deep and energized discussions on the future of the Canada-Japan relationship.

- **Washington, D.C., November 9-10, 2023:** The first of a series of missions to Washington, D.C., took place on the topic of critical minerals. The two-day event, held at the U.S. Chamber of Commerce and at the Canadian Embassy, included over 30 delegates and featured roundtable policy discussions and remarks from both American and Canadian government officials and industry leaders.

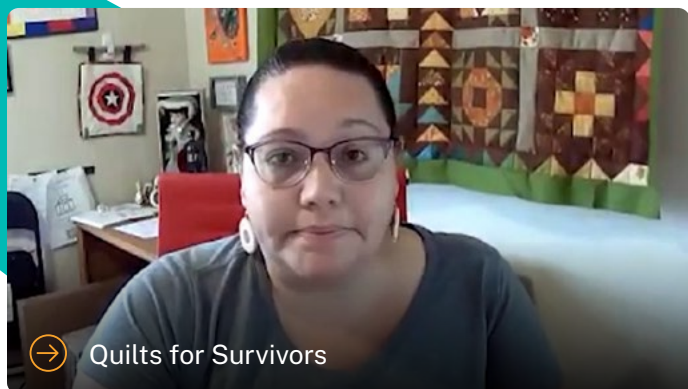

Business Services

Our programs and services are designed to help ease the burden of doing business. Whether you're looking to save money, get access to the data you need to make informed decisions or expand the reach of your business to stay competitive in today's global market, we'll be there for you.

ATA Carnet

We are the national guaranteeing organization for ATA Carnet. Accepted in over 80 countries, a Carnet permits the duty-free and tax-free importation of goods into foreign countries during its one-year validation period, simplifies customs procedures, reduces business costs, and saves time and paperwork.

In 2023, we launched a new publication for our clients called *The Export Report*. This monthly newsletter informs our clients and members of our activities that help foster trade and international collaboration.

Document Certification

We certify a variety of trade documentation for Canadian exporters; the most common being Certificates of Origin (COs). COs are often requested by customs administrations, importers, freight forwarders or banks for clearance of goods at customs and for international transactions. We now offer origin verification for shipments leveraging free-trade agreements.



Board of Directors

At our Special Meeting of Members held on June 28 for the purposes of advancing the Board's efforts on our governance model modernization, the membership unanimously approved the Articles of Amendment and the proposed changes to our by-laws.

This initiative responds to consistent feedback and requests from Board members over the years to put a more modern and efficient structure in place. The move to a pure governance Board model and the creation of two new advisory bodies — the Pan-Canadian Chamber Forum and the National Advisory Table on Business & the Economy — for network consultation and public policy issues will greatly enrich engagement with all stakeholders, allowing us to be more nimble in

delivering on strategic objectives and to maximize the value and participation of directors, corporate members and the Canadian Chamber Network.

We would like to thank our 2022-2023 Board for their time and dedication to strengthening the Canadian business community. We look forward to working with our 2023-2024 Board as we shape the future of business success.
