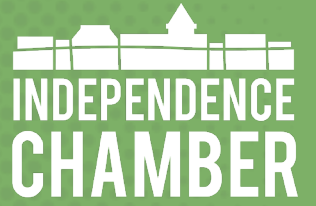

Chamber Members –

I hope this finds your business or organization thriving as we approach the spring and summer months. The Chamber is where business and economic development live in the City of Independence, and we look at a variety of issues that positively impact those things. As you likely know, the Chamber has endorsed and is championing the City of Independence General Obligation Bond Issues, which appear before Independence voters on Tuesday, April 8. Voters are asked to weigh in on three questions related to public safety facilities, community animal shelter, streets, bridges, curbs and sidewalks, parks, and historic sites.

Business and economic development can not move forward in this community without public safety, infrastructure, and quality of life. We strongly encourage you to vote yes on all three issues. We ask that you take these steps between now and April 8:

Member Spotlight

A Gift from England to Independence, Missouri...

Warm, witty, charm combined with a lovely British accent was my initial introduction to Mark Adams, the recently appointed Director of the Harry S. Truman Library and Museum. Mark, appointed as Director in January 2025, brings a plethora of educational and work experiences to his new role.

Mark was born in Liverpool England to parents, Henry and Muriel. Henry worked in the building trades and then began teaching his trade to students. Muriel was a homemaker who managed the family of five children, four brothers and one sister, with Mark as the middle sibling. His parents, who were both born in 1929, learned many life lessons in difficult circumstances, having been evacuated during the bombings of England during World War II. Mark's parents, who survived great hardships in their early years, focused on creating a warm, close-knit family, while supporting each of them in the careers they chose.

With a BA in History and Geography, from the University of Wolverhampton, which was near Birmingham, England, as well as a Post graduate degree in History and Secondary Education at the University of Liverpool, Mark began teaching Secondary History in England. Mark was visiting relatives in Topeka, Kansas, when he met his wife and they had children. After the state of Kansas required Mark to return to college, to obtain additional degrees to teach in their state, Mark looked elsewhere to find employment. He was hired at the Kansas Museum of History, which governed fifteen historic sites in the state. In 1997, Mark became the Education Coordinator for The Truman Library and Museum and was the first trained and experienced Educator to be on the staff at the library, where he began implementing programs structured around the themes of the life of President Truman.

One significant and important fact I discovered was regarding the Independence School District and the Harry S Truman Library and Museum partnership created for the Second, Third and Fifth grades at all Independence Elementary Schools. The Second grade studies about Trumans character, his family, his jobs and his neighborhood. Going deeper into Trumans character qualities, sometimes using the letters Truman wrote to his wife, Bess, third graders discover more in-depth conclusions about his examples of communication and Leadership. Finally, in the Fifth grade, the students study the themes of war and conflict, focusing on World War II, the Korean War, the Cold War, as well as information on spies and espionage matters. How exciting it is for our students to access authentic information about their country!

Mark also wanted to pull people together, to brainstorm, to get out of silo thinking, to obtain a wide variety of abilities, socioeconomic positions, diverse ethnicities and cultures to bring every point of view to the exhibits...allowing all to grasp the complexities comprising each scenario. Mark, in recognizing the attributes of President Truman, finds him to have great character, unwavering honesty, serving as a role model for other leaders.

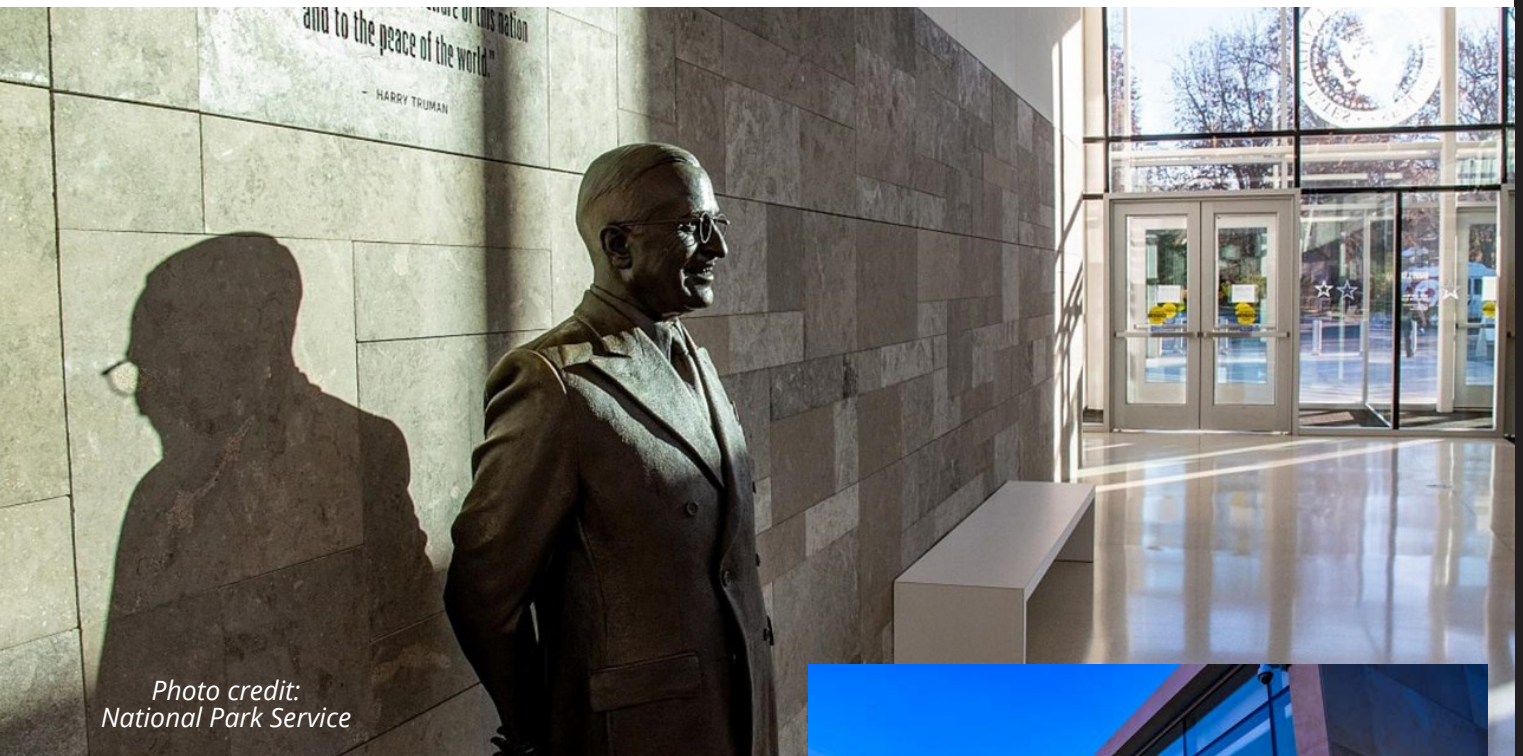

Mark is married to Lucinda, who works in the Kansas museum system. Lucinda is the Executive Director of Freedoms Frontier National Heritage Area, based in Lawrence, KS. Mark has three daughters. He will be testing for his First Degree Black Belt in Tae Kwon Do, in May. Mark's hopes, as Director, to see the Truman Library further elevated and connected to our city and the broader community of greater Kansas City. He also wants our area and visitors, to recognize the legacy of Truman's ideas, such as the Marshall Plan and the Truman Doctrine, still in place today. What a gift Mark, you are to our community!
