General Agreement Terms:

1. **COPYRIGHTS & TRADEMARKS.** Sponsor acknowledges that HBA owns the trademarks, service marks, and its events, and related rights to the names and logos associated with the Home Building Association of Greater Portland and agrees not to use them except as expressly authorized in this agreement in conjunction with the Block Party event.
2. **FORCE MAJEURE.** Neither party shall be held responsible for delay nor default caused by fire, riot, acts of God, war or terrorism where such cause prevents the event from being conducted as scheduled and was beyond the reasonable control of either party. Upon the occurrence of such an event, the parties agree to re-negotiate, in good faith, the terms of this agreement.
3. **ASSIGNMENTS & AMENDMENTS.** This agreement shall not be assigned or transferred by either party without the prior written consent of the other party. This agreement shall not be amended unless such amendment is in writing and signed by both parties.
4. **ARBITRATION.** Any controversy or claim arising out of, or relating to, this Agreement, or the making, performance, or interpretation of this Agreement, shall be settled by arbitration in Portland, Oregon, in accordance with the provisions of ORS 33.210 to 33.250, and judgment on the arbitration award may be entered in any court having jurisdiction over the subject matter of the controversy.
