- **Simple reimbursement** — we cover and pay as Original Medicare, using Medicare's claim submission requirements, benefit/medical policies and payment schedules.
- **No contract required** to see patients or bill/receive payment from the MSA.
- **No credentialing** hassles.

See MSA Patients

Prior authorizations, referrals, admission notices and non-coverage notices are not required unless Original Medicare would require them. Submit documentation to us via the methods listed on the reverse. Provide non-coverage notice to the patient and include the modifier on the claim.

Prepare & Submit MSA Claims

- ✓ **Prepare the claim the same as if you were submitting it to Original Medicare** — we follow Medicare's medical policies, claim submission requirements and payment methodologies.
- ✓ **Include medical records or other supporting documentation** if you would include it for an Original Medicare claim.
- ✓ **Send us your rate letter(s) so we can reprice the claim correctly** if your practice/facility has special rates established with your MAC.
- ✓ **Clearinghouse submission preferred** — if not submitting through a clearinghouse, please ensure the information is properly aligned and legible within the claim form.
- ✓ **Submit MSA claims to Fenyx Health** — do not submit to Original Medicare.
- ✓ **Contact us if the MSA is presented as a secondary or tertiary payer** — by regulation, MSAs cannot be paired with other major medical coverage.

Get Paid

- **95% of clean claims paid within 30 days.**
- **MSAs pay the lesser of billed charges or Medicare-allowed amount.**
- **We return the full Medicare-allowed amount for Medicare-covered services... regardless of deductible status** — you are paid in full and do not need to bill the patient.
- **Medicare-par providers** receive 100% of the allowed amount, minus sequestration. By billing the plan, you accept Medicare's rates and cannot balance bill the patient.
- **Medicare non-par providers** receive 95% of the allowed amount, minus sequestration. Balance billing up to the limiting charge where allowed by state law is permitted.
- **Reimbursement for Medicare-covered services/items not on a fee schedule** follows your MAC's pricing methodology.
