Development in Pearland

The Pearland Economic Development Corporation's Annual Report was released in March. The report recaps the development and progress of the PEDC this last year. Construction has begun on a new trail in Lower Kirby that will run along the western bank of a detention corridor starting at Endress+Hauser's facility on Beltway 8 to the pedestrian bridge at Clear Creek. The approximately 1.25 mile-long trail will include two shade structures, concrete bench seating for rest areas, and landscaping at the focused shade areas.

The January 2023 Houston Area Employment Situation that was released by Workforce Solutions – Gulf Coast shows Pearland still one the lowest unemployment percentage in the region

(4.0% up from the last month). Brazoria County's unemployment rate is 4.8%. The entire region saw an increase of .7% increase from previous months.

The City of Pearland receives updates on sales tax collection from the state. Sales Tax collections is a great tool to evaluate the local economy. The report is always from two months prior, so in February, the City receives December numbers (holiday shopping. The total net collections increased compared to previous year by \$302,740 or 10.2% and 4.8% over the city's amended budget.
