

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics

(BLS) indicate nonfarm employment in Washington rose by 2,300 in August 2019. BLS estimates the private sector gained 2,800 jobs during the month and the public sector lost 500 jobs.

On a not seasonally adjusted basis, estimates for August 2018 through August 2019 indicate an increase in employment of 65,200 for the state. The private sector added 61,800 jobs

while the public sector gained an estimated 3,400 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for August 2019 is 4.6 percent. The revised estimated July 2019 unemployment rate is at 4.6 percent. The August 2018 unemployment rate was 4.4 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. July's preliminary estimated gain of 13,400 jobs was revised to a gain of 5,900 jobs.

## **Whatcom County**

### **Local Area Unemployment Statistics**

The unemployment rate in Whatcom County was 5.6 percent in August 2019 (preliminary), up from 5.3 percent reported in July (revised). The unemployment rate in August 2018 was 4.5 percent.

- Compared to 12 months ago, the number of people counted as 'employed' increased by 4,364 and the number of people counted as 'unemployed' or actively seeking work increased by 1,468, nudging the unemployment rate up over the year. The labor force increased by 5.3 percent. Whatcom County's labor force was estimated at 116,109 in August 2019.
- Initial claims for unemployment benefits in Whatcom County decreased from 710 in July to 668. Altogether, 1,502 Whatcom County residents collected unemployment insurance benefits in August; down from 1,552 in July.

Total nonfarm payroll in Whatcom County decreased by 1,500 from July to August 2019. Year-over-year, the tally of nonfarm jobs was down 300 or 0.3 percent.

- In August, private sector employers collectively neither expanded nor contracted. The large one-month losses were a result of summer vacation for state and local education institutions.
- Over the year, two major industries detailed in this report added jobs; trade, transportation, warehousing (except retail trade) and utilities and professional and business services each

added 100 jobs. Government, construction, financial activities and leisure and hospitality each shed jobs.

# **Skagit County**

### **Local Area Unemployment Statistics**

The unemployment rate in Skagit County was 5.8 percent in August 2019 (preliminary), up from 5.7 percent in July (revised). The unemployment rate 12 months ago was 4.8 percent.

- Compared to August 2018, the number of people counted as 'employed' increased by 2,155 and the number of people counted as 'unemployed' increased by 900. Skagit County's labor force was estimated at 63,554, increasing by 5.0 percent over the year.
- Initial claims for unemployment benefits in Skagit County decreased from 487 in July to 436 in August. Altogether, 966 Skagit County residents received unemployment insurance benefits in August; down from 1,009 in July.

Total nonfarm employment in Skagit County dropped by 900 from July to August 2019. Year-over-year, the tally of nonfarm jobs expanded by 800 or 1.5 percent.

• Over the month, trade, transportation, warehousing and utilities expanded by 100. The expansion was attributable to hiring in retail. Government shed 700 jobs and manufacturing shed 200.

• The only major industry sector adding jobs over the year was construction (+700). Manufacturing, trade, transportation, warehousing and utilities (including retail trade), and leisure and hospitality each shed jobs over the year.

# **Island County**

### **Local Area Unemployment Statistics**

The unemployment rate in Island County was 5.8 percent (preliminary) in August 2019. This is up from 5.7 percent in July (revised). The unemployment rate 12 months ago was 4.9 percent.

- Compared to August 2018, the number of people counted as 'employed' increased by 857 and the number of people counted as 'unemployed' or actively seeking work increased by 389, pushing the unemployment rate up over the year. Island County's civilian labor force was estimated as 35,602, an increase of 3.6 percent over the year.
- There were 144 initial claims for unemployment benefits in Island County in August, down from 174 in July. Altogether, 366 Island County residents collected unemployment insurance benefits in August. This is down from 372 in July.

Total nonfarm payroll jobs in Island County contracted by 50 from July to August 2019. Year-over-year, the tally of nonfarm jobs was unchanged.

- From July to August, five industries expanded and one contracted. The largest increases were attributable to hiring by businesses in leisure and hospitality (+80). One-month government losses were likely related to the annual rhythm of the school year.
- Year-over-year, 3 major industries added jobs and 5 shed jobs. The largest gains were attributable to hiring in the education and health services sector (+190) and the deepest losses were observed in leisure and hospitality (-120).

Note that employment statistics for Island County do not include military employment.

## **San Juan County**

### **Local Area Unemployment Statistics**

The unemployment rate in San Juan County decreased from 3.8 percent in July (revised) to 3.6 percent (preliminary) in August. The unemployment rate 12 months ago was 3.0 percent.

- Compared to August 2018, the number of people counted as 'employed' decreased by 180 and the number counted as 'unemployed' or actively seeking work increased by 54. Altogether, the San Juan County labor force consisted of an estimated 8,916 workers and diminished by 1.4 percent over the year.
- Initial claims for unemployment benefits in San Juan County totaled 14 in August, up from 13 initial claims filed in July. Altogether, 26 San Juan County residents received unemployment insurance benefits in August. This is down from 28 in July.

Net nonfarm payroll in San Juan County increased by 170 from July to August. Year-over-year, total nonfarm employment was down 400 jobs or 5.9 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. In August, the largest one-month gains were reported from leisure and hospitality and trade, transportation, warehousing and utilities (+50 each).
- Over the year, there was a net loss of employment. The largest one-year gains were attributable to hiring in education and health services (+40) and the deepest losses came from trade, transportation, warehousing and utilities.
