

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 10,900 in December 2019.¹ BLS estimates the private sector gained 9,800 jobs during the month and the public sector gained 1,100 jobs.

On a not seasonally adjusted basis, estimates for December 2018 through December 2019 indicate an increase in employment of 77,800



for the state. The private sector added 74,000 jobs while the public sector gained an estimated 3,800 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for December 2019 is 4.3 percent. The revised estimated November 2019 unemployment rate is at 4.4 percent. The December 2018 unemployment rate was 4.5 percent.

December 2019 County unemployment rates, not seasonally adjusted

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County was 4.8 percent in December 2019 (preliminary), down slightly from 4.9 percent reported in November (revised). The unemployment rate in December 2018 was 5.1 percent.

- Compared to 12 months ago, the number of people counted as 'employed' increased by 4,802 and the number of people counted as 'unemployed' or actively seeking work decreased by 131, nudging the unemployment rate down over the year. The labor force increased by 4.1 percent. Whatcom County's labor force was estimated at 119,412 in December 2019.
- Initial claims for unemployment benefits in Whatcom County increased from 836 in November to 1,227. Altogether, 2,074 Whatcom County residents collected unemployment insurance benefits in December; up from 1,592 in November.

Data benchmarked through September 2019

Total nonfarm payroll in Whatcom County (not seasonally adjusted) decreased by 800 from November to December 2019. Year-over-year, the tally of nonfarm jobs was unchanged.

- In December, net employment declined; the only two industries adding jobs were trade, transportation, warehousing and utilities (+200) and leisure and hospitality (+100). The deepest one-month losses were observed in government (-500) and construction (-200).
- Over the year, the largest increases detailed in this report were observed in government (+400) and professional and business services and financial activities (+200 each); the deepest losses came from construction (-800).

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County was 5.4 percent in December 2019 (preliminary), down slightly from 5.5 percent in November (revised). The unemployment rate 12 months ago was 5.6 percent.

- Compared to December 2018, the number of people counted as 'employed' increased by 2,471 and the number of people counted as 'unemployed' increased by 7. Skagit County's resident labor force was estimated at 64,106, increasing by 4.0 percent over the year.
- Initial claims for unemployment benefits in Skagit County increased from 623 in November to 848 in December. Altogether, 1,427 Skagit County residents received unemployment insurance benefits in December; up from 1,090 in November.

Year-over-year, the tally of nonfarm jobs expanded by 700 or 1.4 percent.

- Over the month, private industry shed an estimated 100 jobs in aggregate. The largest gains were observed in trade, transportation, warehousing and utilities (+200); within this, retail trade accounted for half of the new jobs. Construction and government each shed jobs.
- Over the year, four major industries detailed in this report added jobs; the largest net increase was observed in trade, transportation, warehousing and utilities (+600). Manufacturing shed 400 jobs over the year.

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County was 4.7 percent (preliminary) in December 2019. This is down from 5.0 percent reported in November (revised). The unemployment rate 12 months ago was 5.5 percent.

- Compared to December 2018, the number of people counted as 'employed' increased by 1,626 and the number of people counted as 'unemployed' or actively seeking work decreased by 216. Island County's civilian labor force was estimated as 36,997, an increase of 4.0 percent over the year.
- There were 202 initial claims for unemployment benefits in Island County in December, up from 197 in November. Altogether, 446 Island County residents collected unemployment insurance benefits in December. This is up from 365 in November.

Data benchmarked through June 2019

Total nonfarm payroll jobs in Island County expanded by 120 from November to December 2019 on a not seasonally adjusted basis. Year-over-year, the tally of nonfarm jobs expanded by 320.

- From November to December, most major industries detailed in this report expanded and two contracted. The largest increases were attributable to hiring by businesses in leisure and hospitality (+90). The deepest losses were in observed in government.
- Year-over-year, all major industries added jobs. The largest gains were attributable to hiring by employers in professional and business services (+130).

Note that employment statistics for Island County do not include military employment.

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County decreased from 4.0 percent in November (revised) to 3.7 percent in December (preliminary). The unemployment rate 12 months ago was 4.5 percent.

• Compared to December 2018, the number of people counted as 'employed' increased by 417 and the number counted as 'unemployed' or actively seeking work decreased by 47.

Altogether, the San Juan County labor force consisted of an estimated 8,288 resident workers and expanded by 4.7 percent over the year.

• Initial claims for unemployment benefits in San Juan County totaled 75 in December, up from 36 initial claims filed in November. Altogether, 87 San Juan County residents received unemployment insurance benefits in December. This is up from 61 in November.

Net nonfarm payroll in San Juan County neither increased nor decreased over the month. Year-over-year, total nonfarm employment was up 40 or 0.7 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. In December, the largest increases were observed in trade, transportation and utilities (+70). The deepest one-month losses were observed in the county's largest sector; leisure and hospitality (-90).
- Over the year, there was a net loss of employment, with a mix of gains and losses by industry. The largest one-year gains were observed in trade, transportation, and utilities (+80) and the deepest losses came from leisure and hospitality (-200).

Forecast information for Washington state:
