

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 6,000 in June 2019 BLS estimates the private sector gained 5,400 jobs during the month and the public sector gained 600 jobs.

On a not seasonally adjusted basis, estimates for June 2018 through June 2019 indicate an increase in employment of 82,700 for the state. The private sector added 82,600 jobs while the public sector gained an estimated 100 jobs over the year.





Washington's preliminary seasonally adjusted unemployment rate for June 2019 is 4.6 percent. The revised estimated May 2019 unemployment rate is at 4.6 percent. The June 2018 unemployment rate was 4.4 percent. BLS estimates of monthly job gains and losses are based on a survey of businesses.

Preliminary estimates are subject to revision. May's preliminary estimated gain of 9,600 jobs was revised to a gain of 7,600 jobs.

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County was 5.4 percent in June 2019 (preliminary), up from 4.6 percent reported in May (revised). The unemployment rate in June 2018 was 4.6 percent.

- Compared to 12 months ago, the number of people counted as 'employed' increased by 2,405 and the number of people counted as 'unemployed' or actively seeking work increased by 1,111, nudging the unemployment rate up over the year. The labor force increased by 3.1 percent. Whatcom County's labor force was estimated at 115,243 in June 2019.
- Initial claims for unemployment benefits in Whatcom County decreased from 826 in May to 705. Altogether, 1,587 Whatcom County residents collected unemployment insurance benefits in June; up from 1,403 in May.

Total nonfarm payroll in Whatcom County decreased by 300 from May to June 2019. Year-overyear, the tally of nonfarm jobs was up 900 or 0.9 percent.

• In June, private sector employers were responsible for 200 new jobs. The largest one month gains were attributable to hiring in leisure and hospitality (+300) and retail trade, within trade, transportation, warehousing and utilities (+200). Government and construction employment each dropped by 500 over the month.

The largest gains were observed in trade, transportation, warehousing and utilities (+400). Government, construction and financial activities each shed jobs over the year.

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County was 5.8 percent in June 2019 (preliminary), up from 5.2 percent in May (revised). The unemployment rate 12 months ago was 4.9 percent.

- Compared to June 2018, the number of people counted as 'employed' increased by 1,395 and the number of people counted as 'unemployed' increased by 672. Skagit County's labor force was estimated at 62,589, increasing by 3.4 percent over the year.
- Initial claims for unemployment benefits in Skagit County decreased from 590 in May to 422 in June. Altogether, 1,077 Skagit County residents received unemployment insurance benefits in June; up from 1,011 in May.

Data benchmarked through December 2018

In June 2019, Skagit County nonfarm payrolls increased by 900. Year-over-year, the tally of nonfarm jobs expanded by 1,200 or 2.3 percent.

• Over the month, most industries expanded and none declined. The largest one-month increase was attributable to hiring in manufacturing.

The industries reporting the largest gains were construction (+400) and government (+200). Trade, transportation, warehousing and utilities (including retail) reported the largest 12-month losses (-200).

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County was 5.7 percent (preliminary) in June 2019. This is up from 4.9 percent in May (revised). The unemployment rate 12 months ago was 5.1 percent.

- Compared to June 2018, the number of people counted as 'employed' increased by 243 and the number of people counted as 'unemployed' or actively seeking work increased by 244. Island County's civilian labor force was estimated as 34,873, an increase of 1.4 percent over the year.
- There were 193 initial claims for unemployment benefits in Island County in June, up from 152 in May. Altogether, 392 Island County residents collected unemployment insurance benefits in June. This is up barely from 391 in May.

Total nonfarm payroll jobs in Island County expanded by 150 from May to June 2019. Year-overyear, the tally of nonfarm jobs contracted by 170 or 1.0 percent.

- From May to June, most industries reported modest employment gains. The largest one month gains were attributable to hiring in construction (+20).
- Year-over-year, more industries shed jobs than added them. The deepest losses were observed in the education and health services industries (-120). Leisure and hospitality posted the largest year-over-year gains (+60).

It is important to note that employment statistics for Island County do not include military employment.

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County increased from 3.6 percent in May (revised) to 3.8 percent (preliminary) in June. The unemployment rate 12 months ago was 3.4 percent.

- Compared to June 2018, the number of people counted as 'employed' increased by 242 and the number counted as 'unemployed' or actively seeking work increased by 43. Altogether, the San Juan County labor force consisted of an estimated 8,904 workers and increased by 3.3 percent over the year.
- Initial claims for unemployment benefits in San Juan County totaled 9 in June. There were also 9 initial claims filed in May. Altogether, 38 San Juan County residents received unemployment insurance benefits in June. This is down from 48 in May.

Northwest Washington labor market review for June 2019 Report available at http://nwboard.org/impact/laborareasummaries.html Net nonfarm payroll in San Juan County increased by 460 from May to June. Year-over-year, total nonfarm employment was up 140 jobs or 2.2 percent.

- San Juan County has a highly-seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. In June, the largest one-month gains were reported from leisure and hospitality (+320).
- Over the year, there was a net gain of employment. The largest one-year gains were attributable to hiring in leisure and hospitality (+80). Construction and education and health services also made a strong showing, each increasing over the year employment by 50. The only two industries reporting 12-month losses were information and financial activities and government (-40 each).
