
For all intents and purposes, this is the third report to record the effects of the Covid-19 economic situation in Northwest Washington.

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 71,000 in June 2020. BLS estimates the private sector gained 71,700 jobs during the month and the public sector lost 700 jobs.

312,400 for the state. The private sector lost 265,700 jobs while the public sector lost an estimated 46,700 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for June 2020 is 9.8 percent. The revised estimated May 2020 unemployment rate is at 15.1 percent. The June 2019 unemployment

rate was 4.3 percent.

The unemployment rate for the Northwest Workforce Development Area jumped to 17.8 percent in April. In June, the four-county area had an unemployment rate of 10.5 percent.

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County was 10.5 percent in June 2020 (preliminary), down from a record-breaking 17.7 percent reported in April 2020 and 15.6 in May (revised). The unemployment rate in June 2019 was 5.1 percent.

• Compared to 12 months ago, the number of people counted as 'employed' decreased by 6,312 and the number of people counted as 'unemployed' or actively seeking work increased by 6,276. The labor force as a whole remained virtually unchanged. Whatcom County's labor force was estimated at 115,432 in June 2020.

Total nonfarm payroll in Whatcom County (not seasonally adjusted) increased by 2,300 from May to June 2020. Year-over-year, the tally of nonfarm jobs decreased by 8,200 (8.4 percent).

- In June, net employment expanded, with most major industries reporting increases. The largest increases were observed in trade, transportation, warehousing and utilities specifically within retail trade (up 1,600). Government employment dropped in June.
- All major industries detailed in this report shed jobs over the year. The largest decreases came from leisure and hospitality (down 4,500) and government (down 2,800).

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County was 11.3 percent in June 2020 (preliminary); this is down over the month, following a record-setting high unemployment rate of 19.1 percent in April and 16.5 percent in May. The unemployment rate 12 months ago was 5.5 percent.

• Compared to June 2019, the number of people counted as 'employed' dropped by 4,429 and the number of people counted as 'unemployed' expanded by 3,618. Skagit County's resident labor force was estimated at 62,710 decreasing by 1.3 percent over the year.

Total nonfarm employment in Skagit County increased by 2,000 from May to June 2020. Year-over-year, the tally of nonfarm jobs contracted by 6,000 or 11.3 percent.

- Over the month, all major industries in this report added jobs. The industry that added the most jobs was trade, transportation, warehousing and utilities, with job gains observed within retail trade (up 1,300).
- Covid-19 related losses reverberated throughout the economy, showing up in the year over year estimates for all industries. The deepest losses were observed in leisure and hospitality (down 2,500). Retail trade, a subset of trade, transportation, warehousing and utilities was up over the year.

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County was 9.2 percent (preliminary) in May 2020. This is down from 15.8 percent reported in April and 13.7 percent reported in May (revised). The unemployment rate 12 months ago was 5.2 percent.

• Compared to June 2019, the number of people counted as 'employed' decreased by 2,605 and the number of people counted as 'unemployed' or actively seeking work expanded by 1,307. Island County's civilian labor force was estimated as 34,667 in June 2020.

Total nonfarm payroll jobs in Island County expanded by 80 from May to June 2020. Year-over-year, the tally of nonfarm jobs plunged by 1,810 or 10.3 percent.

- From May to June, most industries expanded employment. The largest increases were attributable to trade, transportation and utilities (up 60), with most job gains recorded in retail trade. Government shed 100 jobs over the month.
- Year-over-year, the deepest losses were observed in leisure and hospitality (down 890) and construction (down 580). Education and health services and manufacturing are the only two industries that expanded employment over the year.

Note that employment statistics for Island County do not include military employment.

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County decreased from 17.8 percent in April (revised) to 16.1 percent in May and 10.0 percent in June (preliminary). The unemployment rate 12 months ago was 3.5 percent.

• Compared to June 2019, the number of people counted as 'employed' decreased by 2,051 and the number counted as 'unemployed' or actively seeking work increased by 436. Altogether, the San Juan County labor force consisted of an estimated 7,573 resident workers and contracted by 17.6 percent over the year.

Net nonfarm payroll in San Juan County expanded over the month (up 130), but not the usual summer employment gains San Juan businesses are accustomed to. Year-over-year, total nonfarm employment was down 1,850 or 28.4 percent.

- San Juan County has a highly seasonal economy, due to its orientation toward tourism. Most industries shed jobs in the winter and return with the sun. There was little movement over the month, but there were some gains in June. Leisure and hospitality added 70 the largest increase of any sector this month. Given the timing of Covid-19, the tourism-reliant San Juan Islands are likely facing a difficult summer ahead.
- Over the year, there was a net employment loss, with all industries reporting 12-month losses. The largest one-year losses were observed in leisure and hospitality (down 1,340or 70.9 percent).

Weekly Unemployment Insurance Claims information:

In March, the Employment Security Department began publishing weekly counts of initial claims for Unemployment Insurance. Initial claims provide an indicator of layoffs. Because they are entered weekly, they are a bit more nimble than our survey-based datasets.
