

This report marks the tenth report whereby the year-over-year narrative shifts from pandemic-related losses to recovery since the start of the economic crisis. Pandemic-related employment effects began to show up in March last year, and swiftly led to unprecedented levels of unemployment in April 2020. Many jobs have recovered in the meantime, with significant variation by location and industry. This report tracks a moment in that recovery.

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 5,700 in January 2022. BLS estimates the private sector gained 4,500 jobs during the month and the public sector gained 1,200 jobs.

On a not seasonally adjusted basis, estimates for January 2021 through January 2022 indicate an increase in employment of 186,700 for the state. The private sector gained 164,200 jobs while the public sector gained an estimated 22,500 jobs over the year.



Washington's preliminary seasonally adjusted unemployment rate for January 2022 is 4.4 percent. The revised estimated December 2021 unemployment rate is at 4.5 percent. The January 2021 unemployment rate was 6.0 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. The December 2021 preliminary estimated gain of 14,000 jobs was revised to a gain of 13,600 jobs.

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County was 5.6 percent in January 2022 (preliminary), up from 4.4 percent in December 2021 (revised). For comparison, the unemployment rate 12 months ago was 7.9 percent.

• Compared to January 2021, the labor force expanded by 5,684 workers. Within that estimate, the number of employed workers expanded by 7,869 (7.6 percent) and the number of unemployed workers contracted by 2,185 (24.7 percent). Whatcom County's estimated labor force was 117,832 in January 2022.

Total nonfarm payroll in Whatcom County (not seasonally adjusted) decreased by 600 from December 2021 to January 2022. Over the year, nonfarm employment increased by 6,900 (8.0 percent).

- In January, employment decreased in seasonally-sensitive sectors including retail, construction and leisure and hospitality. Trade transportation warehousing and utilities and government were both up over the month.
- Most sectors added jobs over the year. Leisure and hospitality and government added the largest number of jobs over the year (+3,200 and 1,600 jobs respectively). Employment in construction remained unchanged over the year.

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County was 6.4 percent (preliminary) in January 2022—up from 4.8 percent (revised) in December. The unemployment rate 12 months ago was 8.2 percent.

• Compared to January 2021, the number of people counted as 'employed' increased by 3,323 and the number of people counted as 'unemployed' contracted by 952, bringing the unemployment rate down. Skagit County's resident labor force was estimated at 63,259, increasing by 3.9 percent over the year.

Total nonfarm employment in Skagit County decreased by 700 jobs over the month. Year-over-year, the tally of nonfarm jobs expanded by 3,100 or 6.7 percent.

- Over the month, all major sectors detailed in this report either shed jobs or remained unchanged. The deepest losses were attributable to the seasonal rhythm of holiday hiring and subsequent layoffs.
- Most major industry sectors recovered jobs over the year. The largest 12-month increases
 detailed in this report were attributable to leisure and hospitality (+1,300) and government.
 Increases in government employment were largely attributable to local hiring by public
 school districts.

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County was 5.2 percent (preliminary) in January 2022, above the (revised) unemployment rate (4.0 percent) reported in December 2021. The unemployment rate 12 months ago was 6.9 percent.

• Compared to January 2021, the number of people counted as 'employed' increased by 2,413 (7.1 percent) and the number of people counted as 'unemployed' or actively seeking work contracted by 525 (20.8 percent). Island County's civilian labor force was estimated as 38,183 in January 2022, up 5.2 percent over the year.

Total nonfarm payroll jobs in Island County dipped by 20 from December 2021 to January 2022. Year-over-year, the tally of nonfarm jobs expanded by 1,360 or 8.4 percent.

- From December to January, most industry sectors detailed in this report either expanded or maintained employment levels. The largest increases were attributable to leisure and hospitality and construction. Government and education and health services each shed jobs.
- Year-over-year, the largest employment gains were attributable to leisure and hospitality (+940). Construction and public education also saw large employment increases.
 Manufacturing and education and health services each shed jobs over the year.

Employment statistics for Island County do not include military employment.

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County was 4.9 percent in January 2022 (preliminary), up from 3.6 percent (revised) over the month. For comparison, the unemployment rate 12 months ago was 7.5 percent.

Compared to January 2021, the number of residents counted as 'employed' increased by 947 and the number counted as 'unemployed' or actively seeking work decreased by 173
 Altogether, the San Juan County labor force consisted of an estimated 8,739 resident workers and expanded by 9.7 percent over the year.

Net nonfarm payroll in San Juan County contracted by 10 over the month. Year-over-year, total nonfarm employment was up 790 or 16.6 percent. Employment in San Juan County is highly seasonal. Compared against January 2020 (pre-pandemic), total nonfarm employment appears to have recovered, albeit with losses in some key sectors such as leisure and hospitality.

- From December 2021 to January 2022, most industries detailed in this report expanded or maintained employment. Only leisure and hospitality and government shed jobs over the month. The largest one-month expansion was trade transportation and utilities.
- Over the year, the employment situation in San Juan County is showing substantial improvements in general. All but one industry sector detailed in this report expanded employment over the year, with the largest employment gains attributable to trade, transportation and utilities (+230). Education and health services was the only sector that was down over the year.

Forecast information for Washington state:

The Washington State Economic and Revenue Forecast Council (ERFC) issues quarterly forecasts that address Washington's projected economic health. The February forecast by Washington's Economic and Revenue Forecast Council estimates that the statewide unemployment rate averaged 6.7 percent in 2021. The unemployment rate is expected to average about 4.5 percent in 2022, (down from the November forecast) and drop to 4.0 percent in 2023. Employment is expected to recover to pre-recession levels in 2022. See www.erfc.wa.gov for more information.
