This report marks the seventeenth report whereby the year-over-year narrative shifts from pandemic-related losses to recovery since the start of the economic crisis. Pandemic-related employment effects began to show up in March 2020, and swiftly led to unprecedented levels of unemployment in April 2020. Many jobs have recovered in the meantime, with significant variation by location and industry. This report describes a moment in that recovery.

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 16,100 in August 2022.1 BBLS estimates the private sector gained 9,400 jobs during the month and the public sector gained 6,700 jobs.

On a not seasonally adjusted basis, estimates for August 2021 through August 2022 indicate an increase in employment of 161,600 for the state. The

private sector gained 158,900 jobs while the public sector gained an estimated 2,700 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for August 2022 is 3.7 percent. The revised estimated July 2022 unemployment rate is at 3.7 percent. The August 2021

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. The July 2022 preliminary estimated gain of 6,600 jobs was revised to a gain of 10,200 jobs.

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County was 4.8 percent in August 2022 (preliminary), above 3.9 percent reported in July (revised). For comparison, the unemployment rate 12 months ago was 6.1 percent. The unemployment rate in Whatcom County reached 17.4 percent in April 2020.

• Compared to August 2021, the labor force expanded by 2,042 workers (1.8 percent). Within that estimate, the number of employed workers expanded by 3,496 and the number of unemployed workers contracted by 1,454. Whatcom County's estimated labor force was 115,561 in August 2022.

Total nonfarm payroll in Whatcom County (not seasonally adjusted) decreased by 1,400 from July to August 2022. Over the year, nonfarm employment increased by 3,600 (4.0 percent).

- In August, the largest employment gains were observed in trade, transportation, warehousing and utilities (+200), with gains concentrated in retail trade. The deepest losses were observed in government (-1,300).
- Employment in most major sectors included in this report expanded employment over the year, with the largest increases attributable to manufacturing and leisure and hospitality (700 each). Government employment dropped over the year.

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County was 4.9 percent (preliminary) in August 2022—up over the month from 4.2 percent (revised). The unemployment rate 12 months ago was 6.2 percent. The unemployment rate in April 2020 reached a record 18.8 percent.

• Compared to August 2021, the labor force expanded by 607 (1.0 percent). Within that, the number of people counted as 'employed' increased by 1,415 and the number of people counted as 'unemployed' contracted by 808, bringing the unemployment rate down. Skagit County's resident labor force was estimated at 63,301 in August.

Total nonfarm employment in Skagit County decreased by 100 jobs over the month. Year-over-year, the tally of nonfarm jobs expanded by 600 or 1.2 percent.

- One-month employment gains were observed in trade, transportation and utilities (+200). All other sectors captured in this report remained unchanged or shed jobs over the month. The deepest losses were attributable to government (-500).
- Over the year, government, trade, transportation, warehousing, and utilities (including retail trade) and construction shed jobs. Manufacturing employment expanded and leisure and hospitality remained unchanged.

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County was 4.7 percent (preliminary) in August 2022, up from 3.9 percent (revised) over the month. The unemployment rate 12 months ago was 5.7 percent. In April 2020, the unemployment rate for Island County was a record 16.5 percent.

• Compared to August 2021, the number of people counted as 'employed' increased by 728 and the number of people counted as 'unemployed' or actively seeking work contracted by 363. Island County's civilian labor force was estimated as 36,578, up 1.0 percent over the year.

Total nonfarm payroll jobs in Island County contracted by 100 from July to August 2022. Year-over-year, the tally of nonfarm jobs contracted by 120 or 0.7 percent.

- From July to August, leisure and hospitality, construction and education and health services added jobs. Government and trade, transportation and utilities (specifically retail trade) shed jobs over the month.
- Year-over-year, employment gains were observed in construction and education and health services (+110 and 60 respectively). The deepest losses were observed in trade, transportation and utilities (-120).

Employment statistics for Island County do not include direct military employment.

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County was 3.9 percent in August 2022 (preliminary), up from 3.4 percent (revised) in July. The unemployment rate 12 months ago was 4.7 percent. San Juan's unemployment rate in April 2020 (the height of the pandemic recession) was 19.2 percent.

• Compared to August 2021, the number of residents counted as 'employed' decreased by 541 and the number counted as 'unemployed' or actively seeking work decreased by 90. Altogether, the San Juan County labor force consisted of an estimated 7,621 resident workers and contracted by 7.6 percent over the year.

Net nonfarm payroll in San Juan County contracted by 30 in August. Year-over-year, total nonfarm employment was down 1,580 or 23.8 percent. Employment in San Juan County is highly seasonal. The small sampling size for this small county also means that routine revisions can be substantial.

- From July to August 2022, employment levels in all private industry sectors detailed in this report either dropped jobs or remained unchanged. Government was the only sector that expanded employment (+10).
- Over the year, the payroll tally in San Juan County contracted by 1,580. Annual gains were reported in professional and business services (+30) and construction (+10). All other industries included in this report shed jobs. The deepest one-year losses were observed in the tourism-dependent leisure and hospitality sector (-1,040).

Forecast information for Washington state:

The Washington State Economic and Revenue Forecast Council issues quarterly forecasts that address Washington's projected economic health. ERFC estimates indicate that Washington state employment will have expanded by 5.5 percent from 2021 to 2022 and will expand by 2.6 percent in 2023.
