Pandemic-related employment effects began to show up in Washington state as early as March 2020, and swiftly led to unprecedented levels of unemployment in April 2020. Many jobs have recovered in the meantime, with significant variation by location and industry. This report describes a moment in that recovery.

On a seasonally adjusted basis, preliminary estimates from the federal Bureau of Labor Statistics (BLS) indicate nonfarm employment in Washington rose by 6,100 in April 2023. BLS estimates the private sector gained 7,200 jobs during the month and the public sector lost 1,100 jobs.

On a not seasonally adjusted basis, estimates for April 2022 through Apr 2023 indicate an increase in employment of 116,700 for the state. The private sector gained 98,300 jobs while the public

sector gained an estimated 18,400 jobs over the year.

Washington's preliminary seasonally adjusted unemployment rate for April 2023 is 4.3 percent. The revised estimated March 2023 unemployment rate is at 4.5 percent. The April 2022 unemployment rate was 4.1 percent.

BLS estimates of monthly job gains and losses are based on a survey of businesses. Preliminary estimates are subject to revision. The March 2023 preliminary estimated gain of 1,500 jobs was revised to a gain of 4,300 jobs.

Whatcom County

Local Area Unemployment Statistics

The unemployment rate in Whatcom County was 3.9% in April 2023 (preliminary), below 4.8% reported in March and below 4.5% in April 2022 (revised). The unemployment rate reached a record high of 17.3% in April 2020.

• Compared to April 2022, the labor force expanded by 1,737 workers (1.5%). Within that estimate, the number of employed workers increased by 2,347 and the number of unemployed workers decreased by 610. Whatcom County's estimated labor force was 116,294 in April 2023.

Total nonfarm payroll in Whatcom County (not seasonally adjusted) increased from 97,000 in March (revised) to 97,700 in April 2023 (preliminary). Over the year, nonfarm employment increased by 2,200 (2.3%). Whatcom County has exceeded pre-pandemic levels of employment.

- The largest one-month gains were observed in construction (+400). In April, the only sector reporting one-month losses was trade, transportation, warehousing, and utilities (-300), with losses attributable to retail trade.
- Over the year, most sectors detailed in this report expanded employment, with the largest gains attributable to government (+900, concentrated in local government) and retail trade

(+200). Professional and businesses and leisure and hospitality each shed 300 jobs over the year and manufacturing employment was down by 100.

Skagit County

Local Area Unemployment Statistics

The unemployment rate in Skagit County was 4.2% (preliminary) in April 2023—down over the month from 5.1% (revised). The unemployment rate 12 months ago was 5.0%. The unemployment rate in April 2020 reached a record 18.6%.

• Compared to April 2022, the labor force expanded by 871 (1.4%). Within that, the number of people counted as 'employed' increased by 1,316 and the number of people counted as 'unemployed' decreased by 445. Skagit County's resident labor force was estimated at 61,980 in April 2023.

Total nonfarm employment in Skagit County increased by 500 jobs over the month. Year-over-year, the tally of nonfarm jobs expanded by 1,300 or 2.6%. For context, the current level of employment (52,000) is still 900 jobs shy of the level observed in April 2019 – before the pandemic.

• April was generally characterized by growth in Skagit County. Construction and government posted the largest one-month gains (+200 each); Trade, transportation, warehousing and utilities was the only sector reporting net losses in April (-100).

• Over the year, all industries detailed in this report either added jobs or remained unchanged. The largest increases were observed in construction, trade, transportation, warehousing and utilities, and government; Each added 300 jobs over 12 months.

Island County

Local Area Unemployment Statistics

The unemployment rate in Island County was estimated at 3.9% (preliminary) in April 2023, down from 4.9% in March (revised). The unemployment rate 12 months ago was 4.6%. In April 2020, the unemployment rate for Island County was a record 16.3%.

• Compared to April 2022, the Island County labor force expanded by 762. Within that estimate, the number of people counted as 'employed' increased by 978 and the number of people counted as 'unemployed' or actively seeking work decreased by 216. Island County's civilian labor force was estimated as 36,854, up 2.1% over the year.

Total nonfarm payroll jobs in Island County increased by 80 from March (revised) to April (preliminary) 2023. Year-over-year, the tally of nonfarm jobs expanded by 310 or 1.8%. The tally of Island County jobs reached pre-recession levels in early 2022.

- From March to April, most gains and losses were relatively small. The largest one-month increase was 140 jobs attributable to professional and business services. The deepest losses were observed in information and financial activities (-50).
- Year-over-year, most sectors detailed in this report added jobs. The largest observed employment gains were attributable to leisure and hospitality (+120) and government (+70). Trade, transportation, and utilities (including retail trade) and information and financial activities each shed jobs over the year.

Employment statistics for Island County do not include direct military employment.

San Juan County

Local Area Unemployment Statistics

The unemployment rate in San Juan County was 3.3% in April 2023 (preliminary), down from 4.4% (revised) in March. The unemployment rate 12 months ago was 4.2%. San Juan's unemployment rate in April 2020 (the height of the pandemic recession) was 19.0%.

• Compared to April 2022, the number of residents counted as 'employed' increased by 440 and the number counted as 'unemployed' or actively seeking work decreased by 58. Altogether, the San Juan County labor force consisted of an estimated 8,361 resident workers and expanded by 4.8% over the year.

Net nonfarm payroll in San Juan County increased by 20 in April (preliminary). Year-over-year, total nonfarm employment was up 70 or 1.2%. Employment in San Juan County is highly seasonal. The small sampling size for this small county also means that routine revisions can be substantial.

- From March (revised) to April 2023 (preliminary), leisure and hospitality the largest industry sector in San Juan County expanded employment. All other sectors detailed in this report experienced net losses.
- Over the year, the total nonfarm payroll tally in San Juan County expanded by 70. The largest 12-month increases were attributable to hiring in the professional and business services sector and education and health services (up 70 and 60 respectively). Employment in leisure and hospitality, government, and trade, transportation, and utilities was down over the year.

Forecast information for Washington state:

The Washington State Economic and Revenue Forecast Council issues quarterly forecasts that address Washington's projected economic health. ERFC estimates indicate that Washington state employment expanded by 5.5% from 2021 to 2022 but forecasts a slowdown in 2023; employment is expected to expand by 3.6% this year. This forecast is up slightly compared to the previous report. The average annual unemployment rate is expected to remain in the 4% range for the next few years.
