Enrollment Windows

Cycle One: For applicants enrolling in driver training **January 1 through March 31**.
Deadline for consideration is **December 31**.

Cycle Two: For applicants enrolling in driver training **April 1 through June 30**. Deadline for consideration is **March 31**.

Cycle Three: For applicants enrolling in driver training **July 1 through September 30**.
Deadline for consideration is **June 30**.

Cycle Four: For applicants enrolling in driver training **October 1 through December 31**.
Deadline for consideration is **September 30**.
