

## Business/Human Relations: The Charles Farnham Scholarship.

This scholarship is dedicated to an individual who was very active with the Sauk Valley Area Chamber of Commerce. I could easily talk about my experience thus far in CEO and all the reasons why I decided to join. I'm sure you've heard it all; the communication skills, a look into the business world, and all of the above. Of course, all of that is true I give my props to CEO for already helping me grow as a person in such a short time! The first week of CEO my facilitator, Le, talked about vulnerability. I was in my seat scared out of my mind that I would have to share my deepest darkest secret with 21 unfamiliar students. Thankfully, Le reassured us that we were not going to just spill our guts in front of the class then and there. Even with nerves shaking me to my core, I still felt a sense of reassurance knowing that emotions were welcome in the classroom. For the longest time I was taught and conditioned that my emotions and school have to be separated. Once I step into a school setting any kind of sadness, anger, frustration I have gets pushed down and saved for later. As if it is leftover spaghetti my mom made, that was made to feed 10+ people, knowing there is only three of us eating... When I walked into CEO, and one of the first few things we talked about was vulnerability I wasn't sure of how to react. My immediate reaction was, "No," that was the only word that appeared in my head. All other thoughts disappeared, and I wanted to close myself away. I realized that maybe this one time, I shouldn't shut down and become a shell of a person. I signed up for this class because I wanted to be able to actually feel like I was a part of something bigger than myself and the part I play to have a real meaning. If I chose in that very moment to react as I normally do and close myself off to the class, I would've gained nothing. CEO is about more than just the tours, speakers, and connections. It is about the impact it leaves on each and every one of the students. Just from my personal experience five months in, I have grown in so many different ways. There are certain parts of me that I didn't even think CEO would impact, but it did. This class has helped me become a more well-rounded person and the year isn't even over. Every day in CEO I feel like I am doing something that is meaningful, and it motivates me to get out of bed every day. I can only imagine how much more I will grow in these upcoming months!

We successfully did a trial run of making the casseroles. We made 28 tater tot casseroles for Gary Sandrock and his church group at New Life Lutheran, which delivered the casseroles to families in need. ## **Government Affairs Update**

## U.S. Chamber CEO Commends Passage of Pandemic Package



WASHINGTON, D.C. - U.S. Chamber of Commerce CEO Thomas J. Donohue issued the following statement on the passage of pandemic relief legislation.

"The Chamber applauds a truly bipartisan compromise that finally puts the American people and businesses ahead of partisan squabbling. We commend the Congressional leadership and the bipartisan senators and representatives whose actions led to this achievement. Together, they have illustrated how we can break partisan gridlock in the new Congress next year.

"The package includes aid for small businesses and nonprofits, extension of unemployment programs, funding for schools and day care centers, and resources to support vaccinations before the end of the year. It will help small businesses and Americans contend with the devastating economic impact of the pandemic, which, of course, has tragically taken more than 300,000 Americans this year.

"It's regrettable that the Portman-Manchin legislation that included state and local aid temporary aid, and targeted liability protections for businesses, schools, and nonprofits that follow public health guidelines, did not also pass with bipartisan support. These key provisions would have enhanced our nation's ability to stage a broad-based economic recovery in 2021. The Chamber will urge the new Congress and administration to support local and state aid and targeted liability protections in legislation in the new year."

Details:

As part of the end-of-year pandemic relief package, Congress has passed several changes to the Paycheck Protection Program (PPP) and created a "Second Draw" PPP for small businesses who have exhausted their initial loan. Other changes impact eligibility for initial PPP loans, the loan forgiveness process, and the tax treatment of PPP loans. Congress has also made changes to other programs – including Economic Injury Disaster Loans (EIDL Program), the Employee Retention Tax Credit, a Venue Grant program, and SBA loan programs –that will benefit small businesses. 
